WHEREAS, we deeply regret and are greatly saddened to learn of the death of Reverend James Curtis Owens who was called home to glory on March 26, 2016, at 64 years of age, and we uplift his inspiring life and legacy with utmost reverence and respect; and

WHEREAS, the passing of Reverend James Curtis Owens leaves a void in the lives of his loving family, many friends, and the entire community, where he was highly regarded; and

WHEREAS, Mr. Owens gave his life to Christ at an early age and joined First Baptist Church Annisburg, now Antioch Baptist Church; he graduated from Fairfield High School and, in 1969, became the first African American to receive a football scholarship at Auburn University, where he lettered as a fullback for the Tigers from 1970 to 1972 and played a key role on the 1972 Amazins team; he was drafted in the 11th round of the NFL draft by the New Orleans Saints; and

WHEREAS, Mr. Owens entered into Holy Matrimony with Gloria Sanks on April 20, 1974; in 1982, he served as Assistant Football Coach, Physical Education instructor, and employee of the United States Steel Corporation in Fairfield; he returned to Auburn at the request of Coach Pat Dye to serve as Assistant Football Coach; later, he continued to mentor and inspire students as Head Football Coach at Miles College; after leaving Miles College, he relocated to the Opelika/Auburn area and was employed by Tuskegee University and Auburn University; he retired from Auburn in 2004; and

WHEREAS, in 1995, Reverend Owens answered God's call upon his life to enter the ministry and became the Associate Minister of Pleasant Grove Missionary Baptist Church in Opelika, Alabama; in 2001, he became the Pastor of Pleasant Ridge Missionary Baptist Church in Dadeville, Alabama; he retired from full-time ministry in 2013 due to health issues, but continued to share God's Word; and

WHEREAS, survivors include his queen and devoted wife of 41 years, Gloria Sanks Owens; three loving children, DeWana (Derrick) Blackmon, Kimberly (Bishop) Moss, Jamelia Owens (Jacquin Dennis); three grandchildren, James Owens-Moss, Jada Moss, Jakayla Moss; one step granddaughter, Jessica Tolefree; special nephew, LaDarius Owens; two brothers, Neal (Pamela) Owens, Jr., George (Bernadine) Owens, Sr.; four sisters, Ella (Melvin) Lovejoy, Nora (Martin) Hill, Omega Levins, and Ora Owens; five stepbrothers, Roderick (Sonya)
