12 Huntsville, Alabama, on December 28, 2015, at 86 years of age;

14 WHEREAS, the passing of Mr. Riddick leaves a void in
15 the lives of his loving family, many friends, and the entire
16 community, where he was highly regarded; and

17 WHEREAS, a Huntsville native, Mr. Riddick served
18 with the United States Army during the Korean War before
19 graduating from Auburn University; he was employed with the

23 Riddick served the citizens of Huntsville and Madison County
24 as a member of the Huntsville City Council and the Alabama

27 Madison County in 2000 before becoming Director of

1 Governmental Affairs for the Huntsville Area Association of
2 Realtors; he served on numerous local boards including the
3 Madison County Mental Health Board and the Harris Home for
4 Children; and

5 WHEREAS, Mr. Riddick was a faithful and devoted
6 member of Chase Park Church of Christ; and

7 WHEREAS, survivors include his beloved and devoted
8 wife of 59 years, Barbara McDaniel Riddick; son, Madison
9 County Commissioner Phil Riddick (Rebecca); daughter, Teresa
10 Chilek (Greg); sisters, Miriam Riddick Dendy and Minnie
11 Frances Riddick Nash; and grandson, Steven Henderson Riddick;
