8 SYNOPSIS: This bill makes appropriations for the  
9 ordinary expenses of the executive, legislative and  
10 judicial agencies of the State, for other functions  
11 of government, for debt service, and for capital  
12 outlay for the fiscal year ending September 30,  
13 2018.

15 A BILL  
16 TO BE ENTITLED  
17 AN ACT  
18

19 To make appropriations for the ordinary expenses of  
20 the executive, legislative and judicial agencies of the State,  
21 for other functions of government, for debt service, and for  
22 capital outlay for the fiscal year ending September 30, 2018.  
23 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

24 Section 1. The monies in Section 2 are appropriated  
25 from the named funds for the 2018 fiscal year to the state  
26 agencies indicated, as the amounts to be used to pay the  
27 expenditures of the named agencies, and are in lieu of all

1 monies appropriated for these purposes in other sections of  
2 the Alabama Statutes.

3 For the purpose of this act, the amounts herein for  
4 expenditures are listed by programmatic area and the totals  
5 for all programs are shown by the source of funds. It is  
6 intended that only the herein named funds be appropriated in  
7 the amounts specified to the named agencies and that the  
8 following definitions shall be applicable.

9 "Appropriation Total" shall mean the aggregate total  
10 of all fund sources.

11 "Program" shall mean specific governmental services  
12 required to achieve a specific objective. A program shall be  
13 directed to meeting the need of an identified clientele, or  
14 group of recipients or beneficiaries, and shall be expended  
15 only for such purposes.

16 "Capital Outlay" shall mean expenditures which  
17 result in the acquisition and/or addition to items, such as  
18 land or buildings, which have an appreciable and calculable  
19 period of usefulness in excess of one year, and shall be  
20 expended only for such purposes.

21 "Debt Service" shall mean an expenditure for the  
22 payment of interest and principal on bonded debt obligations  
23 of the State, and shall be expended only for such purposes.

24 "Federal and Local Funds" shall mean all gifts,  
25 grants, contributions, or entitlements, including grants by  
26 the Congress of the United States, municipalities or counties.

Section 2. There is hereby appropriated the amounts set forth herein for the ordinary expenses of the executive, legislative, and judicial agencies of the State, for other functions of government, for debt service, and for capital outlay for the fiscal year ending September 30, 2018, to be paid out of any monies hereinafter specified, from such other funds and accounts as may be designated, or so much thereof as may be necessary, and the total amount to be expended for the items for which the appropriation is herein made shall not exceed the amount provided therefor, except as provided in the Budget Management Act of 1976, Sections 41-19-1 through 41-19-12, Code of Alabama 1975. Provided, however, that regardless of the ending date of any pay period which has been or may be established by the Legislature for the payment of salaries of state employees, the entire payment due shall be made from the fiscal year's appropriation in which the pay date falls.

7	Alabama Alcoholic Beverage Control Board, after provision has been made for the		
8	other expenditures herein authorized, such sums as are or may be necessary to pur-		
9	chase the alcoholic beverages which are essential to maintain adequate stocks and		
10	inventory for an economic and successful sales operation. In addition to the above		
11	appropriation, it is further provided that, in the event any county or municipality

20 Account No. 0396 by Act 87-761, Act 88-947, Act 89-79, Act  
21 90-556 and Act 91-572 are hereby appropriated to the  
22 Governor's Contingency Fund to be spent at the discretion of  
23 the Governor. Any other interest earned by the state from  
24 Revenue Sharing Investments under the State and Local Fiscal  
25 Assistance Act of 1972, as amended, Public Law 92-512, 92nd  
26 Congress, together with any accruals or reversions thereon are  
27 hereby appropriated to the State General Fund.

1           Section 12. All encumbered balances of a previous  
2           fiscal year appropriation, other than the exclusions  
3           authorized by this Act or in Section 41-4-93, Code of Alabama  
4           1975, shall lapse no later than September 30 of the fiscal  
5           year immediately following the fiscal year for which the  
6           appropriation was made and shall revert to the credit of the  
7           State General Fund or earmarked fund from which the  
8           appropriation or appropriations were made.

9           Section 13. The appropriations made herein to the  
10          departments, boards, offices, commissions and agencies include  
11          the amounts necessary, and said departments, boards, offices,  
12          commissions and agencies are hereby directed to make the  
13          transfer of funds to the State Personnel Department in said  
14          amounts enumerated in this act. All agencies enumerated in  
15          this act and receiving services from other governmental  
16          agencies enumerated in this act shall make full payment in a  
17          timely manner (as determined by the Department of Finance) for  
18          such services.

19          Section 14. All funds collected under Section  
20          40-12-43.1 between the effective date of Act 98-191 and  
21          September 30, 2017 are hereby appropriated to the Auburn  
22          University Center for Governmental Services for the  
23          administration of the examiner certification program  
24          established by the Alabama Local Tax Institute of Standards  
25          and Training as provided in Section 40-12-43.1.

26          Section 15. It is the intent of the Legislature that  
27          the funds appropriated to the Office of the Senate President

1 Pro Tempore in subsection 8 of Section 2A of this act which  
2 are not otherwise designated may be expended by the Senate  
3 President Pro Tempore for the same purposes as are authorized  
4 for the Lieutenant Governor pursuant to Section 29-4-50, Code  
5 of Alabama 1975, and the Speaker of the House of  
6 Representatives pursuant to Section 29-4-60, Code of Alabama  
7 1975.

8 Section 16. The appropriations made herein to the  
9 departments, boards, offices, commissions and agencies include  
10 the amounts necessary to pay the SEIB. The SEIB rate shall be  
11 \$930 per month for each full-time employee for the fiscal year  
12 ending September 30, 2018. In addition to the amounts  
13 otherwise appropriated in this act, there is hereby  
14 appropriated from the State General Fund in the same  
15 proportion as the salaries of the several State officials and  
16 employees are paid, additional amounts to pay for the increase  
17 in employer contributions to SEIB. The additional amounts  
18 appropriated in this section from the State General Fund shall  
19 not exceed \$9,600,000 for the fiscal year ending September 30,  
20 2018. The Director of Finance shall ensure that first priority  
21 shall be given to all General Fund payrolls, including the  
22 payroll of the Legislature. State agencies may receive  
23 additional allocations from the appropriation made in this  
24 section from the General Fund in amounts necessary to pay for  
25 the increase. The remainder of this appropriation from the  
26 State General Fund may be allotted by the Director of Finance  
27 to those agencies which receive transfers from the State

1 General Fund. The SEIB shall adjust the insurance program  
2 wherever appropriate to maintain the aforementioned fixed  
3 rate; however, it is the intent of the Legislature that the  
4 Board not increase the out of pocket costs to active and  
5 retired members.

6 Section 17. In addition to the amounts otherwise  
7 appropriated in this act, there is hereby appropriated from  
8 the several funds in the State Treasury, except the Education  
9 Trust Fund, and in the same proportion as the salaries of the  
10 several State officials and employees are paid, such  
11 additional amounts as may be necessary to pay for a four  
12 percent (4.0%) salary increase enacted in the 2017 Regular  
13 Session. The additional amounts appropriated in this section  
14 from the State General Fund shall not exceed \$19,000,000 for  
15 the first fiscal year ending September 30, 2018. The Director  
16 of Finance shall ensure that first priority shall be given to  
17 all State General Fund payrolls, including the payroll of the  
18 Legislature. State agencies shall receive additional  
19 allocations from the appropriation made in this section from  
20 the State General Fund in amounts necessary to increase total  
21 salaries paid from the State General Fund by four percent. The  
22 remainder of this appropriation from the State General Fund  
23 may be allotted from the Director of Finance to those agencies  
24 which receive transfers from the State General Fund.

25 Section 18. It is the intent of the Legislature that  
26 the Director of Finance shall notify the Chair of the House  
27 Ways and Means General Fund Committee, the Chair of the Senate



1 Finance and Taxation General Fund Committee, and the  
2 Legislative Fiscal Officer of any interagency transfers, of  
3 any type, including contracting, of any of the funds  
4 appropriated in this act.

5 Section 19. If any section, paragraph, sentence,  
6 clause, provision or portion of this act or all or any portion  
7 of any appropriations herein made be held unconstitutional or  
8 invalid, it shall not affect any other section, paragraph,  
9 sentence, clause, provision or portion of this act or any  
10 other appropriation or appropriations or portion thereof  
11 hereby made not in and of itself unconstitutional or invalid.

12 Section 20. All laws or parts of laws, general,  
13 special, private or local that are in conflict with or  
14 inconsistent with the provisions of this act are hereby  
15 expressly repealed.

16 Section 21. Each agency of the state funded through  
17 the provisions of this act shall provide an equal opportunity  
18 for employment and business opportunities for all citizens of  
19 this state without regard to sex or race.

20 Section 22. This act shall become effective October  
21 1, 2017.
