12 honoring Mr. Tim Hudson of Auburn, Alabama, for his
13 outstanding athletic achievements, his extraordinary
14 professional baseball career, and his philanthropy benefitting

23 Hudson played with the Oakland Athletics from 1999-2004, the
24 Atlanta Braves 2005-2013, and the San Francisco Giants
25 2014-2015; he continued to set records and earn a multitude of
26 honors and awards during his professional career including:
27 2010 Hutch Award, 2010 Major League Baseball Comeback Player

1 of the Year; four-time All-Star, 2000, 2004, 2010, and 2014;
2 and three-time Top 10 in American League Cy Young Award
3 voting; and

4 WHEREAS, retiring in 2015 as the winningest active
5 Major League pitcher, Hudson has since served as a guest
6 instructor and a spring training instructor; he is also known
7 for his faith and his willingness to give back to the citizens
8 of Alabama, particularly the children; and

9 WHEREAS, Tim and Kim Hudson have been active in
10 numerous charitable organizations providing a positive impact
11 on many of our citizens; in 2009 they established the Hudson
12 Family Foundation to serve those persons in Alabama and
13 Georgia who need assistance in specific physical, emotional,
14 or financial circumstances; and

15 WHEREAS, his unwavering commitment to excellence in
16 athletics and his philanthropy reflect immense credit upon the
17 entire State of Alabama; Tim has enriched countless lives
18 through his meritorious life's work, and he is truly deserving
19 of special recognition; it is a tremendous privilege to
20 recognize Tim Hudson and welcome him as a special guest on a
21 legislative day; now therefore,
