11 WHEREAS, the mission of the Southern States Energy
12 Board is "to enhance economic development and the quality of
13 life in the South, through innovations in energy and
14 environmental programs, policies and technologies"; and

15 WHEREAS, the Southern States Energy Board bases its
16 mission and vision on a strong and prosperous Southern region
17 powered by clean, affordable, reliable, and secure energy
18 resources; and

19 WHEREAS, the board seeks to develop and sustain
20 American economic leadership by improving industrial and
21 manufacturing processes through effective and more efficient
22 energy technology deployment; and

23 WHEREAS, energy use in commercial and residential
24 buildings represents a significant opportunity for improved
25 efficiency and distributed resource deployment; and

26 WHEREAS, the transition to a global clean energy
27 economy requires the demonstration of new technologies that

1 employ all energy resources including renewable energy, clean
2 coal, energy efficiency, distributed energy, and oil and
3 natural gas with protection mechanisms for our environment;
4 and

5 WHEREAS, the scientific application and advancement
6 of innovative technologies can lead to breakthroughs that
7 provide a strategic investment in America's energy future,
8 modernize our infrastructure, and mitigate the effects of
9 climate challenges; and

10 WHEREAS, high volume process engineering, industry
11 alignment, a supply chain development, new business models,
12 and standardization will cause industry to achieve additional
13 cost reductions resulting in the breaking down of market
14 barriers for technology development; and

15 WHEREAS, the past programs, committees, and
16 coalitions of the Southern States Energy Board, from its
17 inception in 1960, include addressing cutting edge energy
18 issues facing its member states and territories such as
19 alternative transportation fuels; generation of electric power
20 from a variety of energy resources; energy efficiency in
21 homes, buildings, and industries; integration of a reliable,
22 resilient, and efficient interstate electric energy grid
23 system; support for technologies that improve clean energy
24 manufacturing industries; facilitation of technology
25 development; and solid waste management; now therefore,

26 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF
27 THE LEGISLATURE OF ALABAMA, That this body calls on the United

1 States Secretary of Energy to work in collaboration with the
2 Southern States Energy Board to expand the opportunity for
3 clean energy technology innovations and applications in
4 southern states to maximize sustainable economic development
5 for a thriving and successful future.
