25	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
26	Section 1. In addition to all other appropriations
27	heretofore or hereafter made, there is hereby appropriated a



1	total of \$15,089,140 from the Education Trust Fund Advancement
2	and Technology Fund to the public institutions of higher edu-
3	cation for the fiscal year ending September 30, 2017. This
4	appropriation shall be expended for: (1) repairs or deferred
5	maintenance of facilities for public education purposes in the
6	state; (2) insuring facilities; or (3) the acquisition or pur-
7	chase of education technology and equipment, or both. This

facilities for public education purposes in the state; (2)
classroom instructional support pursuant to 16-13-231(b)(2)c
and Section 16-13-231.3; (3) insuring facilities; (4)
transportation pursuant to Section 16-13-233; or (5) purchase
of education technology and equipment or both.
