8 SYNOPSIS: This bill makes a supplemental appropriation
9 from the State General Fund to the Department of
10 Corrections in the amount of \$30,000,000 for the
11 fiscal year ending September 30, 2018; makes a
12 supplemental appropriation from the State General
13 Fund to the Choctawhatchee, Pea and Yellow Rivers
14 Watershed Management Authority in the amount of
15 \$11,000 for the fiscal year ending September 30,
16 2018; makes a supplemental appropriation from the
17 State General Fund to the Departmental Emergency
18 Fund in the amount of \$2,600,000 for the fiscal
19 year ending September 30, 2018; makes a
20 supplemental appropriation from the DNA Fund to the
21 Department of Forensic Sciences in the amount of
22 \$500,000 for the fiscal year ending September 30,
23 2018; makes a supplemental appropriation from the
24 Recovery Audit Fund to the Examiners of Public
25 Accounts in the amount of \$530,000 for the fiscal
26 year ending September 30, 2018; and makes a
27 supplemental appropriation from the Insurance

1 Department Fund to the Department of Insurance in
2 the amount of \$2,500,000 for the fiscal year ending
3 September 30, 2018.

9 To make a supplemental appropriation from the State
10 General Fund to the Department of Corrections in the amount of
11 \$30,000,000 for the fiscal year ending September 30, 2018; to
12 make a supplemental appropriation from the State General Fund
13 to the Choctawhatchee, Pea and Yellow Rivers Watershed
14 Management Authority in the amount of \$11,000 for the fiscal
15 year ending September 30, 2018; to make a supplemental
16 appropriation from the State General Fund to the Departmental
17 Emergency Fund in the amount of \$2,600,000 for the fiscal year
18 ending September 30, 2018; to make a supplemental
19 appropriation from the DNA Fund to the Department of Forensic
20 Sciences in the amount of \$500,000 for the fiscal year ending
21 September 30, 2018; to make a supplemental appropriation from
22 the Recovery Audit Fund to the Examiners of Public Accounts in
23 the amount of \$530,000 for the fiscal year ending September
24 30, 2018; and to make a supplemental appropriation from the
25 Insurance Department Fund to the Department of Insurance in
26 the amount of \$2,500,000 for the fiscal year ending September
27 30, 2018.

1 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

2 Section 1. In addition to all other appropriations
3 heretofore or hereafter made, there is hereby appropriated
4 \$30,000,000 from the State General Fund to the Department of
5 Corrections for the fiscal year ending September 30, 2018.

6 Section 2. In addition to all other appropriations
7 heretofore or hereafter made, there is hereby appropriated
8 \$11,000 from the State General Fund to the Choctawhatchee, Pea
9 and Yellow Rivers Watershed Management Authority for the
10 fiscal year ending September 30, 2018.

11 Section 3. In addition to all other appropriations
12 heretofore or hereafter made, there is hereby appropriated
13 \$2,600,000 from the State General Fund to the Departmental
14 Emergency Fund for the fiscal year ending September 30, 2018.

15 Section 4. In addition to all other appropriations
16 heretofore or hereafter made, there is hereby appropriated
17 \$500,000 from the DNA Fund to the Department of Forensic
18 Sciences for the fiscal year ending September 30, 2018.

19 Section 5. In addition to all other appropriations
20 heretofore or hereafter made, there is hereby appropriated
21 \$530,000 from the Recovery Audit Fund to the Examiners of
22 Public Accounts for the fiscal year ending September 30, 2018.

23 Section 6. In addition to all other appropriations
24 heretofore or hereafter made, there is hereby appropriated
25 \$2,500,000 from the Insurance Department Fund to the
26 Department of Insurance for the fiscal year ending September
27 30, 2018. For the fiscal year ending September 30, 2018, the

1 Commissioner of Insurance is authorized to transfer up to
2 \$5,000,000 from the Insurance Department Fund to the
3 Strengthen Alabama Homes Fund established pursuant to Section
4 27-31E-2, Code of Alabama 1975.

5 Section 7. This act shall become effective
6 immediately upon its passage and approval by the Governor, or
7 upon its otherwise becoming law.
