Section 2. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$11,000 from the State General Fund to the Choctawhatchee, Pea and Yellow Rivers Watershed Management Authority for the fiscal year ending September 30, 2018.

Section 3. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$2,600,000 from the State General Fund to the Departmental Emergency Fund for the fiscal year ending September 30, 2018.

Section 4. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$500,000 from the DNA Fund to the Department of Forensic Sciences for the fiscal year ending September 30, 2018.

Section 5. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$530,000 from the Recovery Audit Fund to the Examiners of Public Accounts for the fiscal year ending September 30, 2018.
