11 To make a supplemental appropriation from the State
12 General Fund to the Department of Corrections in the amount of
13 \$30,000,000 for the fiscal year ending September 30, 2018; to
14 make a supplemental appropriation from the State General Fund
15 to the Choctawhatchee, Pea and Yellow Rivers Watershed
16 Management Authority in the amount of \$11,000 for the fiscal
17 year ending September 30, 2018; to make a supplemental
18 appropriation from the State General Fund to the Departmental
19 Emergency Fund in the amount of \$2,600,000 for the fiscal year
20 ending September 30, 2018; to make a supplemental
21 appropriation from the DNA Fund to the Department of Forensic
22 Sciences in the amount of \$500,000 for the fiscal year ending
23 September 30, 2018; to make a supplemental appropriation from
24 the Recovery Audit Fund to the Examiners of Public Accounts in
25 the amount of \$530,000 for the fiscal year ending September
26 30, 2018; and to make a supplemental appropriation from the
27 Insurance Department Fund to the Department of Insurance in

1 the amount of \$2,500,000 for the fiscal year ending September
2 30, 2018.

3 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

4 Section 1. In addition to all other appropriations
5 heretofore or hereafter made, there is hereby appropriated
6 \$30,000,000 from the State General Fund to the Department of
7 Corrections for the fiscal year ending September 30, 2018.

8 Section 2. In addition to all other appropriations
9 heretofore or hereafter made, there is hereby appropriated
10 \$11,000 from the State General Fund to the Choctawhatchee, Pea
11 and Yellow Rivers Watershed Management Authority for the
12 fiscal year ending September 30, 2018.

13 Section 3. In addition to all other appropriations
14 heretofore or hereafter made, there is hereby appropriated
15 \$2,600,000 from the State General Fund to the Departmental
16 Emergency Fund for the fiscal year ending September 30, 2018.

17 Section 4. In addition to all other appropriations
18 heretofore or hereafter made, there is hereby appropriated
19 \$500,000 from the DNA Fund to the Department of Forensic
20 Sciences for the fiscal year ending September 30, 2018.

21 Section 5. In addition to all other appropriations
22 heretofore or hereafter made, there is hereby appropriated
23 \$530,000 from the Recovery Audit Fund to the Examiners of
24 Public Accounts for the fiscal year ending September 30, 2018.

25 Section 6. In addition to all other appropriations
26 heretofore or hereafter made, there is hereby appropriated
27 \$2,500,000 from the Insurance Department Fund to the

1 Department of Insurance for the fiscal year ending September
2 30, 2018. For the fiscal year ending September 30, 2018, the
3 Commissioner of Insurance is authorized to transfer up to
4 \$5,000,000 from the Insurance Department Fund to the
5 Strengthen Alabama Homes Fund established pursuant to Section
6 27-31E-2, Code of Alabama 1975.

7 Section 7. This act shall become effective
8 immediately upon its passage and approval by the Governor, or
9 upon its otherwise becoming law.
