This section does 12 13 not include any provision concerning the display of 14 the Ten Commandments. 15 Section 263 of Article XIV of the 16 Constitution of Alabama of 1901, now appearing as 17 Section 263 of Article XIV of the Official 18 Recompilation of the Constitution of 1901, as amended, prohibits public school funds being 19 20 appropriated to any sectarian or denominational 21 school. 22 Amendment 622 to the Constitution of Alabama 23 of 1901, now appearing as Section 3.01 of Article I 24 of the Official Recompilation of the Constitution of 1901, as amended, the Alabama Religious Freedom 25 26 Amendment, provides that freedom of religion may 27 not be burdened by state and local law.

The proposed amendment would propose a constitutional amendment which would provide that property belonging to the state may be used to display the Ten Commandments and that the right to display the Ten Commandments on property owned or administrated by a public school or public body is not restrained or abridged.

8 The proposed amendment would also provide 9 that every person would be at liberty to worship 10 according to his or her own conscience; and that no 11 person would be compelled to attend or support a 12 place of worship or a minister.

13The proposed amendment would also provide14that the civil and political rights, privileges,15and capacities of no person may be diminished or16enlarged on account of his or her religious17beliefs.

18The proposed amendment would prohibit the19expenditure of public funds in defense of the20constitutionality of this amendment.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The following amendment to the Constitution of Alabama of 1901, as amended, is proposed and shall become valid as a part thereof when approved by a majority of the qualified electors voting thereon and in accordance with Sections 284, 285, and 287 of the Constitution of Alabama of 1901, as amended:

## PROPOSED AMENDMENT

14 Every person shall be at liberty to worship God 15 according to the dictates of his or her own conscience. No person shall be compelled to attend, or, against his or her 16 17 consent, to contribute to the erection or support of any place 18 of religious worship, or to pay tithes, taxes, or other rates for the support of any minister of the gospel. Property 19 20 belonging to the state may be used to display the Ten 21 Commandments, and the right of a public school and public body 22 to display the Ten Commandments on property owned or administrated by a public school or public body in this state 23 24 is not restrained or abridged. The civil and political rights, 25 privileges, and capacities of no person shall be diminished or enlarged on account of his or her religious belief. No public 26

1 funds may be expended in defense of the constitutionality of 2 this amendment.

The Ten Commandments shall be displayed in a manner that complies with constitutional requirements, including, but not limited to, being intermingled with historical or educational items, or both, in a larger display within or on property owned or administrated by a public school or public body.

9 Section 2. An election upon the proposed amendment 10 shall be held in accordance with Sections 284 and 285 of the 11 Constitution of Alabama of 1901, now appearing as Sections 284 12 and 285 of the Official Recompilation of the Constitution of 13 Alabama of 1901, as amended, and the election laws of this 14 state.

15 Section 3. The appropriate election official shall 16 assign a ballot number for the proposed constitutional 17 amendment on the election ballot and shall set forth the 18 following description of the substance or subject matter of 19 the proposed constitutional amendment:

Proposing an amendment to the Constitution of Alabama of 1901, providing for certain religious rights and liberties; authorizing the display of the Ten Commandments on state property and property owned or administrated by a public school or public body; and prohibiting the expenditure of public funds in defense of the constitutionality of this amendment.
