4 ENROLLED, SJR18,

5 RECOGNIZING THE ESTABLISHMENT OF A STATE FIREFIGHTER  
6 CANCER REGISTRY DATABASE BY THE ALABAMA FIRE COLLEGE.

8 WHEREAS, the construction of buildings and the  
9 manufacturing of their contents include more materials that  
10 use chemicals that when burned, their compounds change; and

11 WHEREAS, these burning compounds release many  
12 different known carcinogens; and

13 WHEREAS, it is now known that firefighters are at  
14 risk of being exposed to these carcinogens while on the scene  
15 of a fire; and

16 WHEREAS, national studies have indicated that  
17 firefighters are twice as likely to develop specific types of  
18 cancer and are likely to die from these cancers due to more  
19 exposure to the carcinogens than the general public; and

20 WHEREAS, the gathering of quality informational data  
21 regarding these exposures is vital to understanding the known  
22 exposures and how to limit the risk and best protect  
23 firefighters and their families; now therefore,

24 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH  
25 HOUSES THEREOF CONCURRING, That we recognize the establishment

1 of a state firefighter cancer registry database created by the  
2 Alabama Fire College that will provide a tool for all  
3 firefighters in the state, whether paid or volunteer, to login  
4 and enter their exposure information.

5 BE IT FURTHER RESOLVED, That this database will  
6 provide a private account that only the firefighter or an  
7 administrator of the database system can access for privacy  
8 concerns.

9 BE IT FURTHER RESOLVED, We acknowledge that the  
10 exposure information, less any personal information not  
11 required, would be collected from the entries in the database  
12 and forwarded annually to the Centers for Disease Control and  
13 Prevention to be utilized in studies that are attempting to  
14 limit the exposure of firefighters to known carcinogens while  
15 performing the duties of their job.
