13 "All funds collected pursuant to this chapter shall
14 be deposited in the State Treasury to the credit of the State
15 Fire Marshal's Fund authorized in Section ~~24-5-10~~ 36-19-31.
16 The State Fire Marshal may expend moneys from the State Fire
17 Marshal's Fund for the operation of the State Fire Marshal's
18 Office, including the administration and enforcement of this
19 chapter. The State Fire Marshal may receive grants and
20 donations from associations, firms, or individuals who are
21 interested in the upgrading and quality of fire alarm systems
22 in compliance with Alabama state ethics laws."

23 Section 2. Section 36-19-31 is added to the Code of
24 Alabama 1975, to read as follows:

25 §36-19-31.

26 (a) There is hereby established in the State
27 Treasury a special fund to be known as the State Fire

1 Marshal's Fund. All sums received by the State Fire Marshal's
2 Office through the payment of fees, the recovery of civil
3 penalties, grants, and appropriations by the Legislature,
4 including funds received pursuant to Article 8, Article 8A,
5 Article 9, and Article 10 of Chapter 17 of Title 8, and
6 pursuant to Chapter 33 and Chapter 33A of Title 34, shall be
7 deposited in the State Fire Marshal's Fund.

8 (b) The State Fire Marshal's Fund shall be expended
9 for the operation of the State Fire Marshal's Office,
10 including the administration and enforcement of Article 8,
11 Article 8A, Article 9, and Article 10 of Chapter 17 of Title
12 8, and of Chapter 33 and Chapter 33A of Title 34, for training
13 and research programs, and to support fire safety and
14 prevention programs.

15 (c) No funds shall be withdrawn or expended from the
16 State Fire Marshal's Fund except as budgeted and allotted
17 according to Sections 41-4-80 to 41-4-96, inclusive, and
18 41-19-1 to 41-19-12, inclusive, and only in amounts as
19 stipulated in the general appropriations act, or other
20 appropriations act. Any unencumbered and unexpended balance of
21 the fund remaining at the end of any fiscal year shall not
22 lapse or revert to the General Fund but shall be carried
23 forward to the next fiscal year.

24 Section 3. The deposit of any funds in the State
25 Fire Marshal's Fund and the expenditure of any funds from the
26 State Fire Marshal's Fund prior to the effective date of this
27 act are ratified and confirmed.
