8 SYNOPSIS: This bill makes a supplemental appropriation
9 from the Home Builders Property Acquisition Fund to
10 the Home Builders Licensure Board in the amount of
11 \$600,000 for the fiscal year ending September 30,
12 2019; makes a supplemental appropriation from the
13 Alabama State Board of Midwifery Fund to the
14 Alabama State Board of Midwifery in the amount of
15 \$25,000 for the fiscal year ending September 30,
16 2019; makes a supplemental appropriation from the
17 Alabama Behavior Analyst Licensing Board Fund to
18 the Alabama Behavior Analyst Licensing Board in the
19 amount of \$30,000 for the fiscal year ending
20 September 30, 2019; makes a supplemental
21 appropriation from the State General Fund to the
22 Legislature in the amount of \$459,000 for the
23 fiscal year ending September 30, 2019; and makes a
24 supplemental appropriation from the State General
25 Fund to the Unified Judicial System for the Alabama
26 Sentencing Commission in the amount of \$375,000 for
27 the fiscal year ending September 30, 2019.

6 To make a supplemental appropriation from the Home
7 Builders Property Acquisition Fund to the Home Builders
8 Licensure Board in the amount of \$600,000 for the fiscal year
9 ending September 30, 2019; to make a supplemental
10 appropriation from the Alabama State Board of Midwifery Fund
11 to the Alabama State Board of Midwifery in the amount of
12 \$25,000 for the fiscal year ending September 30, 2019; to make
13 a supplemental appropriation from the Alabama Behavior Analyst
14 Licensing Board Fund to the Alabama Behavior Analyst Licensing
15 Board in the amount of \$30,000 for the fiscal year ending
16 September 30, 2019; to make a supplemental appropriation from
17 the State General Fund to the Legislature in the amount of
18 \$459,000 for the fiscal year ending September 30, 2019; and to
19 make a supplemental appropriation from the State General Fund
20 to the Unified Judicial System for the Alabama Sentencing
21 Commission in the amount of \$375,000 for the fiscal year
22 ending September 30, 2019.

23 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

24 Section 1. In addition to all other appropriations
25 heretofore or hereafter made, there is hereby appropriated
26 \$600,000 from the Home Builders Property Acquisition Fund to

1 the Home Builders Licensure Board for the fiscal year ending
2 September 30, 2019.

3 Section 2. In addition to all other appropriations
4 heretofore or hereafter made, there is hereby appropriated
5 \$25,000 from the Alabama State Board of Midwifery Fund to the
6 Alabama State Board of Midwifery for the fiscal year ending
7 September 30, 2019.

8 Section 3. In addition to all other appropriations
9 heretofore or hereafter made, there is hereby appropriated
10 \$30,000 from the Alabama Behavior Analyst Licensing Board Fund
11 to the Alabama Behavior Analyst Licensing Board for the fiscal
12 year ending September 30, 2019.

13 Section 4. In addition to all other appropriations
14 heretofore or hereafter made, there is hereby appropriated
15 \$459,000 from the State General Fund to the Legislature for
16 the fiscal year ending September 30, 2019.

17 Section 5. In addition to all other appropriations
18 heretofore or hereafter made, there is hereby appropriated
19 \$375,000 from the State General Fund to the Unified Judicial
20 System for the Alabama Sentencing Commission for the fiscal
21 year ending September 30, 2019 for the purpose of developing
22 and implementing a correctional forecast simulator model.

23 Section 6. This act shall become effective
24 immediately upon its passage and approval by the Governor, or
25 upon its otherwise becoming law.
