ENROLLED, An Act,

To authorize the Town Council of the Town of Triana in Madison County, pursuant to Amendment No. 373 of the Constitution of Alabama 1901, to increase the rate of the town's general ad valorem tax levied and collected on all taxable property in the town which is authorized pursuant to the Constitution of Alabama of 1901, by an additional 12 mills on each dollar (\$1.20 on each one hundred dollars) of assessed value to be used exclusively for educational purposes.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. This act shall apply to the Town of Triana in Madison County.

Section 2. For the purposes of this act, the following words have the following meanings:

(1) AMENDMENT NO 373. Amendment No. 373 of the Constitution of Alabama of 1901, now appearing as Section 217 of the Recompiled Constitution of Alabama of 1901.

(2) Town. The Town of Triana, Alabama.

(3) TOWN GENERAL AD VALOREM TAX. The tax authorized pursuant to the applicable provisions of the general laws of this state and the Constitution of Alabama of 1901, to be levied by the town for general municipal purposes and without express limit as to time.

1 Section 3. The town presently levies and collects
2 the town general ad valorem tax. Pursuant to a resolution
3 adopted by the Town Council of the Town of Triana after a
4 public hearing in accordance with Amendment No. 373, the Town
5 of Triana proposes to increase the rate at which it may levy
6 and collect the town general ad valorem tax by an additional
7 12 mills (\$1.20 on each one hundred dollars) of assessed
8 value.

9 Section 4. Pursuant to subsection (f) of Amendment
10 No. 373 and a resolution adopted by the Town Council of the
11 Town of Triana after a public hearing, the town may increase
12 the rate at which the town levies and collects the town
13 general ad valorem tax by a maximum rate increase for any tax
14 year equal to 12 mills (\$1.20 on each one hundred dollars) of
15 assessed value, to be used and expended exclusively for public
16 educational purposes.

17 Section 5. The increase in the rate at which the
18 town general ad valorem tax may be levied and collected
19 pursuant to this act is subject to approval by a majority of
20 the qualified electors residing in the town who vote on the
21 proposed increase at a special election called and held for
22 that purpose pursuant to subsection (f) of Amendment No. 373.

23 Section 6. The increase in the rate of ad valorem
24 tax authorized by this act upon approval of a majority of the
25 qualified electors residing in the town shall be levied only

1 if the City of Madison also approves a 12 mill increase in the
2 rate of its ad valorem tax at a special election held
3 contemporaneously with the special election held in the Town
4 of Triana, the proceeds of which are to be used exclusively
5 for public educational purposes.

6 Section 7. The increase in the maximum level of ad
7 valorem tax authorized pursuant to this act may be made
8 effective beginning with the levy for the tax year beginning
9 on October 1, 2019, for which tax year municipal ad valorem
10 taxes will become due and payable on October 1, 2020.

11 Section 8. This act shall become effective
12 immediately following its passage and approval by the
13 governor, or its otherwise becoming law.
