To make a supplemental appropriation from the Home Builders Property Acquisition Fund to the Home Builders Licensure Board in the amount of \$600,000 for the fiscal year ending September 30, 2019; to make a supplemental appropriation from the Alabama State Board of Midwifery Fund to the Alabama State Board of Midwifery in the amount of \$25,000 for the fiscal year ending September 30, 2019; to make a supplemental appropriation from the Alabama Behavior Analyst Licensing Board Fund to the Alabama Behavior Analyst Licensing Board in the amount of \$30,000 for the fiscal year ending September 30, 2019; to make a supplemental appropriation from the State General Fund to the Legislature in the amount of \$459,000 for the fiscal year ending September 30, 2019; and to make a supplemental appropriation from the State General Fund to the Unified Judicial System for the Alabama Sentencing Commission in the amount of \$375,000 for the fiscal year ending September 30, 2019.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$600,000 from the Home Builders Property Acquisition Fund to the Home Builders Licensure Board for the fiscal year ending September 30, 2019.

In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$375,000 from the State General Fund to the Unified Judicial System for the Alabama Sentencing Commission for the fiscal year ending September 30, 2019 for the purpose of developing and implementing a correctional forecast simulator model.

Section 6. This act shall become effective immediately upon its passage and approval by the Governor, or upon its otherwise becoming law.
