2 ENROLLED, An Act,

3           To make a supplemental appropriation from the Home  
4 Builders Property Acquisition Fund to the Home Builders  
5 Licensure Board in the amount of \$600,000 for the fiscal year  
6 ending September 30, 2019; to make a supplemental  
7 appropriation from the Alabama State Board of Midwifery Fund  
8 to the Alabama State Board of Midwifery in the amount of  
9 \$25,000 for the fiscal year ending September 30, 2019; to make  
10 a supplemental appropriation from the Alabama Behavior Analyst  
11 Licensing Board Fund to the Alabama Behavior Analyst Licensing  
12 Board in the amount of \$30,000 for the fiscal year ending  
13 September 30, 2019; to make a supplemental appropriation from  
14 the State General Fund to the Legislature in the amount of  
15 \$459,000 for the fiscal year ending September 30, 2019; and to  
16 make a supplemental appropriation from the State General Fund  
17 to the Unified Judicial System for the Alabama Sentencing  
18 Commission in the amount of \$375,000 for the fiscal year  
19 ending September 30, 2019.

20 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

21           Section 1. In addition to all other appropriations  
22 heretofore or hereafter made, there is hereby appropriated  
23 \$600,000 from the Home Builders Property Acquisition Fund to  
24 the Home Builders Licensure Board for the fiscal year ending  
25 September 30, 2019.

1           Section 2. In addition to all other appropriations  
2 heretofore or hereafter made, there is hereby appropriated  
3 \$25,000 from the Alabama State Board of Midwifery Fund to the  
4 Alabama State Board of Midwifery for the fiscal year ending  
5 September 30, 2019.

6           Section 3. In addition to all other appropriations  
7 heretofore or hereafter made, there is hereby appropriated  
8 \$30,000 from the Alabama Behavior Analyst Licensing Board Fund  
9 to the Alabama Behavior Analyst Licensing Board for the fiscal  
10 year ending September 30, 2019.

11           Section 4. In addition to all other appropriations  
12 heretofore or hereafter made, there is hereby appropriated  
13 \$459,000 from the State General Fund to the Legislature for  
14 the fiscal year ending September 30, 2019.

15           Section 5. In addition to all other appropriations  
16 heretofore or hereafter made, there is hereby appropriated  
17 \$375,000 from the State General Fund to the Unified Judicial  
18 System for the Alabama Sentencing Commission for the fiscal  
19 year ending September 30, 2019 for the purpose of developing  
20 and implementing a correctional forecast simulator model.

21           Section 6. This act shall become effective  
22 immediately upon its passage and approval by the Governor, or  
23 upon its otherwise becoming law.
