8 SYNOPSIS: This bill makes a supplemental appropriation
9 from the Home Builders Property Acquisition Fund to
10 the Home Builders Licensure Board in the amount of
11 \$600,000 for the fiscal year ending September 30,
12 2019; makes a supplemental appropriation from the
13 Alabama State Board of Midwifery Fund to the
14 Alabama State Board of Midwifery in the amount of
15 \$25,000 for the fiscal year ending September 30,
16 2019; makes a supplemental appropriation from the
17 Alabama Behavior Analyst Licensing Board Fund to
18 the Alabama Behavior Analyst Licensing Board in the
19 amount of \$30,000 for the fiscal year ending
20 September 30, 2019; and makes a supplemental
21 appropriation form the State General Fund to the
22 Legislature in the amount of \$459,000 for the
23 fiscal year ending September 30, 2019.

2 To make a supplemental appropriation from the Home
3 Builders Property Acquisition Fund to the Home Builders
4 Licensure Board in the amount of \$600,000 for the fiscal year
5 ending September 30, 2019; to make a supplemental
6 appropriation from the Alabama State Board of Midwifery Fund
7 to the Alabama State Board of Midwifery in the amount of
8 \$25,000 for the fiscal year ending September 30, 2019; to make
9 a supplemental appropriation from the Alabama Behavior Analyst
10 Licensing Board Fund to the Alabama Behavior Analyst Licensing
11 Board in the amount of \$30,000 for the fiscal year ending
12 September 30, 2019; and to make a supplemental appropriation
13 from the State General Fund to the Legislature in the amount
14 of \$459,000 for the fiscal year ending September 30, 2019.

15 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

16 Section 1. In addition to all other appropriations
17 heretofore or hereafter made, there is hereby appropriated
18 \$600,000 from the Home Builders Property Acquisition Fund to
19 the Home Builders Licensure Board for the fiscal year ending
20 September 30, 2019.

21 Section 2. In addition to all other appropriations
22 heretofore or hereafter made, there is hereby appropriated
23 \$25,000 from the Alabama State Board of Midwifery Fund to the
24 Alabama State Board of Midwifery for the fiscal year ending
25 September 30, 2019.

26 Section 3. In addition to all other appropriations
27 heretofore or hereafter made, there is hereby appropriated

1 \$30,000 from the Alabama Behavior Analyst Licensing Board Fund
2 to the Alabama Behavior Analyst Licensing Board for the fiscal
3 year ending September 30, 2019.

4 Section 4. In addition to all other appropriations
5 heretofore or hereafter made, there is hereby appropriated
6 \$459,000 from the State General Fund to the Legislature for
7 the fiscal year ending September 30, 2019.

8 Section 5. This act shall become effective
9 immediately upon its passage and approval by the Governor, or
10 upon its otherwise becoming law.
