Section 1. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$600,000 from the Home Builders Property Acquisition Fund to the Home Builders Licensure Board for the fiscal year ending September 30, 2019.

Section 2. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$25,000 from the Alabama State Board of Midwifery Fund to the Alabama State Board of Midwifery for the fiscal year ending September 30, 2019.

Section 3. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated

\$30,000 from the Alabama Behavior Analyst Licensing Board Fund 1 2 to the Alabama Behavior Analyst Licensing Board for the fiscal 3 year ending September 30, 2019. Section 4. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated 5 \$459,000 from the State General Fund to the Legislature for 6 7 the fiscal year ending September 30, 2019. Section 5. This act shall become effective immediately upon its passage and approval by the Governor, or 9
