## PROPOSED AMENDMENT

The Legislature, upon the recommendation of the Director of the Legislative Services Agency through a proposed draft, may arrange this constitution, as amended, in proper articles, parts, and sections removing all racist language, delete duplicative and repealed provisions, consolidate provisions regarding economic development, arrange all local amendments by county of application during the 2022 Regular Session of the Legislature, and make no other changes. The draft and arrangement, when approved by a three-fifths vote of each house of the Legislature, through joint resolution, shall be submitted to the voters pursuant to Amendment 714 of the Constitution of Alabama of 1901, now appearing as Section 286.01 of the Official Recompilation of the Constitution of Alabama of 1901, as amended. The Constitution of Alabama, with the amendments made thereto, in accordance with this amendment, once approved by the voters, shall be the supreme law of the state.

Section 2. An election upon the proposed amendment shall be held in accordance with Sections 284 and 285 of the Constitution of Alabama of 1901, now appearing as Sections 284 and 285 of the Official Recompilation of the Constitution of Alabama of 1901, as amended, and the election laws of this state.

1	Section 3. The appropriate election official shall
2	assign a ballot number for the proposed constitutional
3	amendment on the election ballot and shall set forth the
4	following description of the substance or subject matter of
5	the proposed constitutional amendment:
6	"Proposing an amendment to the Constitution of
7	Alabama of 1901, to authorize the Legislature to recompile the
8	Alabama Constitution and submit it during the 2022 Regular
9	Session, and provide a process for its ratification by the
10	voters of this state.
11	"Proposed by Act"
12	This description shall be followed by the following
13	language:
14	"Yes ( ) No ( )."
