8 SYNOPSIS: This bill makes a supplemental appropriation
9 from the Education Trust Fund to the State
10 Department of Education in the amount of \$3,112,615
11 for the fiscal year ending September 30, 2019;
12 makes a supplemental appropriation from the
13 Education Trust Fund to the Department of
14 Rehabilitation Services in the amount of \$1,550,000
15 for the fiscal year ending September 30, 2019;
16 makes a supplemental appropriation from the
17 Education Trust Fund to the Alabama Public Library
18 Service in the amount of \$500,000 for the fiscal
19 year ending September 30, 2019; makes a
20 supplemental appropriation from the Education Trust
21 Fund to the Legislative Services Agency in the
22 amount of \$500,000 for the fiscal year ending
23 September 30, 2019; and makes a supplemental
24 appropriation from the Education Trust Fund to the
25 Alabama Building Renovation Finance Authority in an
26 amount up to \$650,000 for the fiscal year ending
27 September 30, 2019.

6 To make a supplemental appropriation from the
7 Education Trust Fund to the State Department of Education in
8 the amount of \$3,112,615 for the fiscal year ending September
9 30, 2019; to make a supplemental appropriation from the
10 Education Trust Fund to the Department of Rehabilitation
11 Services in the amount of \$1,550,000 for the fiscal year
12 ending September 30, 2019; to make a supplemental
13 appropriation from the Education Trust Fund to the Alabama
14 Public Library Service in the amount of \$500,000 for the
15 fiscal year ending September 30, 2019; to make a supplemental
16 appropriation from the Education Trust Fund to the Legislative
17 Services Agency in the amount of \$500,000 for the fiscal year
18 ending September 30, 2019; and to make a supplemental
19 appropriation from the Education Trust Fund to the Alabama
20 Building Renovation Finance Authority in an amount up to
21 \$650,000 for the fiscal year ending September 30, 2019.

22 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

23 Section 1. In addition to all other appropriations
24 heretofore or hereafter made, there is hereby appropriated
25 \$3,112,615 from the Education Trust Fund to the State
26 Department of Education for the fiscal year ending September
27 30, 2019. Of this appropriation, \$1,809,535 shall be expended

1 for start-up costs incurred in connection with the
2 implementation of a new Student Administration System;
3 \$303,080 shall be expended for pilot projects to address
4 dyslexia; and \$1,000,000 shall be expended to support the
5 development of programs specifically targeted at literacy,
6 numeracy, and career and technical education through the
7 expansion of professional development opportunities for
8 teachers in the summer of 2019.

9 Section 2. In addition to all other appropriations
10 heretofore or hereafter made, there is hereby appropriated
11 \$1,550,000 from the Education Trust Fund to the Department of
12 Rehabilitation Services for the fiscal year ending September
13 30, 2019. Of this appropriation, \$1,300,000 shall be expended
14 for the Early Intervention Program and \$250,000 shall be
15 transferred to the Alabama Head and Spinal Cord Injury Trust
16 Fund.

17 Section 3. In addition to all other appropriations
18 heretofore or hereafter made, there is hereby appropriated
19 \$500,000 from the Education Trust Fund to the Alabama Public
20 Library Service for the fiscal year ending September 30, 2019.
21 Of this appropriation, \$250,000 shall be distributed to the
22 Alabama Supreme Court Library and \$250,000 is to be
23 distributed to public libraries within the State.

24 Section 4. In addition to all other appropriations
25 heretofore or hereafter made, there is hereby appropriated
26 \$500,000 from the Education Trust Fund to the Legislative
27 Services Agency for the fiscal year ending September 30, 2019.

1 This appropriation shall be expended for a pilot project to
2 replace and modernize the appropriation bill drafting and
3 support system.

4 Section 5. In addition to all other appropriations
5 heretofore or hereafter made, there is hereby appropriated up
6 to \$650,000 from the Education Trust Fund to the Alabama
7 Building Renovation Finance Authority for the fiscal year
8 ending September 30, 2019. This appropriation shall be
9 expended to reimburse the Authority for expenditures incurred
10 related to bicentennial activities. This appropriation shall
11 be limited to the amount necessary to reimburse the Authority.

12 Section 6. This act shall become effective
13 immediately upon its passage and approval by the Governor, or
14 upon its otherwise becoming law.
