8 SYNOPSIS: Under existing law, the Home Builders
9 Licensure Board has the sole authority to fix the

20 To amend Section 34-14A-4, Code of Alabama 1975, as
21 amended by Act 2018-143, 2018 Regular Session, relating to the
22 Home Builders Licensure Board; to require the board to obtain
23 the approval of the Governor and the State Personnel Board
24 when setting the salary of the executive director and the
25 deputy director.

26 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

1 Section 1. Section 34-14A-4 of the Code of Alabama
2 1975, as amended by Act 2018-143, 2018 Regular Session, is
3 amended to read as follows:

4 "§34-14A-4.

5 "(a) Members of the board shall select from its own
6 membership a chair, who shall preside at all meetings of the
7 board unless otherwise ordered, and he or she shall exercise
8 and perform all duties and functions incident to the office of
9 chair. The board may select from its own membership a
10 vice-chair, a secretary, and a treasurer. The offices of
11 secretary and treasurer may be held by the same person.

12 "(b) The board, at a minimum, shall meet on a
13 quarterly basis and at such other times as the chair may
14 designate for the purpose of transacting business as may
15 properly come before the board. Four members shall constitute
16 a quorum at all meetings. The secretary of the board shall
17 keep such records of each meeting as shall be required by the
18 board.

19 "(c) Members of the board may be compensated in an
20 amount not to exceed three hundred fifty dollars (\$350) per
21 day, not to exceed 15 days per year, for attending meetings of
22 the board or its committees and, in addition, may be
23 reimbursed for such necessary travel expenses as are paid to
24 state employees.

25 "(d) The board may employ an executive director and
26 a deputy director. The board ~~shall have sole authority to,~~
27 with the approval of the Governor and the State Personnel

1 Board as provided in Section 36-6-6, shall fix the salary of
2 the executive director and the deputy director. ~~The authority~~
3 ~~to fix the salary of the executive director is not subject to~~
4 ~~subsection (b) of Section 36-6-6.~~

5 "(e) The executive director may hire staff to carry
6 out this chapter."

7 Section 2. This act shall become effective
8 immediately following its passage and approval by the
9 Governor, or its otherwise becoming law.
