13 Relating to Barbour County; to amend Section  
14 45-3-232 of the Code of Alabama 1975, to provide that all of  
15 the sheriff's pistol permit fees will be deposited in the  
16 Sheriff's Fund and used exclusively for law enforcement  
17 purposes.

18 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

19 Section 1. Section 45-3-232 of the Code of Alabama  
20 1975, is amended to read as follows:

21 "§45-3-232.

22 "(a) In Barbour County the fee for issuance of a  
23 permit to carry a pistol in a vehicle or concealed on or about  
24 the person as provided in Section 13A-11-75 shall be ~~fifteen~~  
25 ~~dollars (\$15)~~ twenty dollars (\$20) which shall be collected by  
26 the sheriff, or his or her agent.

1           " ~~(b) Nine dollars (\$9) of each Each fee collected~~  
2 under subsection (a) shall be paid to the county treasury  
3 ~~which shall be used for the specific purpose of motor vehicle~~  
4 ~~purchases for the Barbour County Sheriff's Department. The~~  
5 ~~remaining six dollars (\$6) of each fee shall be deposited by~~  
6 the Sheriff of Barbour County, or his or her agent, in any  
7 bank located in Barbour County into a fund known as the  
8 Sheriff's Fund.

9           "(c) The Sheriff's Fund provided for in subsection  
10 (b) shall be drawn upon by the Sheriff of Barbour County or  
11 his or her appointed agent and shall be used exclusively for  
12 law enforcement purposes and in the discharge of the sheriff's  
13 office as he or she sees fit.

14           "(d) The establishment of the Sheriff's Fund as  
15 provided in this section and the use of such funds shall in no  
16 way diminish or take the place of any other imbursement or  
17 other source of income established for the sheriff or the  
18 operation of his or her office.

19           " ~~(e) Effective after August 1, 2010, the Barbour~~  
20 ~~County Commission by resolution of the commission may increase~~  
21 ~~the fee for the issuance of a pistol permit as provided for in~~  
22 ~~Section 13A-11-75, by five dollars (\$5). The additional fee~~  
23 ~~when collected by the sheriff shall be deposited in the county~~  
24 ~~treasury and used only for the purchase and maintenance of~~  
25 ~~motor vehicles for the Barbour County Sheriff's Department.~~  
26 ~~The additional fee when adopted by the county commission shall~~  
27 ~~not be effective prior to the first day of the month~~

1 ~~thereafter or at a later time designated in the resolution.~~  
2 Any fees for the issuance of a pistol permit deposited in the  
3 county treasury prior to the effective date of the act adding  
4 this language shall be transferred to the Sheriff's Fund  
5 established in subsection (b)."

6           Section 2. This act shall become effective  
7 immediately following its passage and approval by the  
8 Governor, or its otherwise becoming law.
