8 SYNOPSIS: This bill makes a supplemental appropriation  
9 from the Alabama State Board of Midwifery Fund to  
10 the Alabama State Board of Midwifery in the amount  
11 of \$25,000 for the fiscal year ending September 30,  
12 2020; makes a supplemental appropriation from the  
13 Genetic Counseling Fund to the Alabama Board of  
14 Genetic Counseling in the amount of \$70,000 for the  
15 fiscal year ending September 30, 2020; makes a  
16 supplemental appropriation from the Alabama Bail  
17 Bond Board Fund to the Alabama Professional Bail  
18 Bonding Board in the amount of \$61,620 for the  
19 fiscal year ending September 30, 2020; makes a  
20 supplemental appropriation from the Forever Wild  
21 Land Trust Fund to the Board of Forever Wild Land  
22 Trust in the amount of \$3,050,000 for the fiscal  
23 year ending September 30, 2020; makes a  
24 supplemental appropriation from the State General  
25 Fund to the Department of Finance in the amount of  
26 \$11,000,000 for the fiscal year ending September  
27 30, 2020; makes a supplemental appropriation from

1 the State General Fund to the Department of  
2 Conservation and Natural Resources in the amount of  
3 \$600,000 for the fiscal year ending September 30,  
4 2020; makes a supplemental appropriation from the  
5 State General Fund to the Legislature in the amount

4 To make a supplemental appropriation from the  
5 Alabama State Board of Midwifery Fund to the Alabama State  
6 Board of Midwifery in the amount of \$25,000 for the fiscal  
7 year ending September 30, 2020; to make a supplemental  
8 appropriation from the Genetic Counseling Fund to the Alabama  
9 Board of Genetic Counseling in the amount of \$70,000 for the  
10 fiscal year ending September 30, 2020; to make a supplemental  
11 appropriation from the Alabama Bail Bond Board Fund to the  
12 Alabama Professional Bail Bonding Board in the amount of  
13 \$61,620 for the fiscal year ending September 30, 2020; to make  
14 a supplemental appropriation from the Forever Wild Land Trust  
15 Fund to the Board of Forever Wild Land Trust in the amount of  
16 \$3,050,000 for the fiscal year ending September 30, 2020; to  
17 make a supplemental appropriation from the State General Fund  
18 to the Department of Finance in the amount of \$11,000,000 for  
19 the fiscal year ending September 30, 2020; to make a  
20 supplemental appropriation from the State General Fund to the  
21 Department of Conservation and Natural Resources in the amount  
22 of \$600,000 for the fiscal year ending September 30, 2020; to  
23 make a supplemental appropriation from the State General Fund  
24 to the Legislature in the amount of \$400,000 for the fiscal  
25 year ending September 30, 2020; to make a supplemental  
26 appropriation from the State General Fund to the Alabama  
27 Forestry Commission in the amount of \$525,000 for the fiscal

1 year ending September 30, 2020; to make a supplemental  
2 appropriation from the State General Fund to the Department of  
3 Mental Health in the amount of \$2,500,000 for the fiscal year  
4 ending September 30, 2020; to make a supplemental  
5 appropriation from the State General Fund to the Department of  
6 Human Resources in the amount of \$100,000 for the fiscal year  
7 ending September 30, 2020; to make a supplemental  
8 appropriation from the State General Fund to the Department of  
9 Public Health in the amount of \$5,000,000 for the fiscal year  
10 ending September 30, 2020; and to make a supplemental  
11 appropriation from the State General Fund to the General Fund  
12 Budget Reserve Fund in the amount of \$5,000,000 for the fiscal  
13 year ending September 30, 2020.

14 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

15 Section 1. In addition to all other appropriations  
16 heretofore or hereafter made, there is hereby appropriated  
17 \$25,000 from the Alabama State Board of Midwifery Fund to the  
18 Alabama State Board of Midwifery for the fiscal year ending  
19 September 30, 2020.

20 Section 2. In addition to all other appropriations  
21 heretofore or hereafter made, there is hereby appropriated  
22 \$70,000 from the Genetic Counseling Fund to the Alabama Board  
23 of Genetic Counseling for the fiscal year ending September 30,  
24 2020.

25 Section 3. In addition to all other appropriations  
26 heretofore or hereafter made, there is hereby appropriated  
27 \$61,620 from the Alabama Bail Bond Board Fund to the Alabama

1 Professional Bail Bonding Board for the fiscal year ending  
2 September 30, 2020.

3 Section 4. In addition to all other appropriations  
4 heretofore and hereafter made, there is hereby appropriated  
5 \$3,050,000 from the Forever Wild Land Trust Fund to the Board  
6 of Forever Wild Land Trust for the fiscal year ending  
7 September 30, 2020.

8 Section 5. In addition to all other appropriations  
9 heretofore or hereafter made, there is hereby appropriated  
10 \$11,000,000 from the State General Fund to the Department of  
11 Finance for implementation costs for replacement of the  
12 state's human resource management and payroll system for the  
13 fiscal year ending September 30, 2020.

14 Section 6. In addition to all other appropriations  
15 heretofore or hereafter made, there is hereby appropriated  
16 \$600,000 from the State General Fund to the Department of  
17 Conservation and Natural Resources for the fiscal year ending  
18 September 30, 2020 for the purpose of repairs at Chattahoochee  
19 and Joe Wheeler State Parks. Of the above appropriation,  
20 \$300,000 shall be expended for Chattahoochee and \$300,000  
21 shall be expended for Joe Wheeler.

22 Section 7. In addition to all other appropriations  
23 heretofore and hereafter made, there is hereby appropriated  
24 \$400,000 from the State General Fund to the Legislature for  
25 the fiscal year ending September 30, 2020 to be used for  
26 renovations to the House Chamber.

1           Section 8. In addition to all other appropriations  
2 heretofore and hereafter made, there is hereby appropriated  
3 \$525,000 from the State General Fund to the Alabama Forestry  
4 Commission for the fiscal year ending September 30, 2020 of  
5 which \$325,000 shall be used for repairs at Flagg Mountain and  
6 Claude D. Kelley State Park; and \$200,000 shall be used for  
7 the Forest Workforce Training Institute.

8           Section 9. In addition to all other appropriations  
9 heretofore and hereafter made, there is hereby appropriated  
10 \$2,500,000 from the State General Fund to the Department of  
11 Mental Health for the Rural County Crisis Diversion Project  
12 for Southwest Mental Health, Cahaba Mental Health, Demopolis  
13 Mental Health, Wellstone Mental Health Authority, and  
14 Northwest Mental Health Center.

15           Section 10. In addition to all other appropriations  
16 heretofore of hereafter made, there is hereby appropriated  
17 \$100,000 from the State General Fund to the Department of  
18 Human Resources for the fiscal year ending September 30, 2020,  
19 to be used for the Mary Hill Family Resource Center.

20           Section 11. In addition to all other appropriations  
21 heretofore and hereafter made, there is hereby appropriated  
22 \$5,000,000 from the State General Fund to the Department of  
23 Public Health for the fiscal year ending September 30, 2020 to  
24 be used for Coronavirus preparedness and response activities.

25           Section 12. In addition to all other appropriations  
26 heretofore and hereafter made, there is hereby appropriated  
27 \$5,000,000 from the State General Fund to the General Fund

1 Budget Reserve Fund for the fiscal year ending September 30,  
2 2020, to be used for initial funding for the General Fund  
3 Budget Reserve Fund created in SB129 of the 2020 Regular  
4 Session.

5 Section 13. This act shall become effective  
6 immediately upon its passage and approval by the Governor, or  
7 upon its otherwise becoming law.
