9 SYNOPSIS: This bill makes appropriations for the  
10 ordinary expenses of the executive, legislative,  
11 and judicial agencies of the State, for other  
12 functions of government, for debt service, and for  
13 capital outlay for the fiscal year ending September  
14 30, 2021.

16 A BILL  
17 TO BE ENTITLED  
18 AN ACT  
19

20 To make appropriations for the ordinary expenses of  
21 the executive, legislative, and judicial agencies of the  
22 State, for other functions of government, for debt service,  
23 and for capital outlay for the fiscal year ending September  
24 30, 2021.

25 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

26 Section 1. The monies in Section 2 are appropriated  
27 from the named funds for the 2021 fiscal year to the state

1 agencies indicated, as the amounts to be used to pay the  
2 expenditures of the named agencies, and are in lieu of all  
3 monies appropriated for these purposes in other sections of  
4 the Alabama Statutes.

5 For the purpose of this act, the amounts herein for  
6 expenditures are listed by programmatic area and the totals  
7 for all programs are shown by the source of funds. It is  
8 intended that only the herein named funds be appropriated in  
9 the amounts specified to the named agencies and that the  
10 following definitions shall be applicable.

11 "Appropriation Total" shall mean the aggregate total  
12 of all funding sources.

13 "Program" shall mean specific governmental services  
14 required to achieve a specific objective. A program shall be  
15 directed to meeting the need of an identified clientele, or  
16 group of recipients or beneficiaries, and shall be expended  
17 only for such purposes.

18 "Capital Outlay" shall mean expenditures which  
19 result in the acquisition and/or addition to items, such as  
20 land or buildings, which have an appreciable and calculable  
21 period of usefulness in excess of one year, and shall be  
22 expended only for such purposes.

23 "Debt Service" shall mean an expenditure for the  
24 payment of interest and principal on bonded debt obligations  
25 of the State, and shall be expended only for such purposes.

1           "Federal and Local Funds" shall mean all gifts,  
2 grants, contributions, or entitlements, including grants by  
3 the Congress of the United States, municipalities or counties.

4           Section 2. There is hereby appropriated the amounts  
5 set forth herein for the ordinary expenses of the executive,  
6 legislative, and judicial agencies of the State, for other  
7 functions of government, for debt service, and for capital  
8 outlay for the fiscal year ending September 30, 2021, to be  
9 paid out of any monies hereinafter specified, from such other  
10 funds and accounts as may be designated, or so much thereof as  
11 may be necessary, and the total amount to be expended for the  
12 items for which the appropriation is herein made shall not  
13 exceed the amount provided therefor, except as provided in the  
14 Budget Management Act of 1976, Sections 41-19-1 through  
15 41-19-12, Code of Alabama 1975. Provided, however, that re-  
16 gardless of the ending date of any pay period which has been  
17 or may be established by the Legislature for the payment of  
18 salaries of state employees, the entire payment due shall be  
19 made from the fiscal year's appropriation in which the pay  
20 date falls.

24 each additional retail and wholesale store that is relocated or put into operation  
25 during the fiscal year, an amount equal to the sum required to install and operate a  
26 comparable store in operation by said Board. There is further appropriated to the  
27 Alabama Alcoholic Beverage Control Board, after provision has been made for the  
28 other expenditures herein authorized, such sums as are or may be necessary to pur-  
29 chase the alcoholic beverages which are essential to maintain adequate stocks and  
30 inventory for an economic and successful sales operation. In addition to the above  
31 appropriation, it is further provided that, in the event any county or municipality  
32 of the state shall, during the fiscal period covered by this appropriation by proper  
33 referendum, authorize the legal sale of malt and brewed beverages within such county  
34 or municipality there is further appropriated, in addition to the amount herein set  
35 out, an amount comparable to that expended during the prior fiscal year for beer and  
36 license tax supervision within counties or municipalities of similar size and popu-  
37 lation. Provided further, that the amount appropriated herein shall be reduced in  
38 like manner in the event any county or municipality wherein malt and brewed bever-  
39 ages are now authorized by law to be sold shall, during the fiscal period covered by  
40 this appropriation by proper referendum, declare unlawful the sale in such county or

27 such department, division, board, bureau, commission, agency,



1 institution, office, or officer to be used only for the  
2 purpose or purposes for which the grant or contribution was or  
3 shall be made. Provided, however, any expenditure made from  
4 any direct stimulus funding provided by the Congress of the  
5 United States to the State of Alabama from the Coronavirus  
6 Relief Fund of the Coronavirus, Aid, Relief, and Economic  
7 Security (CARES) Act (P.L. 116-136) or any other direct  
8 stimulus funding provided by Congress to the State of Alabama  
9 for expenditures related to the coronavirus pandemic, and not  
10 directly related to an existing program or function, must be  
11 approved by a majority of the Governor, and the Chairmen of  
12 the House Ways and Means - General Fund Committee, and Senate  
13 Finance and Taxation - General Fund Committee, prior to  
14 expenditure. Further, all state, county, municipal, and  
15 educational entities are authorized to disburse such sums as  
16 deemed necessary by mutual agreement among said entities, the  
17 State of Alabama, and the Department of Examiners of Public  
18 Accounts to partially defray the cost of auditing services  
19 performed by said agency. All such sums are hereby  
20 appropriated and reappropriated if necessary to the Department  
21 of Examiners of Public Accounts for audit services, to be  
22 expended through the fund established by Section 41-5A-22,  
23 Code of Alabama 1975.

24 Section 11. The Department of Examiners of Public  
25 Accounts is hereby authorized to examine as deemed necessary  
26 all appropriations herein made for compliance with the laws of  
27 the State of Alabama. Any examination performed shall be in

1 accordance with the provisions of Title 41, Chapter 5A, Code  
2 of Alabama 1975. It is the intent of the Legislature that all  
3 state agencies cooperate with the Examiners of Public Accounts  
4 to provide the information necessary to conduct recovery  
5 audits as provided for in Section 41-5A-6, Code of Alabama  
6 1975.

7 Section 12. Upon certification to the Director of  
8 Finance by the State Attorney General that a federal court has  
9 ordered the State of Alabama to pay claims, attorney fees, or  
10 other costs relating to said court order, funds are hereby  
11 appropriated to the affected department, board, bureau, or  
12 commission from the appropriate fund or funds of such  
13 department, board, bureau, or commission in the amount  
14 necessary to satisfy that court order. Such appropriations are  
15 in addition to any other appropriation heretofore or hereafter  
16 made in this appropriation act. Such appropriations are  
17 conditioned upon the availability of funds and a determination  
18 by the Director of Finance that existing appropriations are  
19 not available for the court-ordered payments.

20 Section 13. All interest earned from funds paid into  
21 Account No. 0396 by Act 87-761, Act 88-947, Act 89-79, Act  
22 90-556, and Act 91-572 are hereby appropriated to the  
23 Governor's Contingency Fund to be spent at the discretion of  
24 the Governor. Any other interest earned by the state from  
25 Revenue Sharing Investments under the State and Local Fiscal  
26 Assistance Act of 1972, as amended, Public Law 92-512, 92nd

1 Congress, together with any accruals or reversions thereon are  
2 hereby appropriated to the State General Fund.

3 Section 14. All encumbered balances of a previous  
4 fiscal year appropriation, other than the exclusions  
5 authorized by this act or in Section 41-4-93, Code of Alabama  
6 1975, shall lapse no later than September 30 of the fiscal  
7 year immediately following the fiscal year for which the  
8 appropriation was made and shall revert to the credit of the  
9 State General Fund or earmarked fund from which the  
10 appropriation or appropriations were made.

11 Section 15. The appropriations made herein to the  
12 departments, boards, offices, commissions, and agencies  
13 include the amounts necessary, and said departments, boards,  
14 offices, commissions, and agencies are hereby directed to make  
15 the transfer of funds to the State Personnel Department in  
16 said amounts enumerated in this act. All agencies enumerated  
17 in this act and receiving services from other governmental  
18 agencies enumerated in this act shall make full payment in a  
19 timely manner (as determined by the Department of Finance) for  
20 such services.

21 Section 16. All funds collected under Section  
22 40-12-43.1, Code of Alabama 1975, between the effective date  
23 of Act 98-191 and September 30, 2020, are hereby appropriated  
24 to the Auburn University Center for Governmental Services for  
25 the administration of the examiner certification program  
26 established by the Alabama Local Tax Institute of Standards

1 and Training as provided in Section 40-12-43.1, Code of  
2 Alabama 1975.

3 Section 17. It is the intent of the Legislature that  
4 the funds appropriated to the Office of the Senate President  
5 Pro Tempore in subsection 6 of Section 2A of this act which  
6 are not otherwise designated may be expended by the Senate  
7 President Pro Tempore for the same purposes as are authorized  
8 for the Lieutenant Governor pursuant to Section 29-4-50, Code  
9 of Alabama 1975, and the Speaker of the House of  
10 Representatives pursuant to Section 29-4-60, Code of Alabama  
11 1975.

12 Section 18. The appropriations made herein to the  
13 departments, boards, offices, commissions, and agencies  
14 include the amounts necessary to pay the SEIB. The SEIB rate  
15 shall be \$930 per month for each full-time employee for the  
16 fiscal year ending September 30, 2021. The SEIB shall adjust  
17 the insurance program wherever appropriate to maintain the  
18 aforementioned fixed rate; however, it is the intent of the  
19 Legislature that the Board not increase the out of pocket  
20 costs to active and retired members.

21 Section 19. It is the intent of the Legislature that  
22 the Director of Finance shall notify the Chair of the House  
23 Ways and Means General Fund Committee, the Chair of the Senate  
24 Finance and Taxation-General Fund Committee, and the Deputy  
25 Director of the Legislative Services Agency-Fiscal Division of  
26 any interagency transfers, of any type, including contracting,  
27 of any of the funds appropriated in this act.

1           Section 20. If any section, paragraph, sentence,  
2 clause, provision, or portion of this act or all or any  
3 portion of any appropriations herein made be held  
4 unconstitutional or invalid, it shall not affect any other  
5 section, paragraph, sentence, clause, provision, or portion of  
6 this act or any other appropriation or appropriations or  
7 portion thereof hereby made not in and of itself  
8 unconstitutional or invalid.

9           Section 21. All laws or parts of laws, general,  
10 special, private, or local that are in conflict with or  
11 inconsistent with the provisions of this act are hereby  
12 expressly repealed.

13           Section 22. Each agency of the state funded through  
14 the provisions of this act shall provide an equal opportunity  
15 for employment and business opportunities for all citizens of  
16 this state without regard to sex or race.

17           Section 23. This act shall become effective October  
18 1, 2020.
