9 SYNOPSIS: This bill makes a supplemental appropriation
10 from the Education Trust Fund to the State
11 Department of Education in the amount of
12 \$14,085,735 for the fiscal year ending September
13 30, 2020; makes a supplemental appropriation from
14 the Education Trust Fund to the Alabama Community
15 College System in the amount of \$501,943 for the
16 fiscal year ending September 30, 2020; makes a
17 supplemental appropriation from the Education Trust
18 Fund to the Marine Environmental Sciences
19 Consortium in the amount of \$1,000,000 for the
20 fiscal year ending September 30, 2020; makes a
21 supplemental appropriation from the Education Trust
22 Fund to Alabama State University in the amount of
23 \$400,000 for the fiscal year ending September 30,
24 2020; makes a supplemental appropriation from the
25 Education Trust Fund to the Alabama Department of
26 Commerce in the amount of \$1,000,000 for the fiscal
27 year ending September 30, 2020; makes a

1 supplemental appropriation from the Education Trust
2 Fund to the Fire College in the amount of \$144,000
3 for the fiscal year ending September 30, 2020;
4 makes a supplemental appropriation from the

21 To make a supplemental appropriation from the
22 Education Trust Fund to the State Department of Education in
23 the amount of \$14,085,735 for the fiscal year ending September
24 30, 2020; to make a supplemental appropriation from the
25 Education Trust Fund to the Alabama Community College System
26 in the amount of \$501,943 for the fiscal year ending September
27 30, 2020; to make a supplemental appropriation from the

1 Education Trust Fund to the Marine Environmental Sciences
2 Consortium in the amount of \$1,000,000 for the fiscal year
3 ending September 30, 2020; to make a supplemental
4 appropriation from the Education Trust Fund to Alabama State
5 University in the amount of \$400,000 for the fiscal year
6 ending September 30, 2020; to make a supplemental
7 appropriation from the Education Trust Fund to the Alabama
8 Department of Commerce in the amount of \$1,000,000 for the
9 fiscal year ending September 30, 2020; to make a supplemental
10 appropriation from the Education Trust Fund to the Fire
11 College in the amount of \$144,000 for the fiscal year ending
12 September 30, 2020; to make a supplemental appropriation from

15 ending September 30, 2020; to make a supplemental
16 appropriation from the Education Trust Fund to the University

20 Department of Archives and History in the amount of \$50,000
21 for the fiscal year ending September 30, 2020; to make a
22 supplemental appropriation from the Education Trust Fund to
23 the Department of Early Childhood Education in the amount of
24 \$2,000,000 for the fiscal year ending September 30, 2020; to
25 make a supplemental appropriation from the Education Trust
26 Fund to Athens State University in the amount of \$280,000 for
27 the fiscal year ending September 30, 2020; to make a

1 supplemental appropriation from the Education Trust Fund to
2 Troy University in the amount of \$175,000 for the fiscal year
3 ending September 30, 2020; to make a supplemental
4 appropriation from the Education Trust Fund to the Alabama
5 Commission on Higher Education in the amount of \$240,000 for
6 the fiscal year ending September 30, 2020; to make a
7 supplemental appropriation from the Education Trust Fund to
8 the Education Trust Fund Advancement and Technology Fund in
9 the amount of \$4,775,265 for the fiscal year ending September
10 30, 2020; to amend language in Section 3B of Act 2019-403 for
11 the Alabama State Council on the Arts; to amend language in
12 Section 3B of Act 2019-403 for the Alabama School of Cyber
13 Technology and Engineering; to amend language in Section 3A of
14 Act 2019-403 for the Examiner of Public Accounts; and to
15 revise the repayment dates for certain withdrawals from the
16 Budget Stabilization Fund.

17 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

18 Section 1. In addition to all other appropriations
19 heretofore or hereafter made, there is hereby appropriated
20 \$14,085,735 from the Education Trust Fund to the State
21 Department of Education for the fiscal year ending September
22 30, 2020. Of this appropriation, \$9,835,735 shall be expended
23 for expansion of the science of reading training in support of
24 initial implementations of the Literacy Act; \$2,700,000 shall
25 be expended for additional regional math coaches and trainers
26 to expand early mathematics improvement efforts and AMSTI,
27 NUMBERS, and OGAP training opportunities; \$250,000 shall be

1 expended to be paired with existing resources of the
2 Department to continue the provision of one school safety
3 liaison per ALEA region to assist schools across the state;
4 \$1,000,000 shall be expended for a marketing campaign for
5 teachers; and \$300,000 shall be expended for teacher and
6 parent online teaching assistance grants.

7 Section 2. In addition to all other appropriations
8 heretofore or hereafter made, there is hereby appropriated
9 \$501,943 from the Education Trust Fund to the Alabama
10 Community College System for the fiscal year ending September
11 30, 2020.

12 Section 3. In addition to all other appropriations
13 heretofore or hereafter made, there is hereby appropriated
14 \$1,000,000 from the Education Trust Fund to the Marine
15 Environmental Sciences Consortium for the fiscal year ending
16 September 30, 2020 for Wetlab relocation and renovation.

17 Section 4. In addition to all other appropriations
18 heretofore or hereafter made, there is hereby appropriated
19 \$1,000,000 from the Education Trust Fund to the Alabama
20 Department of Commerce for the fiscal year ending September
21 30, 2020 to assist with the expansion of the Lockheed Martin
22 Corporation training facility.

23 Section 5. In addition to all other appropriations
24 heretofore or hereafter made, there is hereby appropriated
25 \$400,000 from the Education Trust Fund to Alabama State
26 University for the fiscal year ending September 30, 2020 for
27 one-time repair expenses for the forensics lab.

1 Section 6. In addition to all other appropriations
2 heretofore or hereafter made, there is hereby appropriated
3 \$144,000 from the Education Trust Fund to the Alabama Fire
4 College for the fiscal year ending September 30, 2020 for
5 one-time expenses for an audio/visual presentation system.

6 Section 7. In addition to all other appropriations
7 heretofore or hereafter made, there is hereby appropriated
8 \$6,878,778 from the Education Trust Fund to the Alabama
9 Institute for the Deaf and Blind for the fiscal year ending
10 September 30, 2020 to assist in the construction and expansion
11 of regional centers.

12 Section 8. In addition to all other appropriations
13 heretofore or hereafter made, there is hereby appropriated
14 \$500,000 from the Education Trust Fund to the University of
15 South Alabama for the fiscal year ending September 30, 2020
16 for one-time expenses for Children and Women's Learning
17 Hospital expansion.

18 Section 9. In addition to all other appropriations
19 heretofore or hereafter made, there is hereby appropriated
20 \$4,775,265 from the Education Trust Fund to the Education
21 Trust Fund Advancement and Technology Fund for the fiscal year
22 ending September 30, 2020 to be allocated in accordance with
23 Section 29-9-4, Code of Alabama 1975.

24 Section 10. In addition to all other appropriations
25 heretofore or hereafter made, there is hereby appropriated
26 \$50,000 from the Education Trust Fund to the Alabama

1 Department of Archives and History for the fiscal year ending
2 September 30, 2020.

3 Section 11. In addition to all other appropriations
4 heretofore or hereafter made, there is hereby appropriated
5 \$2,000,000 from the Education Trust Fund to the Department of
6 Early Childhood Education for the fiscal year ending September
7 30, 2020.

8 Section 12. In addition to all other appropriations
9 heretofore or hereafter made, there is hereby appropriated
10 \$280,000 from the Education Trust Fund to Athens State
11 University for the fiscal year ending September 30, 2020.

12 Section 13. In addition to all other appropriations
13 heretofore or hereafter made, there is hereby appropriated
14 \$175,000 from the Education Trust Fund to Troy University for
15 the fiscal year ending September 30, 2020 for the Sign
16 Language Interpretive Center.

17 Section 14. In addition to all other appropriations
18 heretofore or hereafter made, there is hereby appropriated
19 \$240,000 from the Education Trust Fund to the Alabama
20 Commission on Higher Education for the fiscal year ending
21 September 30, 2020, of which \$120,000 shall be for the City of
22 Decatur and \$120,000 shall be for Marengo County to establish
23 the Best and Brightest STEM Pilot Program for the purpose of
24 paying the student loan debt of recent STEM graduates that
25 relocate to the City of Decatur and Marengo County. Applicants
26 cannot be a resident of the subject county at the time of
27 application. The duration of the pilot program shall be no

1 more than five years and the amount available per graduate
2 shall be \$3,000 annually.

3 Section 15. All funds appropriated in this act not
4 expended in the fiscal year ending September 30, 2020 shall
5 not revert but shall be carried forward for the purpose
6 appropriated.

7 Section 16. The appropriation made within the Fine
8 Arts Program of the Alabama State Council on the Arts in
9 Section 3B of Act 2019-403 is amended to read as follows: "Of
10 the above appropriation, \$875,000 shall be expended for the
11 Alabama Center for the Arts, of which \$75,000 shall be
12 expended for Urban Art; \$75,000 shall be expended for the Arts
13 Hall of Fame; and \$200,000 shall be expended for the Alabama
14 Center for the Arts Foundation."

15 Section 17. Notwithstanding any other provision of
16 law to the contrary, any of the appropriation made in Section
17 3B of Act 2019-403 to the Alabama School of Cyber Technology
18 and Engineering which remains unexpended on September 30,
19 2020, shall be reappropriated to the school in the fiscal year
20 beginning October 1, 2020.

21 Section 18. Notwithstanding any other provision of
22 law to the contrary, any funds appropriated in Section 3A of
23 Act 2019-403 to the Department of Examiners of Public Accounts
24 for the evaluation and reorganization study of the State
25 Department of Education which remains unexpended on September
26 30, 2020, shall be reappropriated to the Department in the
27 fiscal year beginning October 1, 2020.

1 Section 19. Notwithstanding the provisions of
2 Sections 29-9-6, Code of Alabama 1975, during the fiscal year
3 ending September 30, 2020, temporary transfers from the Budget
4 Stabilization Fund into the Education Trust Fund to alleviate
5 cash flow problems shall be repaid within 180 days following
6 the date the funds are transferred. Notwithstanding the
7 provisions of Section 29-9-5(b), repayment requirements for
8 emergency withdrawals shall not apply to withdrawals made
9 prior to January 1, 2020.

10 Section 20. This act shall become effective
11 immediately upon its passage and approval by the Governor, or
12 upon its otherwise becoming law.
