Under existing law, the state imposes sales 8 SYNOPSIS: and use taxes upon certain persons, firms, or 9 10 corporations. 1 To exempt the St. Vincent de Paul Thrift Store of 2 Florence from the payment of all state, county, and municipal 3 sales and use taxes.

4 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

5 Section 1. The St. Vincent de Paul Thrift Store of 6 Florence is exempted from paying any state, county, and 7 municipal sales and use taxes.

8 Section 2. This act shall become effective on the 9 first day of the third month following its passage and 10 approval by the Governor, or its otherwise becoming law.
