A BILL
TO BE ENTITLED
AN ACT

To make a supplemental appropriation from the Education Trust Fund to the State Department of Education in the amount of \$14,085,735 for the fiscal year ending September 30, 2020; to make a supplemental appropriation from the Education Trust Fund to the Alabama Community College System in the amount of \$501,943 for the fiscal year ending September 30, 2020; to make a supplemental appropriation from the Education Trust Fund to the Marine Environmental Sciences Consortium in the amount of \$1,000,000 for the fiscal year ending September 30, 2020; to make a supplemental appropriation from the Education Trust Fund to Alabama State University in the amount of \$400,000 for the fiscal year ending September 30, 2020; to make a supplemental appropriation from the Education Trust Fund to the Alabama Department of Commerce in the amount of \$1,000,000 for the fiscal year ending September 30, 2020; to make a supplemental appropriation from the Education Trust Fund to the Fire College in the amount of \$144,000 for the fiscal year ending September 30, 2020; to make a supplemental appropriation from the Education Trust Fund to the Alabama Institute for the Deaf

1 and Blind in the amount of \$6,878,778 for the fiscal year
2 ending September 30, 2020; to make a supplemental
3 appropriation from the Education Trust Fund to the University
4 of South Alabama in the amount of \$500,000 for the fiscal year
5 ending September 30, 2020; to make a supplemental
6 appropriation from the Education Trust Fund to the Alabama
7 Department of Archives and History in the amount of \$50,000
8 for the fiscal year ending September 30, 2020; to make a
9 supplemental appropriation from the Education Trust Fund to
10 the Education Trust Fund Advancement and Technology Fund in
11 the amount of \$7,470,265 for the fiscal year ending September
12 30, 2020; to amend language in Section 3B of Act 2019-403 for
13 the Alabama State Council on the Arts; to amend language in
14 Section 3B of Act 2019-403 for the Alabama School of Cyber
15 Technology and Engineering; to amend language in Section 3A of
16 Act 2019-403 for the Examiner of Public Accounts; and to
17 revise the repayment date for temporary transfers from the
18 Budget Stabilization Fund for cash flow purposes for the
19 fiscal year ending September 30, 2020 only.

20 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

21 Section 1. In addition to all other appropriations
22 heretofore or hereafter made, there is hereby appropriated
23 \$14,085,735 from the Education Trust Fund to the State
24 Department of Education for the fiscal year ending September
25 30, 2020. Of this appropriation, \$9,835,735 shall be expended
26 for expansion of the science of reading training in support of
27 initial implementations of the Literacy Act; \$2,700,000 shall

1 be expended for additional regional math coaches and trainers
2 to expand early mathematics improvement efforts and AMSTI,
3 NUMBERS, and OGAP training opportunities; \$250,000 shall be
4 expended to be paired with existing resources of the
5 Department to continue the provision of one school safety
6 liaison per ALEA region to assist schools across the state;
7 \$1,000,000 shall be expended for a marketing campaign for
8 teachers; and \$300,000 shall be expended for teacher and
9 parent online teaching assistance grants.

10 Section 2. In addition to all other appropriations
11 heretofore or hereafter made, there is hereby appropriated
12 \$501,943 from the Education Trust Fund to the Alabama
13 Community College System for the fiscal year ending September
14 30, 2020.

15 Section 3. In addition to all other appropriations
16 heretofore or hereafter made, there is hereby appropriated
17 \$1,000,000 from the Education Trust Fund to the Marine
18 Environmental Sciences Consortium for the fiscal year ending
19 September 30, 2020 for Wetlab relocation and renovation.

20 Section 4. In addition to all other appropriations
21 heretofore or hereafter made, there is hereby appropriated
22 \$1,000,000 from the Education Trust Fund to the Alabama
23 Department of Commerce for the fiscal year ending September
24 30, 2020 to assist with the expansion of the Lockheed Martin
25 Corporation training facility.

26 Section 5. In addition to all other appropriations
27 heretofore or hereafter made, there is hereby appropriated

1 \$400,000 from the Education Trust Fund to Alabama State
2 University for the fiscal year ending September 30, 2020 for
3 one-time repair expenses for the forensics lab.

4 Section 6. In addition to all other appropriations
5 heretofore or hereafter made, there is hereby appropriated
6 \$144,000 from the Education Trust Fund to the Alabama Fire
7 College for the fiscal year ending September 30, 2020 for
8 one-time expenses for an audio/visual presentation system.

9 Section 7. In addition to all other appropriations
10 heretofore or hereafter made, there is hereby appropriated
11 \$6,878,778 from the Education Trust Fund to the Alabama
12 Institute for the Deaf and Blind for the fiscal year ending
13 September 30, 2020 to assist in the construction and expansion
14 of regional centers.

15 Section 8. In addition to all other appropriations
16 heretofore or hereafter made, there is hereby appropriated
17 \$500,000 from the Education Trust Fund to the University of
18 South Alabama for the fiscal year ending September 30, 2020
19 for one-time expenses for Children and Women's Learning
20 Hospital expansion.

21 Section 9. In addition to all other appropriations
22 heretofore or hereafter made, there is hereby appropriated
23 \$7,470,265 from the Education Trust Fund to the Education
24 Trust Fund Advancement and Technology Fund for the fiscal year
25 ending September 30, 2020 to be allocated in accordance with
26 Section 29-9-4, Code of Alabama 1975.

1 Section 10. In addition to all other appropriations
2 heretofore or hereafter made, there is hereby appropriated
3 \$50,000 from the Education Trust Fund to the Alabama
4 Department of Archives and History for the fiscal year ending
5 September 30, 2020.

6 Section 11. All funds appropriated in this act not
7 expended in the fiscal year ending September 30, 2020 shall
8 not revert but shall be carried forward for the purpose
9 appropriated.

10 Section 12. The appropriation made within the Fine
11 Arts Program of the Alabama State Council on the Arts in
12 Section 3B of Act 2019-403 is amended to read as follows: "Of
13 the above appropriation, \$875,000 shall be expended for the
14 Alabama Center for the Arts, of which \$75,000 shall be
15 expended for Urban Art; \$75,000 shall be expended for the Arts
16 Hall of Fame; and \$200,000 shall be expended for the Alabama
17 Center for the Arts Foundation."

18 Section 13. Notwithstanding any other provision of
19 law to the contrary, any of the appropriation made in Section
20 3B of Act 2019-403 to the Alabama School of Cyber Technology
21 and Engineering which remains unexpended on September 30,
22 2020, shall be reappropriated to the school in the fiscal year
23 beginning October 1, 2020.

24 Section 14. Notwithstanding any other provision of
25 law to the contrary, any funds appropriated in Section 3A of
26 Act 2019-403 to the Department of Examiners of Public Accounts
27 for the evaluation and reorganization study of the State

1 Department of Education which remains unexpended on September
2 30, 2020, shall be reappropriated to the Department in the
3 fiscal year beginning October 1, 2020.

4 Section 15. Notwithstanding the provisions of
5 Sections 29-9-6, Code of Alabama 1975, during the fiscal year
6 ending September 30, 2020, temporary transfers from the Budget
7 Stabilization Fund into the Education Trust Fund to alleviate
8 cash flow problems shall be repaid within 180 days following
9 the date the funds are transferred.

10 Section 16. This act shall become effective
11 immediately upon its passage and approval by the Governor, or
12 upon its otherwise becoming law.
