8 To make an appropriation of \$367,290 from the
9 Education Trust Fund to Lyman Ward Military Academy in Camp
10 Hill, Alabama for the support and maintenance of the
11 educational program of the institution, for the fiscal year
12 ending September 30, 2021; to provide that the appropriation
13 is subject to certain provisions of the Code of Alabama 1975;
14 to require an operations plan and an audited financial
15 statement prior to the release of any funds; and to require an
16 end of year report.

17 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

18 Section 1. There is hereby appropriated the sum of
19 \$367,290 from the Education Trust Fund to Lyman Ward Military
20 Academy in Camp Hill, Alabama for the support and maintenance
21 of the educational program of the institution, for the fiscal
22 year ending September 30, 2021.

23 Section 2. The above appropriation is made for the
24 support of public education in Alabama and for the support and
25 maintenance of the above program. The appropriation shall be
26 subject to the provisions, terms, conditions, and limitations
27 of the Budget and Financial Control Act, Code of Alabama 1975,

1 Sections 41-4-80 et seq.; the provisions of The Budget
2 Management Act of 1976, Code of Alabama 1975, Sections 41-19-1
3 et seq.; and any other provisions of this act.

4 Section 3. (a) Prior to the release of any funds
5 appropriated under this act the following reports shall be
6 submitted:

7 (1) An operations plan for the fiscal year 2021,
8 including goals and measurable performance indicators, shall
9 be submitted to and approved by the Director of Finance, as
10 provided for state agencies in Code of Alabama 1975, Section
11 41-19-10.

12 (2) An audited financial statement for all
13 operations during the fiscal year 2019.

14 (b) It is the intent that funds appropriated for
15 fiscal year 2021 shall be released by the Director of Finance
16 following receipt of the above reports.

17 (c) In addition, quarterly reports shall be made to
18 the Director of Finance relating actual expenditures and
19 accomplishments to planned expenditures and accomplishments.
20 An end of year performance report for the fiscal year 2021
21 shall be made to the Director of Finance stating the work
22 accomplished and the services provided and the costs of
23 accomplishing the work and providing the services, citing
24 meaningful measures of program effectiveness and costs, as is
25 required for state agencies in Code of Alabama 1975, Section
26 41-19-11.

1 (d) The Director of Finance shall forward a copy of
2 all required reports to the Legislative Council in a timely
3 manner.

4 Section 4. This act shall become effective October
5 1, 2020.
