11 Relating to the medical use of cannabis; to add a
12 new Chapter 2A to Title 20, Code of Alabama 1975; to amend
13 Section 13A-7-2, Code of Alabama 1975; to create the
14 Compassion Act; to provide civil and criminal protections to
15 certain patients with a qualifying medical condition who have
16 a valid medical cannabis card for the medical use of cannabis;
17 to establish the Alabama Medical Cannabis Commission and
18 provide for its membership and duties; to provide for
19 certification of patients to authorize use of medical
20 cannabis; to license and regulate the cultivation, processing,
21 transporting, testing, and dispensing of medical cannabis; to
22 prohibit certain types of medical cannabis products; to
23 provide for patient registry and seed-to-sale tracking; to
24 impose taxes; to provide certain legal protections for users
25 of medical cannabis; to provide certain legal protections for
26 employers; to provide further for workers' compensation
27 benefits in certain circumstances where an employee uses

1 medical cannabis; to amend the crime of trespass in the first
2 degree; to establish the Medical Cannabis Research Consortium
3 to award research grants using tax proceeds; and in connection
4 therewith would have as its purpose or effect the requirement
5 of a new or increased expenditure of local funds within the
6 meaning of Amendment 621 of the Constitution of Alabama of
7 1901, now appearing as Section 111.05 of the Official
8 Recompilation of the Constitution of Alabama of 1901, as
9 amended.

10 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

11 Section 1. Chapter 2A, commencing with Section
12 20-2A-1, is added to Title 20, Code of Alabama 1975, to read
13 as follows:

14 Article 1. General Provisions.

15 §20-2A-1.

16 This chapter shall be known and may be cited as the
17 Compassion Act.

18 §20-2A-2.

19 The Legislature finds all of the following:

20 (1) It is not the intent of this chapter to provide
21 for or enable recreational use of marijuana in the State of
22 Alabama.

23 (2) Medical research indicates that the
24 administration of medical cannabis can successfully treat
25 various medical conditions and alleviate the symptoms of
26 various medical conditions.

1 (3) There are residents in Alabama suffering from a
2 number of medical conditions whose symptoms could be
3 alleviated by the administration of medical cannabis products
4 if used in a controlled setting under the supervision of a
5 physician licensed in this state.

6 (4) A majority of states have adopted a program
7 providing for the administration of cannabis or cannabis
8 derivatives for medical use for residents of their states.

9 (5) Establishing a program providing for the
10 administration of cannabis derivatives for medical use in this
11 state can not only benefit patients by providing relief to
12 pain and other debilitating symptoms, provide opportunities
13 for patients with these debilitating conditions to function
14 and have a better quality of life, but also provide employment
15 and business opportunities for farmers and other residents of
16 this state and revenue to state and local governments.

17 (6) It is important to balance the needs of
18 employers to have a strong functioning workforce with the
19 needs of employees who will genuinely benefit from using
20 cannabis for a medical use in a manner that makes the employee
21 a productive employee.

22 §20-2A-3.

23 As used in this chapter, the following terms have
24 the following meanings:

25 (1) BOARD. The State Board of Medical Examiners.

26 (2) CANNABIS. a. Except as provided in paragraph b.,
27 all parts of any plant of the genus cannabis, whether growing

1 or not, including the seeds, extractions of any kind from any
2 part of the plant, and every compound, derivative, mixture,
3 product, or preparation of the plant.

4 b. The term does not include industrial hemp or hemp
5 regulated under Article 11 of Chapter 8 of Title 2.

6 (3) COMMISSION. The Alabama Medical Cannabis
7 Commission created pursuant to Section 20-2A-20.

8 (4) CULTIVATOR. An entity licensed by the Department
9 of Agriculture and Industries under Section 20-2A-62
10 authorized to grow cannabis pursuant to Article 4.

11 (5) DAILY DOSAGE. The total amount of one or more
12 cannabis derivatives, including, but not limited to,
13 cannabidiol and tetrahydrocannabinol, which may be present in
14 a medical cannabis product that may be ingested by a
15 registered qualified patient during a 24-hour period, as
16 determined by a registered certifying physician.

17 (6) DEPARTMENT. The Department of Agriculture and
18 Industries.

19 (7) DISPENSARY. An entity licensed by the commission
20 under Section 20-2A-64 authorized to dispense and sell medical
21 cannabis at dispensing sites to registered qualified patients
22 and registered caregivers pursuant to Article 4.

23 (8) DISPENSING SITE. A site operated by an
24 dispensary licensee or an integrated facility licensee
25 pursuant to Article 4.

26 (9) FACILITY or MEDICAL CANNABIS FACILITY. Any
27 facility, or land associated with a facility, of a licensee.

1 (10) INTEGRATED FACILITY. An entity licensed under
2 Section 20-2A-67 authorized to perform the functions of a
3 cultivator, processor, secure transporter, and dispensary
4 pursuant to Article 4.

5 (11) LICENSEE. A cultivator, processor, secure
6 transporter, state testing laboratory, dispensary, or
7 integrated facility licensed by the commission under Article
8 4.

9 (12) MEDICAL CANNABIS. a. A medical grade product in
10 the form of any of the following, as determined by rule by the
11 commission, that contains a derivative of cannabis for medical
12 use by a registered qualified patient pursuant to this
13 chapter:

- 14 1. Oral tablet, capsule, or tincture.
- 15 2. Gelatinous cube, gelatinous rectangular cuboid,
16 or lozenge in a cube or rectangular cuboid shape.
- 17 3. Gel, oil, cream, or other topical preparation.
- 18 4. Suppository.
- 19 5. Transdermal patch.
- 20 6. Nebulizer.
- 21 7. Liquid or oil for administration using an
22 inhaler.

- 23 b. The term does not include any of the following:
 - 24 1. Raw plant material.
 - 25 2. Any product administered by smoking, combustion,
26 or vaping.

1 3. A food product that has medical cannabis baked,
2 mixed, or otherwise infused into the product, such as cookies
3 or candies.

4 (13) MEDICAL CANNABIS CARD. A valid card issued
5 pursuant to Section 20-2A-35 or a temporary card issued
6 pursuant to Section 20-2A-36.

7 (14) MEDICAL USE or USE OF MEDICAL CANNABIS or USE
8 MEDICAL CANNABIS. The acquisition, possession, use, delivery,
9 transfer, or administration of medical cannabis authorized by
10 this chapter. The term does not include possession, use, or
11 administration of cannabis that was not purchased or acquired
12 from a licensed dispensary.

13 (15) PACKAGE. Any container that a processor may use
14 for enclosing and containing medical cannabis. The term does
15 not include any carry-out bag or other similar container.

16 (16) PATIENT REGISTRY. The Alabama Medical Cannabis
17 Patient Registry System that is an electronic integrated
18 system that tracks physician certifications, patient
19 registrations, medical cannabis cards, the daily dosage and
20 type of medical cannabis recommended to qualified patients by
21 registered certifying physicians, and the dates of sale,
22 amounts, and types of medical cannabis that were purchased by
23 registered qualified patients at licensed dispensaries.

24 (17) PHYSICIAN CERTIFICATION. A registered
25 certifying physician's authorization for a registered
26 qualified patient to use medical cannabis.

1 (18) PROCESSOR. An entity licensed by the commission
2 under Section 20-2A-63 authorized to purchase cannabis from a
3 cultivator and extract derivatives from the cannabis to
4 produce a medical cannabis product or products for sale and
5 transfer in packaged and labeled form to a dispensing site
6 pursuant to Article 4.

7 (19) QUALIFYING MEDICAL CONDITION. Any of the
8 following conditions or symptoms of conditions, but only after
9 documentation indicates that conventional medical treatment or
10 therapy has failed unless current medical treatment indicates
11 that use of medical cannabis is the standard of care:

- 12 a. Anxiety or panic disorder.
- 13 b. Autism Spectrum Disorder (ASD).
- 14 c. Cancer-related cachexia, nausea or vomiting,
15 weight loss, or chronic pain.
- 16 d. Crohn's Disease.
- 17 e. Epilepsy or a condition causing seizures.
- 18 f. Fibromyalgia.
- 19 g. HIV/AIDS-related nausea or weight loss.
- 20 h. Persistent nausea that is not significantly
21 responsive to traditional treatment, except for nausea related
22 to pregnancy, cannabis-induced cyclical vomiting syndrome, or
23 cannabinoid hyperemesis syndrome.
- 24 i. Post Traumatic Stress Disorder (PTSD).
- 25 j. Sleep disorders.
- 26 k. Spasticity associated with a motor neuron
27 disease, including Amyotrophic Lateral Sclerosis.

1 l. Spasticity associated with Multiple Sclerosis or
2 a spinal cord injury.

3 m. A terminal illness.

4 n. Tourette's Syndrome.

5 o. A condition causing chronic or intractable pain
6 in which conventional therapeutic intervention and opiate
7 therapy is contraindicated or has proved ineffective.

8 p. Menopause or premenstrual syndrome.

9 (20) REGISTERED CAREGIVER. An individual who meets
10 the requirements described in subsection (c) of Section
11 20-2A-30 and is authorized to acquire and possess medical
12 cannabis and to assist one or more registered qualified
13 patients with the use of medical cannabis pursuant to this
14 chapter.

15 (21) REGISTERED CERTIFYING PHYSICIAN. A physician
16 authorized by the State Board of Medical Examiners to certify
17 patients for the use of medical cannabis pursuant to this
18 chapter.

19 (22) REGISTERED QUALIFIED PATIENT. Either of the
20 following:

21 a. An adult who meets the requirements described in
22 subsection (a) of Section 20-2A-30 and is authorized to
23 acquire, possess, and use medical cannabis pursuant to this
24 chapter.

25 b. A minor who meets the requirements described in
26 subsection (b) of Section 20-2A-30 and is authorized to use

1 medical cannabis pursuant to this chapter with the assistance
2 of a registered caregiver.

3 (23) SECURE TRANSPORTER. An entity licensed by the
4 commission under Section 20-2A-65 authorized to transport
5 cannabis or medical cannabis from one licensed facility or
6 site to another licensed facility or site.

7 (24) STATE TESTING LABORATORY. An entity licensed
8 under Section 20-2A-66 authorized to test cannabis and medical
9 cannabis to ensure the product meets safety qualifications
10 required under this chapter.

11 (25) STATEWIDE SEED-TO-SALE TRACKING SYSTEM. The
12 tracking system established pursuant to Section 20-2A-54 that
13 tracks all cannabis and medical cannabis in the state.

14 (26) UNIVERSAL STATE SYMBOL. The image established
15 by the commission pursuant to Section 20-2A-53 made available
16 to processors which indicates the package contains medical
17 cannabis.

18 §20-2A-4.

19 This chapter supersedes state criminal and civil
20 laws pertaining to the acquisition, possession, use,
21 cultivation, manufacturing, processing, research and
22 development, and sale of medical cannabis. The acquisition,
23 possession, use, cultivation, manufacturing, processing,
24 research and development, transportation, testing, or sale of
25 cannabis or medical cannabis in compliance with this chapter
26 and rules of the commission does not constitute a violation of

1 Article 5 of Chapter 12 of Title 13A, or any other law to the
2 contrary.

3 §20-2A-5.

4 All data related to the implementation of this
5 chapter, including, but not limited to, application forms,
6 licensing information, physician certifications, registration
7 of qualified patients and designated caregivers, compliance,
8 and the status of cannabis research programs must be
9 maintained in a secure system developed or procured by the
10 commission. Data may not be sold, and patient information
11 shall remain confidential, except as otherwise permitted
12 pursuant to this chapter, and may not be transferred or sold.

13 §20-2A-6.

14 (a) This chapter does not do any of the following:

15 (1) Require an insurer, organization for managed
16 care, health benefit plan, or any individual or entity
17 providing coverage for a medical or health care service to pay
18 for or to reimburse any other individual or entity for costs
19 associated with the use of medical cannabis.

20 (2) Require any employer to permit, accommodate, or
21 allow the use of medical cannabis, or to modify any job or
22 working conditions of any employee who engages in the use of
23 medical cannabis or for any reason seeks to engage in the use
24 of medical cannabis.

25 (3) Prohibit any employer from refusing to hire,
26 discharging, disciplining, or otherwise taking an adverse
27 employment action against an individual with respect to

1 hiring, discharging, tenure, terms, conditions, or privileges
2 of employment as a result, in whole or in part, of that
3 individual's use of medical cannabis, regardless of the
4 individual's impairment or lack of impairment resulting from
5 the use of medical cannabis.

6 (4) Prohibit or limit the ability of any employer
7 from establishing or enforcing a drug testing policy,
8 including, but not limited to, a policy that prohibits the use
9 of medical cannabis in the workplace or from implementing a
10 drug-free workforce program established in accordance with
11 Article 13, commencing with Section 25-5-330, of Chapter 5 of
12 Title 25.

13 (5) Prohibit or limit any employer from adopting an
14 employment policy requiring its employees to notify the
15 employer if an employee possesses a medical cannabis card.

16 (6) Interfere with, impair, or impede, any federal
17 restrictions on employment, including, but not limited to,
18 regulations adopted by the United States Department of
19 Transportation in Title 49, Code of Federal Regulations.

20 (7) Permit, authorize, or establish any individual's
21 right to commence or undertake any legal action against an
22 employer for refusing to hire, discharging, disciplining, or
23 otherwise taking an adverse employment action against an
24 individual with respect to hiring, discharging, tenure, terms,
25 conditions, or privileges of employment due to the
26 individual's use of medical cannabis.

1 (8) Require a government medical assistance program,
2 employer, property and casualty insurer, or private health
3 insurer to reimburse an individual for costs associated with
4 the use of medical cannabis.

5 (9) Affect, alter, or otherwise impact the workers'
6 compensation premium discount available to employers who
7 establish a drug-free workplace policy certified by the
8 Department of Labor, Workers' Compensation Division, in
9 accordance with Article 13, commencing with Section 25-5-330,
10 of Chapter 5 of Title 25.

11 (10) Affect, alter, or otherwise impact an
12 employer's right to deny, or establish legal defenses to, the
13 payment of workers' compensation benefits to an employee on
14 the basis of a positive drug test or refusal to submit to or
15 cooperate with a drug test, as provided under Section 25-5-51.

16 (b) For the purpose of obtaining needed medical
17 care, including organ transplants, a registered qualified
18 patient's authorized use of medical cannabis in accordance
19 with this chapter is considered the equivalent of the
20 authorized use of any other medication used at the direction
21 of a licensed health care professional and may not constitute
22 the use of an illicit substance or otherwise disqualify a
23 registered qualified patient from such needed medical care.

24 (c) An individual who is discharged from employment
25 because of that individual's use of medical cannabis, or
26 refusal to submit to or cooperate with a drug test, shall be
27 legally conclusively presumed to have been discharged for

1 misconduct if the conditions of paragraph a. of subdivision
2 (3) of Section 25-4-78 are otherwise met.

3 (d) Nothing in this chapter shall prohibit the
4 Department of Human Resources from considering a parent or
5 caretaker's use of medical cannabis as a factor for
6 determining the welfare of a child in any of the following
7 circumstances:

8 (1) There is evidence of child abuse or neglect.

9 (2) The best interest of a child is determined for
10 custody purposes.

11 (3) A background check is performed for a
12 prospective foster, adoptive, or kinship caretaker.

13 §20-2A-7.

14 (a) A registered qualified patient 19 years of age
15 or older or registered caregiver is not subject to arrest or
16 prosecution for unlawful possession of marijuana if he or she
17 possesses no more than 70 daily dosages of medical cannabis
18 and has a valid medical cannabis card.

19 (b) A registered certifying physician who acts in
20 good faith compliance with this chapter regarding the dosage
21 established under this chapter and the applicable
22 administrative rules established pursuant to this chapter
23 shall be immune from civil and criminal prosecution and is not
24 subject to arrest, prosecution, or penalty in any manner and
25 may not be denied any right or privilege, including, but not
26 limited to, protection from civil penalty for certifying
27 patients under Section 20-2A-33 or for otherwise stating that,

1 in the physician's professional opinion, a patient is likely
2 to receive therapeutic or palliative benefit from the medical
3 use of medical cannabis to treat or alleviate the patient's
4 qualifying medical condition or symptoms associated with the
5 qualifying medical condition, provided that nothing shall
6 prevent the board from disciplining a physician. Nothing in
7 this chapter shall modify, amend, repeal, or supersede any
8 provision of Section 6-5-333, the Alabama Medical Liability
9 Act of 1987, commencing with Section 6-5-540, or the Alabama
10 Medical Liability Act of 1996, commencing with Section
11 6-5-548, or any amendment to any of these laws or judicial
12 interpretation of these laws.

13 (c) A licensee or any employee of that licensee is
14 not subject to arrest or prosecution if the person is acting
15 pursuant to this chapter and within the scope of his or her
16 employment.

17 (d) A hospital, medical facility, or hospice program
18 where a registered qualified patient is receiving treatment in
19 accordance with this chapter is not subject to arrest,
20 prosecution, or penalty in any manner, or denied any right or
21 privilege solely for providing that treatment.

22 (e) Mere possession of, or application for, a
23 medical cannabis card does not constitute probable cause or
24 reasonable suspicion, nor shall it be used as the sole basis
25 to support the search of the person, property, or home of the
26 individual possessing or applying for the medical cannabis
27 card. The possession of, or application for, a medical

1 cannabis card does not preclude the existence of probable
2 cause if probable cause exists on other grounds.

3 (f) Nothing in this chapter shall preclude the
4 Alabama State Law Enforcement Agency or a local law
5 enforcement agency from searching a licensee where there is
6 probable cause to believe that a criminal law has been
7 violated and the search is conducted in conformity with
8 constitutional and state law.

9 §20-2A-8.

10 (a) (1) An individual may not distribute, possess,
11 manufacture, or use medical cannabis or a medical cannabis
12 product that has been diverted from a registered qualified
13 patient, a registered caregiver, or a licensed cultivator,
14 processor, secure transporter, dispensary, or a state testing
15 laboratory.

16 (2) An individual who violates this section is
17 guilty of a Class B felony.

18 (3) The penalty under this section is in addition to
19 any penalties that a person may be subject to for manufacture,
20 possession, or distribution of marijuana under Title 13A.

21 (b) This chapter does not permit any individual to
22 engage in, and does not prevent the imposition of any civil,
23 criminal, or other penalty for engaging in any of the
24 following conduct:

25 (1) Undertaking any task under the influence of
26 cannabis, when doing so would constitute negligence,

1 professional malpractice, or professional misconduct, or
2 violation of law.

3 (2) Possessing or using medical cannabis on any
4 property of a K-12 school or day care or child care facility,
5 in any correctional facility, or in a vehicle unless the
6 medical cannabis is in its original package and is sealed and
7 reasonably inaccessible while the vehicle is moving.

8 §20-2A-9.

9 The commission shall provide annual written reports
10 to the Legislature, with the first due no later than January
11 1, 2022, tracking implementation of this chapter. The report
12 shall be made publicly available and posted on the
13 commission's website. The report shall include all of the
14 following:

15 (1) The number of patients applying for and
16 receiving medical cannabis cards.

17 (2) The qualifying medical conditions identified to
18 obtain the medical cannabis cards.

19 (3) Comments from physicians and other health care
20 providers and from pharmacists.

21 (4) Revenues and expenses of card issuance and
22 licensing of medical cannabis facilities.

23 (5) Relevant developments in other states' cannabis
24 laws.

25 (6) Relevant scientific research.

26 (7) Applicable tax revenue.

1 (8) The commission's annual operating expenses and
2 revenues.

3 (9) The number of total applicants for each type of
4 license under Article 4 and the number of veterans,
5 minorities, and women who applied and the number of these
6 applicants who were denied a license.

7 (10) Any other information available to the
8 commission that would inform public officials of how this
9 chapter affects the public.

10 (11) Any suggested legislative changes to this
11 chapter or other state laws, including all of the following:

12 a. Any suggestions to ensure that veterans, women,
13 and minorities are not unfairly discriminated against in
14 obtaining licenses under Article 4.

15 b. Changes to reflect changes in federal law or
16 regulation.

17 c. Changes based on additional medical or scientific
18 research.

19 §20-2A-10.

20 (a) There is created a special account in the State
21 Treasury to be known as the Medical Cannabis Commission Fund.
22 Expenditures from the Medical Cannabis Commission Fund may be
23 made only by the commission to implement, administer, and
24 enforce this chapter. Specifically, the Medical Cannabis
25 Commission Fund includes all of the following:

26 (1) Tax proceeds collected pursuant to subsections
27 (a) and (b) of Section 2 of the act adding this language, less

1 an amount sufficient to cover the cost of administration of
2 the tax levies imposed under subsections (a) and (b) of
3 Section 2, which shall be retained by the Department of
4 Revenue.

5 (2) License fees, civil penalties, and other fees or
6 charges collected pursuant to Article 4 of the act adding this
7 language.

8 (3) Any monies appropriated by the Legislature for
9 the initial operation of the commission.

10 (b) Amounts in the Medical Cannabis Commission Fund
11 shall be budgeted and allotted in accordance with Section
12 41-4-80 through 41-4-96 and Sections 41-19-1 through 41-19-12,
13 but shall not be limited by the fiscal year appropriation cap.

14 (c) Beginning October 1, 2025, any funds in the
15 Medical Cannabis Commission Fund in excess of actual expenses
16 from the previous fiscal year shall be distributed, less 10
17 percent, as follows:

18 (1) 60 percent shall be transferred to the General
19 Fund.

20 (2) 30 percent shall be transferred to the Medical
21 Cannabis Research Fund established pursuant to subsection (f)
22 of Section 4.

23 §20-2A-11.

24 The possession of a medical cannabis card lawfully
25 obtained pursuant to this chapter does not infringe on the
26 cardholder's state or federal constitutional rights.

27 Article 2. Alabama Medical Cannabis Commission.

1 §20-2A-20.

2 (a) The Alabama Medical Cannabis Commission is
3 established. The commission shall consist of the following
4 members, with initial members appointed not later than July 1,
5 2020:

6 (1) Three members appointed by the Governor, one of
7 whom is a physician licensed to practice medicine in this
8 state; one of whom is a licensed pharmacist; and one of whom
9 has experience in agricultural lending or banking. Initial
10 terms shall be four, three, and two years, respectively.

11 (2) Three members appointed by the Lieutenant
12 Governor, one of whom is a physician licensed to practice
13 medicine in this state certified in the specialty of
14 pediatrics; one of whom is licensed to practice law in this
15 state who specializes in health law; and one of whom is a
16 biochemist. Initial terms shall be one, four, and three years,
17 respectively.

18 (3) Two members appointed by the President Pro
19 Tempore of the Senate, one of whom is a physician licensed to
20 practice medicine in this state certified in the specialty of
21 oncology; and one of whom has experience in multiple crop
22 development and agricultural practices. Initial terms shall be
23 two and one years, respectively.

24 (4) Two members appointed by the Speaker of the
25 House of Representative, one of whom has a background and
26 experience in mental health or substance abuse counselling and
27 treatment; and one of whom has professional experience in

1 agricultural systems management. Initial terms shall be four
2 and three years, respectively.

3 (5) One member appointed by the Commissioner of
4 Agriculture and Industries who is experienced in agricultural
5 production or agronomic or other horticultural practices. The
6 initial term shall be two years.

7 (b) Each commission member appointed to the
8 commission is subject to confirmation by the Senate during the
9 legislative session in which the appointment is made or, if
10 the appointment is made when the Legislature is not in
11 session, during the next special or regular session. An
12 appointee may serve in the position pending confirmation by
13 the Senate. Each member of the committee shall serve after the
14 expiration of his or her term until his or her successor is
15 appointed.

16 (c) A member may not have any interest, financial or
17 otherwise, direct or indirect, in any facility licensed under
18 Article 4 in this state. Any current public official,
19 candidate for public office, current public employee, or
20 registered lobbyist may not serve as a member.

21 (d) Members must be at least 30 years of age and
22 residents of this state for at least five continuous years
23 immediately preceding their appointment. The appointing
24 officers shall coordinate their appointments so that diversity
25 of gender, race, and geographical areas is reflective of the
26 makeup of this state.

1 (e) After initial appointments, each member shall
2 serve a term of four years, but may be reappointed for one
3 additional term. If at any time there is a vacancy, a
4 successor member shall be appointed by the respective
5 appointing officer to serve for the remainder of the term.
6 Members may be removed for cause by the appointing authority.

7 (f) The commission shall elect from the membership
8 one member to serve as chair and one member to serve as
9 vice-chair.

10 (g) While serving on business of the commission,
11 members shall be entitled to a per diem of five hundred
12 dollars (\$500) per day, as well as actual travel expenses
13 incurred in the performance of duties as a member, as other
14 state employees are paid, when approved by the chair.

15 (h) The commission shall meet at least six times per
16 year and hold other meetings for any period of time as may be
17 necessary for the commission to transact and perform its
18 official duties and functions. A majority of members of the
19 commission shall constitute a quorum for the transaction of
20 any business, or in the performance of any duty, power, or
21 function of the commission, and the concurrence of a majority
22 of those present and voting in any matter within its duties is
23 required for a determination of matters within its
24 jurisdiction. A special meeting may be called by the chair, or
25 upon the written request of two or more members. All members
26 shall be duly notified by the commission director of the time
27 and place of any regular or special meeting at least thirty

1 days in advance of any meeting. Members may participate by
2 telephone, video conference, or by similar communications
3 equipment so that all individuals participating in the meeting
4 may hear each other at the same time. Participating by such
5 means shall constitute presence in person at a meeting for all
6 purposes. The chair shall be responsible for setting and
7 keeping a meeting schedule that ensures the commission meets
8 the requirements of this chapter. A member who misses more
9 than two meetings in one calendar year shall be subject to
10 removal by his or her appointing authority.

11 (i) (1) The commission may employ a director to serve
12 at the pleasure of the commission. The director's salary shall
13 be fixed by the commission and shall not be subject to Section
14 36-6-6. The director shall be at least 30 years of age and
15 have been a citizen and resident of this state for at least
16 five years prior to employment. The director is the chief
17 administrative officer of the commission, and all personnel
18 employed by the commission shall be under the director's
19 direct supervision. The director shall be solely responsible
20 to the commission for the administration and enforcement of
21 this chapter and responsible for the performance of all duties
22 and functions delegated by the commission.

23 (2) The director shall maintain all records of the
24 commission and also serve as secretary of the commission. The
25 director shall prepare and keep the minutes of all meetings
26 held by the commission, including a record of all business
27 transacted and decisions rendered by the commission. A copy of

1 the record of the minutes and business transacted and
2 decisions rendered shall be kept on file at the commission's
3 main office and shall be available for public inspection.

4 (3) If the director is licensed to practice law in
5 this state, he or she shall act and serve as hearing officer
6 when designated by the commission and shall perform such
7 duties as the regular hearing officer.

8 (j) The commission may employ an assistant director
9 who shall perform all duties and functions which may be
10 assigned by the director or the commission. The assistant
11 director, if licensed to practice law in this state, may also
12 be designated by the commission to sit, act, and serve as a
13 hearing officer, and when designated as a hearing officer, the
14 assistant director may perform the same duties and functions
15 as the regular hearing officer.

16 (k) Each member of the commission shall be entitled
17 to the immunity provided by Section 36-1-12.

18 (l) In any action or suit brought against the
19 members of the commission in their official capacity in a
20 court of competent jurisdiction, to review any decision or
21 order issued by the commission, service of process issued
22 against the commission may be lawfully served or accepted by
23 the director on behalf of the commission as though the members
24 of the commission were personally served with process.

25 (m) The commission may employ additional officers,
26 including an inspection officer. The director, assistant
27 director, and any other officer or employee shall be

1 reimbursed for actual travel expenses as other state employees
2 are paid, when approved by the chair.

3 (n) The commission shall retain legal counsel
4 familiar with the requirements of this chapter and medical
5 cannabis licensing and best practices in other states in order
6 to assist the commission and staff with establishing a
7 functional program and achieving compliance with applicable
8 laws.

9 (o) All employees of the commission shall not be
10 subject to the state Merit System Act.

11 (p) The commission shall be subject to the Alabama
12 Administrative Procedure Act.

13 §20-2A-21.

14 (a) A member of the commission and any individual
15 employed by the commission may not have any interest,
16 financial or otherwise, either direct or indirect, in any
17 licensee. In addition, a member or employee of the commission
18 may not have any family member who is employed by any
19 dispensary, cultivator, or manufacturer or who holds any
20 cannabis license in this state. A member or employee of the
21 commission or his or her family member may not have an
22 interest of any kind in any building, fixture, or premises
23 occupied by any person licensed under this chapter; and may
24 not own any stock or have any interest of any kind, direct or
25 indirect, pecuniary or otherwise, by a loan, mortgage, gift,
26 or guarantee of payment of a loan, in any dispensary,
27 cultivator, or manufacturer licensed under this chapter.

1 (b) A member or employee of the commission may not
2 accept any gift, favor, merchandise, donation, contribution,
3 or any article or thing of value, from any person licensed
4 under this chapter.

5 (c) Any individual violating this section shall be
6 terminated from employment or position, and as a consequence,
7 the individual shall forfeit any pay or compensation which
8 might be due.

9 (d) For purposes of this section, family member
10 includes a spouse, child, parent, or sibling, by blood or
11 marriage.

12 (e) In addition to any violation of Chapter 25 of
13 Title 36, a violation of this section is a Class C
14 misdemeanor.

15 §20-2A-22.

16 (a) The Alabama Medical Cannabis Commission shall
17 implement this chapter by making medical cannabis derived from
18 cannabis grown in Alabama available to registered qualified
19 patients and by licensing facilities that process, transport,
20 test, or dispense medical cannabis.

21 (b) The commission shall administer and enforce this
22 chapter and all rules adopted pursuant to this chapter.

23 Article 3. Physician Certifications, Medical
24 Cannabis Patient Registry, and Medical Cannabis Cards.

25 §20-2A-30.

1 (a) (1) A resident of this state who is 19 years of
2 age or older is a registered qualified patient if he or she
3 meets all of the following conditions:

4 a. Has been certified by a registered certifying
5 physician as having a qualifying medical condition.

6 b. Is registered with the commission.

7 c. Has been issued a valid medical cannabis card by
8 the commission.

9 (2) A registered qualified patient described in
10 subdivision (1) may purchase, possess, or use medical
11 cannabis, subject to subsection (d).

12 (b) (1) A resident of this state who is under the age
13 of 19 is a registered qualified patient if he or she meets all
14 of the following conditions:

15 a. Has been certified by a registered certifying
16 physician as having a qualifying medical condition.

17 b. Is registered with the commission.

18 c. Has a qualified designated caregiver who is the
19 patient's parent or legal guardian.

20 (2) A registered qualified patient described in
21 subdivision (1) may use medical cannabis but may not purchase
22 or possess medical cannabis.

23 (c) (1) A resident of this state who is 19 years of
24 age or older is a registered caregiver if he or she meets both
25 of the following conditions:

26 a. Is registered with the commission.

1 b. Has been issued a valid medical cannabis card by
2 the commission.

3 (2) A registered caregiver described in subdivision
4 (1) may purchase and possess medical cannabis, subject to
5 subsection (d), but may not use medical cannabis unless he or
6 she is also a registered qualified patient.

7 (3) The commission, by rule, may limit the number of
8 registered qualified patients a registered caregiver may have
9 under his or her care.

10 (4) A registered caregiver may receive compensation
11 for services provided to a registered qualified patient
12 pursuant to this chapter.

13 (d) Notwithstanding subdivision (2) of subsections
14 (a) and (c), a registered qualified patient or registered
15 caregiver may not purchase more than 60 daily dosages of
16 medical cannabis and may not renew the supply more than 10
17 days before the 60-day period expires. At no time may a
18 registered qualified patient or registered caregiver possess
19 more than 70 daily dosages of medical cannabis.

20 §20-2A-31.

21 (a) In order for a physician to qualify as a
22 registered certifying physician, he or she must meet the
23 following requirements:

24 (1) Hold an active license to practice medicine
25 under Chapter 24 of Title 34.

26 (2) Complete a four-hour course related to medical
27 cannabis and complete a subsequent examination, both of which

1 shall be offered by a multi-specialty statewide professional
2 organization of physicians in this state that is recognized to
3 accredit intrastate organizations to provide AMA PRA category
4 1 credits. The course must be administered at least annually
5 and may be offered in a distance learning format, including an
6 electronic online format upon request. The price of the course
7 may not exceed five hundred dollars (\$500). Every two years
8 thereafter, in order to requalify, a certifying physician must
9 complete a two-hour refresher course offered by an entity
10 described in this subdivision.

11 (3) Meet any additional qualifications established
12 by rule by the board.

13 (b) Upon meeting the requirements of subsection (a),
14 the board shall issue a registration certificate and
15 registration number to each registered certifying physician.
16 The board shall maintain on its website an updated list of
17 registered certifying physicians.

18 (c) The board, by rule, may establish requirements
19 for registered certifying physicians to remain qualified,
20 grounds for revoking registration, and a process for renewing
21 registration of qualified certifying physicians.

22 §20-2A-32.

23 A registered certifying physician may not do any of
24 the following:

25 (1) Except for the limited purpose of performing a
26 medical cannabis-related study, accept, solicit, or offer any
27 form of remuneration from or to a qualified patient,

1 designated caregiver, or any licensee, including a principal
2 officer, board member, agent, or employee of the licensee, to
3 certify a patient, other than accepting payment from a patient
4 for the fee associated with the examination, medical
5 consultation, or other treatment, including, but not limited
6 to, any third party reimbursement for the same.

7 (2) Accept, solicit, or offer any form of
8 remuneration from or to a dispensary for the purpose of
9 referring a patient to a specific dispensary.

10 (3) Offer a discount of any other item of value to a
11 qualified patient who uses or agrees to designate a specific
12 caregiver or use a specific dispensary to obtain medical
13 cannabis.

14 (4) Hold a direct or indirect economic interest in a
15 licensee.

16 (5) Serve on the board of directors or as an
17 employee of a licensee.

18 (6) Refer qualified patients to a specific caregiver
19 or a specific dispensary.

20 (7) Advertise in a dispensary.

21 (8) Advertise on the physician's website, brochures,
22 or any other media that generally describe the scope of
23 practice of the physician, any statement that refers to the
24 physician as a "medical cannabis" or "medical marijuana"
25 physician or doctor, or otherwise advertises his or her status
26 as a registered certifying physician, other than the
27 following: "Dr. _____ is qualified by the State of Alabama

1 to certify patients for medical cannabis use under the Alabama
2 Compassion Act."

3 §20-2A-33.

4 (a) In order to certify a patient, a registered
5 certifying physician must diagnose the patient with at least
6 one qualifying medical condition or confirm that the patient
7 has been medically diagnosed with at least one qualifying
8 medical condition.

9 (b) Not later than December 1, 2020, the board shall
10 adopt rules for the issuance of physician certifications for
11 patients to use medical cannabis as recommended by a
12 registered certifying physician. The rules shall include, but
13 not be limited to, all of the following:

14 (1) Requirements for patient examination and the
15 establishment of a physician-patient relationship.

16 (2) Requirements for relevant information to be
17 included in the patient's medical record.

18 (3) Requirements for review of the patient's
19 controlled drug prescription history in the controlled
20 substance prescription database established under Article 10
21 of Chapter 2 of this title.

22 (4) Requirements for review of the patient registry.

23 (5) Requirements for obtaining the voluntary and
24 informed written consent from the patient to use medical
25 cannabis, or from the patient's designated caregiver to assist
26 the patient with the use of medical cannabis, on a form
27 created by the board and accessible at no charge on its

1 website. The form shall include, but not be limited to,
2 information relating to all of the following:

3 a. The federal and state classification of cannabis
4 as a Schedule I controlled substance.

5 b. The approval and oversight status of cannabis by
6 the Food and Drug Administration.

7 c. The current state of research on the efficacy of
8 cannabis to treat the qualifying medical condition or
9 conditions.

10 d. The potential for addiction.

11 e. The potential effect that cannabis may have on a
12 patient's coordination, motor skills, and cognition, including
13 a warning against operating heavy machinery, operating a motor
14 vehicle, or engaging in activities that require an individual
15 to be alert or respond quickly.

16 f. The potential side effects of cannabis use.

17 g. The risks, benefits, and drug interactions of
18 cannabis.

19 h. A statement that the use of medical cannabis
20 could result in termination from employment without recourse
21 and that costs may not be covered by insurance or government
22 programs.

23 i. That the patient's de-identified health
24 information contained in the patient's medical record,
25 physician certification, and patient registry may be used for
26 research purposes or used to monitor compliance with this

1 chapter, as further provided in subsection (c) of Section 20-2A-34.

2 (6) Requirements for the issuance and reissuance of
3 physician certifications by certifying physicians, the
4 permissible length of duration of a physician certification,
5 and the process and circumstances under which a physician
6 certification may be deactivated, as well as stipulations for
7 timely updating of physician certifications on the patient
8 registry.

9 (c) A registered certifying physician who is
10 treating a patient for a medical condition other than a
11 qualifying medical condition may petition the Medical Cannabis
12 Appeal Panel for approval of physician certification by
13 submitting a petition to the panel, on a form established by
14 the board in consultation with the commission, that includes,
15 but is not limited to, relevant treatment history and other
16 information to assist the Medical Cannabis Appeal Panel in
17 determining whether to grant approval of physician
18 certification, as further provided in Section 20-2A-23. If
19 approved by the panel, the petitioning registered certifying
20 physician may issue a physician certification.

21 (d) At the time of physician certification, the
22 registered certifying physician shall enter electronically in
23 the patient registry, in a manner determined by rule by the
24 board, relevant information necessary to appropriately
25 identify the patient; the respective qualifying medical
26 condition or conditions of the patient; the daily dosage and

1 type of medical cannabis recommended for medical use; and any
2 other information the board, by rule, deems relevant.

3 (e) A physician certification does not constitute a
4 prescription for medical cannabis.

5 (f) A physician certification shall be valid for a
6 period of time as determined by the board, but in no event may
7 a physician certification exceed 12 months in duration.

8 (g) The commission, by rule, shall specify, by form
9 and tetrahydrocannabinol content, a maximum daily dosage of
10 medical cannabis that may be recommended by a registered
11 certifying physician for a particular qualifying medical
12 condition; provided, however, the maximum daily dosage may not
13 exceed 75 mg of delta-9-tetrahydrocannabinol.

14 (h) A registered certifying physician may not
15 lawfully recommend the use of medical cannabis with a potency
16 greater than three percent tetrahydrocannabinol to any minor
17 for any qualifying medical condition. A minor may not legally
18 use medical cannabis with a potency greater than three percent
19 tetrahydrocannabinol, whether or not the minor has a valid
20 medical cannabis card. A parent or legal guardian of a minor
21 who holds a medical cannabis card may not legally possess
22 medical cannabis with a potency greater than three percent
23 tetrahydrocannabinol, unless the parent or guardian holds a
24 valid medical cannabis card for his or her own qualifying
25 medical condition.

26 §20-2A-34.

1 (a) In order to commence, use, and maintain a
2 reliable system to track all aspects of patient and caregiver
3 qualification not later than September 1, 2021, the commission
4 shall do all of the following:

5 (1) Establish and administer an integrated,
6 electronic patient and caregiver registry, known as the
7 Alabama Medical Cannabis Patient Registry System, that does
8 all of the following:

9 a. Receives and records physician certifications.

10 b. Receives and tracks qualified patient
11 registration and issuance of medical cannabis cards.

12 c. Receives and tracks designated caregiver
13 registration and issuance of medical cannabis cards.

14 d. Includes in the patient registry database for
15 each qualified patient registrant the name of the qualified
16 patient and the patient's designated caregiver, if applicable,
17 the patient's registered certifying physician, the respective
18 qualifying medical condition or conditions, the recommended
19 daily dosage and type of medical cannabis, and any other
20 information the commission, by rule, deems relevant.

21 e. Verifies that a medical cannabis card is current
22 and valid and has not been suspended, revoked, or denied.

23 f. Tracks purchases of medical cannabis at
24 dispensaries by date, time, amount, and type.

25 g. Determines whether a particular sale of medical
26 cannabis transaction exceeds the permissible limit.

1 h. Tracks medical cannabis cards that are denied,
2 revoked, or suspended.

3 i. Interfaces as necessary with the statewide
4 seed-to-sale tracking system established under Article 4.

5 j. Provides access as further provided in subsection
6 (b).

7 (b) The patient registry shall be accessible to the
8 following:

9 (1) State and local law enforcement agencies,
10 provided the database may only be accessed upon probable cause
11 or reasonable suspicion of a violation of a controlled
12 substance law or of driving under the influence, and access is
13 strictly limited to information that is necessary to verify
14 that an individual is registered and possesses a valid and
15 current medical cannabis card and, if appropriate, to verify
16 that the amount and type of product in the individual's
17 possession complies with the daily dosage limit and type of
18 medical cannabis recommended.

19 (2) Health care practitioners licensed to prescribe
20 prescription drugs.

21 (3) Registered certifying physicians.

22 (4) Dispensaries.

23 (5) The State Board of Medical Examiners.

24 (c) The commission may monitor patient registrations
25 in the patient registry for practices that could facilitate
26 unlawful diversion or misuse of cannabis and shall recommend
27 disciplinary action to the board as appropriate.

1 §20-2A-35.

2 (a) Once certified, a patient and, if applicable,
3 the patient's designated caregiver, shall register in the
4 patient registry. The commission shall develop the application
5 and renewal process for patient and designated caregiver
6 registration, that shall include, but not be limited to, an
7 application form, relevant information that must be included
8 on the form, any additional requirements for eligibility the
9 commission deems necessary, and an application fee not to
10 exceed sixty-five dollars (\$65).

11 (b) If the certified patient or designated caregiver
12 meets the criteria for registration, the commission shall
13 place the patient or caregiver on the patient registry and
14 issue the patient or designated caregiver a medical cannabis
15 card. The commission shall determine the criteria for revoking
16 or suspending a medical cannabis card. Medical cannabis cards
17 shall be resistant to counterfeiting and tampering and, at a
18 minimum, shall include all of the following:

19 (1) The name, address, and date of birth of the
20 qualified patient or caregiver, as applicable.

21 (2) A photograph of the qualified patient or
22 caregiver, as applicable.

23 (3) Identification of the cardholder as a qualified
24 patient or a caregiver.

25 (4) The expiration date, as determined by commission
26 rule.

1 (5) The following statement: "This card is only
2 valid in the State of Alabama".

3 (c) Once a patient or designated caregiver is
4 registered and issued a medical cannabis card, he or she is
5 qualified to acquire, possess, or use medical cannabis, as
6 applicable.

7 (d) If a registered qualified patient or registered
8 caregiver loses his or her medical cannabis card, he or she
9 shall notify the commission within 10 days of becoming aware
10 the card is lost or stolen. The commission, by rule, shall
11 determine the process and fee for replacing a lost or stolen
12 card, including a process for invalidating the lost or stolen
13 card.

14 (e) The commission shall adopt rules to implement
15 this section and may impose civil penalties for violations of
16 this section.

17 §20-2A-36.

18 (a) A nonresident patient or caregiver who holds a
19 valid medical cannabis or medical marijuana card issued in
20 another state may register on a temporary basis in the patient
21 registry and be issued a temporary medical cannabis card that
22 permits the temporary cardholder to access dispensaries in
23 this state, as further provided in this section and pursuant
24 to commission rules; provided, however, the commission may
25 only register the nonresident patient or caregiver on a
26 temporary basis and issue a temporary card if the commission
27 can determine that a medical cannabis product comparable to

1 the type of product the patient or caregiver is permitted to
2 use in his or her home state is available and can be dispensed
3 in this state.

4 (b) A nonresident patient or caregiver shall
5 complete an application, which shall be in a form
6 substantially similar to the application required under
7 Section 20-2A-35, along with proof, as determined by
8 commission rule, that the applicant has lawful permission in
9 his or her home state to purchase a medical cannabis or
10 medical marijuana product that is comparable to a type of
11 medical cannabis product dispensed in this state. An applicant
12 shall pay a processing fee to cover the costs incurred by the
13 commission to administer this section as determined by
14 commission rule.

15 (c) A temporary medical cannabis card shall be in a
16 form substantially similar to medical cannabis cards issued
17 under Section 20-2A-35.

18 (d) A temporary medical cannabis card is valid for a
19 period determined by the commission by rule, but in no event
20 more than 60 days. A temporary medical cannabis card may not
21 be renewed.

22 (e) If requested by the regulatory agency of the
23 nonresident's home state which issued the nonresident a valid
24 medical cannabis or medical marijuana card, the commission
25 shall notify that regulatory agency of the nonresident's
26 purchase of medical cannabis pursuant to this section.

1 (f) To the extent practicable, the commission shall
2 coordinate with any other state that has a medical cannabis or
3 medical marijuana program and may request notification by the
4 regulatory agency of that other state when an Alabama resident
5 with a medical cannabis card purchases medical cannabis
6 through the reciprocal medical cannabis or medical marijuana
7 program in that state. Notification shall include the dosage
8 or amount and type of product the cardholder purchases.

9 Article 4. Cultivation, Processing, and Dispensing
10 of Medical Cannabis.

11 §20-2A-50.

12 (a) The state hereby preemptively regulates medical
13 cannabis from seed to sale and shall reasonably regulate and
14 control all aspects of the medical cannabis industry to meet
15 the intent of this chapter. All functions and activities
16 relating to the production of medical cannabis in the state
17 shall be licensed, and licenses shall be granted to integrated
18 facilities, as well as to independent entities in the
19 following categories: Cultivator, processor, dispensary,
20 secure transporter, and testing laboratory.

21 (b) The commission shall license and regulate all
22 aspects of medical cannabis under this article, excluding
23 cultivation. The Department of Agriculture and Industries
24 shall license and regulate the cultivation of cannabis. For
25 integrated facility licenses, the commission and the
26 department shall enter into a memorandum of understanding
27 relating to the sharing of regulatory and licensing and

1 enforcement authority over licensees with regard to the
2 cultivation function.

3 §20-2A-51.

4 (a) Where the commission is authorized under this
5 article to determine the number of licenses of a specific
6 license category the commission will grant, or increase the
7 number of licenses of a specific license category to grant,
8 the commission shall consider the population of the state, the
9 number of active registered qualified patients, market demand,
10 the unemployment rate, the need for agricultural and other
11 business opportunities in communities, access to health care,
12 infrastructure, and other factors the commission deems
13 relevant in providing the greatest benefits to the residents
14 of this state and taking into account the racial and economic
15 makeup of the state.

16 (b) The commission, and where applicable the
17 department, shall ensure that at least one-fourth of all
18 licenses, or in the case of Section 20-2A-67, one-fifth of all
19 licenses, are awarded to business entities at least 51 percent
20 of which are owned by members of a minority group or, in the
21 case of a corporation, at least 51 percent of the shares of
22 the corporation are owned by members of a minority group, and
23 are managed and controlled by members of a minority group in
24 its daily operations. For purposes of this subsection,
25 minority group means individuals of African American, Native
26 American, Asian, or Hispanic descent.

27 §20-2A-52.

1 (a) The commission, and the department with regard
2 to cultivation facilities, shall have all powers necessary and
3 proper to fully and effectively oversee the operation of
4 medical cannabis facilities licensed pursuant to this article,
5 including the authority to do all of the following:

6 (1) Investigate applicants for licenses, determine
7 the eligibility for licenses, and grant licenses to applicants
8 in accordance with this article and the rules.

9 (2) Investigate all individuals employed by
10 licensees.

11 (3) At any time, through its investigators, agents,
12 or auditors, without a warrant and without notice to the
13 licensee, enter the premises, offices, facilities, or other
14 places of business of a licensee, if evidence of compliance or
15 noncompliance with this article or rules is likely to be found
16 and consistent with constitutional limitations, for the
17 following purposes:

18 a. To inspect and examine all premises of licensees.

19 b. To inspect and examine relevant records of the
20 licensee and, if the licensee fails to cooperate with an
21 investigation, impound, seize, assume physical control of, or
22 summarily remove from the premises all books, ledgers,
23 documents, writings, photocopies, correspondence, records, and
24 videotapes, including electronically stored records, money
25 receptacles, or equipment in which the records are stored.

26 c. To inspect the person, and inspect or examine
27 personal effects present in a licensee, of any holder of a

1 state operating license while that individual is present in a
2 licensee.

3 d. To investigate alleged violations of this
4 article.

5 (4) Investigate alleged violations of this article
6 or rules and take appropriate disciplinary action against a
7 licensee.

8 (5) Require all relevant records of licensees,
9 including financial or other statements, to be kept on the
10 premises authorized for operation of the licensee or in the
11 manner prescribed by the commission.

12 (6) Eject, or exclude or authorize the ejection or
13 exclusion of, an individual from the premises of a licensee if
14 the individual violates this article, rules, or final orders
15 of the commission; provided, however, the propriety of the
16 ejection or exclusion is subject to a subsequent hearing by
17 the commission.

18 (7) Conduct periodic audits of licensees.

19 (8) Take disciplinary action as the commission
20 considers appropriate to prevent practices that violate this
21 article and rules.

22 (9) Take any other reasonable or appropriate action
23 to enforce this article and rules.

24 (b) The commission and department shall adopt rules

1 (c) The commission and department may seek and shall
2 receive the cooperation and assistance of the Alabama State
3 Law Enforcement Agency in conducting criminal background
4 checks and in fulfilling its responsibilities under this
5 article. The Alabama State Law Enforcement Agency may recover
6 its costs of cooperation under this article.

7 (d) The commission and department shall assist any
8 prosecuting agency in the investigation or prosecution of a
9 violation of a controlled substances law.

10 (e) Nothing in this article shall affect the
11 authority of the Alabama Department of Environmental
12 Management to administer and enforce any existing law over
13 which the Alabama Department of Environmental Management has
14 jurisdiction.

15 §20-2A-53.

16 (a) The commission, and the department with regard
17 to cultivation, shall adopt rules as necessary to implement,
18 administer, and enforce this article in a timely manner that
19 allows persons to begin applying for a license by September 1,
20 2021. Rules must ensure safety, security, and integrity of the
21 operation of medical cannabis facilities, that do all of the
22 following for each category of license:

23 (1) Establish operating standards to ensure the
24 health, safety, and security of the public and the integrity
25 of medical cannabis facility operations.

26 (2) Require a minimum of two million dollars
27 (\$2,000,000) of liability and casualty insurance and establish

1 minimum levels of other financial guarantees, if appropriate,
2 that licensees must maintain.

3 (3) Establish qualifications and restrictions for

13 facilities of licensees remain securely enclosed and locked as

16 standards, procedures, and requirements for medical cannabis
17 sold at dispensaries.

18 (7) Provide for the levy and collection of fines for
19 a violation of this article or rules.

20 (8) Establish annual license fees for each type of
21 license, provided the fee shall be not less than ten thousand
22 dollars (\$10,000) and not more than fifty thousand dollars
23 (\$50,000), depending on the category of license.

24 (9) Establish quality control standards, procedures,
25 and requirements.

26 (10) Establish chain of custody standards,
27 procedures, and requirements.

1 (11) In compliance with Chapters 27 and 30 of Title
2 22, establish standards, procedures, and requirements for
3 waste product storage and disposal and chemical storage.

4 (12) Establish standards, procedures, and
5 requirements for securely and safely transporting medical
6 cannabis between facilities.

7 (13) Establish standards, procedures, and
8 requirements for the storage of cannabis and medical
9 cannabis.

10 (14) Subject to Section 20-2A-63, establish
11 packaging and labeling standards, procedures, and requirements
12 for medical cannabis sold at dispensaries.

13 (15) Establish marketing and advertising
14 restrictions for medical cannabis products and medical
15 cannabis facilities.

16 (16) Establish standards and procedures for the
17 renewal, revocation, suspension, and nonrenewal of licenses.

18 (b) The commission, by rule, shall design a
19 universal state symbol that is a color image and made
20 available to licensed processors to include on all packages of
21 medical cannabis, as required under Section 20-2A-63.

22 §20-2A-54.

23 (a) In order to ensure that all medical cannabis
24 sold in the state maintains product quality to protect the
25 health and welfare of state residents, the commission shall
26 establish a statewide seed-to-sale tracking system for use as
27 an integrated cannabis and medical cannabis tracking,

1 inventory, and verification system. The system must allow for
2 interface with third-party inventory and tracking systems as
3 described in Section 20-2A-60 to provide for access by this
4 state, licensees, and law enforcement personnel, to the extent
5 that they need and are authorized to receive or submit the
6 information, to comply with, enforce, or administer this
7 chapter.

8 (b) At a minimum, the system must be capable of
9 storing and providing access to information that, in
10 conjunction with the patient registry and with one or more
11 third-party inventory control and tracking systems under
12 Section 20-2A-60, allows all of the following:

13 (1) Retention of a record of the date, time, amount,
14 and price of each sale or transfer of medical cannabis to a
15 registered qualified patient or registered caregiver.

16 (2) Effective seed-to-sale tracking of cannabis and
17 medical cannabis sales and transfers among licensees and with
18 regard to integrated facility licensees, among facilities of
19 the licensee.

20 (3) Receipt and integration of information from
21 third-party inventory control and tracking systems under
22 Section 20-2A-60.

23 (c) The commission shall seek bids to establish,
24 operate, and maintain the statewide seed-to-sale tracking
25 system under this section. The commission shall do all of the
26 following:

1 (1) Evaluate bidders based on the cost of the
2 service and the ability to meet all of the requirements of
3 this chapter.

4 (2) Give strong consideration to the bidder's
5 ability to prevent fraud, abuse, and other unlawful or
6 prohibited activities associated with the commercial trade in
7 cannabis and medical cannabis in this state, and the ability
8 to provide additional tools for the administration and
9 enforcement of this chapter.

10 (3) Institute procedures to ensure that the person
11 awarded the contract does not disclose or use the information
12 in the system for any use or purpose except for the
13 enforcement, oversight, and implementation of this chapter.

14 (4) Require the person awarded the contract to
15 deliver the functioning system by 180 days after award of the
16 contract.

17 (d) The commission may terminate a contract with the
18 person awarded the contract for a violation of this chapter.

19 (e) The information in the system is confidential
20 and is exempt from disclosure under the Open Records Act,
21 Article 3 of Chapter 12 of Title 36; provided, however,
22 information in the system may be disclosed for purposes of
23 enforcing this chapter.

24 §20-2A-55.

25 (a) Beginning September 1, 2021, a person may apply
26 to the commission for a license for an integrated facility or
27 for a license in one of the following independent categories:

1 Cultivator, processor, secure transporter, state testing
2 laboratory, or dispensary. The application shall be made under
3 oath on a form provided by the commission and shall contain
4 information as prescribed by the commission, including, but
5 not limited to, all of the following:

6 (1) The name, business address, business telephone
7 number, and Social Security number or if applicable, federal
8 tax identification number, of the applicant.

9 (2) The identity of every individual having any
10 ownership interest in the applicant with respect to which the
11 license is sought. If the disclosed entity is a trust, the
12 application shall disclose the names and addresses of all
13 trustees and beneficiaries; if a privately held corporation,
14 the names and addresses of all shareholders, officers, and
15 directors; if a publicly held corporation, the names and
16 addresses of all shareholders holding a direct or indirect
17 interest of greater than five percent, officers, and
18 directors; if a partnership or limited liability partnership,
19 the names and addresses of all partners; if a limited
20 partnership or limited liability limited partnership, the
21 names of all partners, both general and limited; or if a
22 limited liability company, the names and addresses of all
23 members and managers.

24 (3) An identification of any business that is
25 directly or indirectly involved in the cultivation,
26 processing, packaging, labeling, testing, transporting, or
27 sale of cannabis, including, if applicable, the state of

1 incorporation or registration, in which an applicant or, if
2 the applicant is an individual, the applicant's spouse,
3 parent, or child has any equity interest. If an applicant is a
4 corporation, partnership, or other business entity, the
5 applicant shall identify any other corporation, partnership,
6 or other business entity that is directly or indirectly
7 involved in the cultivation, processing, packaging, labeling,
8 testing, transporting, or sale of cannabis in which it has any
9 equity interest, including, if applicable, the state of
10 incorporation or registration. An applicant may comply with
11 this subdivision by filing a copy of the applicant's
12 registration with the Securities and Exchange Commission if
13 the registration contains the information required by this
14 subdivision.

15 (4) Whether an applicant has been indicted for,
16 charged with, arrested for, or convicted of, pled guilty or
17 nolo contendere to, forfeited bail concerning any criminal
18 offense under the laws of any jurisdiction, either felony or
19 controlled substance-related misdemeanor, not including
20 traffic violations, regardless of whether the offense has been
21 reversed on appeal or otherwise, including the date, the name
22 and location of the court, arresting agency, and prosecuting
23 agency, the case caption, the docket number, the offense, the
24 disposition, and the location and length of incarceration.

25 (5) Whether an applicant has ever applied for or has
26 been granted any commercial license or certificate issued by a
27 licensing board or commission in this state or any other

1 jurisdiction that has been denied, restricted, suspended,
2 revoked, or not renewed and a statement describing the facts
3 and circumstances concerning the application, denial,
4 restriction, suspension, revocation, or nonrenewal, including
5 the licensing board or commission, the date each action was
6 taken, and the reason for each action.

7 (6) Whether an applicant has filed, or been served
8 with, a complaint or other notice filed with any public body,
9 regarding the delinquency in the payment of, or a dispute over
10 the filings concerning the payment of, any tax required under
11 federal, state, or local law, including the amount, type of
12 tax, taxing agency, and time periods involved.

13 (7) A statement listing the names and titles of all
14 public officials of any unit of government, and the spouses,
15 parents, and children of those public officials, who, directly
16 or indirectly, own any financial interest in, have any
17 beneficial interest in, are the creditors of or hold any debt
18 instrument issued by, or hold or have any interest in any
19 contractual or service relationship with an applicant.

20 (9) The anticipated or actual number of employees;
21 and projected or actual gross receipts.

22 (10) Financial information in the manner and form
23 required by rule by the commission.

24 (b) An individual with a controlling interest in an
25 applicant shall be subject to a state and national criminal
26 background check. The commission shall determine the manner in
27 which fingerprints of the individual shall be submitted to the

1 Alabama State Law Enforcement Agency along with a sufficient
2 fee required to perform the criminal history records check by
3 the agency and by the Federal Bureau of Investigation. The
4 applicant shall submit with its application the individual's
5 written consent to the criminal history records check.

6 (c) A false application is cause for the commission
7 to deny a license. The commission shall not consider an
8 incomplete application but, within a reasonable time, shall
9 return the application to the applicant with notification of
10 the deficiency and instructions for submitting a corrected
11 application. Information the commission obtains from the
12 background investigation is exempt from disclosure under the
13 Open Records Act, Article 3 of Chapter 12 of Title 36.

14 (d) An applicant shall provide written consent to
15 the inspections, examinations, searches, and seizures provided
16 for in subdivision (a) (3) of Section 20-2A-52 and to
17 disclosure to the commission and its agents of otherwise
18 confidential records, including tax records held by any
19 federal, state, or local agency, or credit bureau or financial
20 institution, while applying for or holding a license.
21 Information the commission receives under this subsection is
22 exempt from disclosure under the Open Records Act.

23 (e) An applicant shall certify that the applicant
24 does not have an interest in any other license under this
25 article.

26 (f) A nonrefundable application fee of two thousand
27 five hundred dollars (\$2,500) shall be paid at the time of

1 filing to defray the costs associated with the background
2 investigation conducted by the commission. If the costs of the
3 investigation and processing the application exceed the
4 application fee, the applicant shall pay the additional amount
5 to the commission. All information, records, interviews,
6 reports, statements, memoranda, or other data supplied to or
7 used by the commission in the course of its review or
8 investigation of an application for a license under this
9 article shall be disclosed only in accordance with this
10 article. The information, records, interviews, reports,
11 statements, memoranda, or other data are not admissible as
12 evidence or discoverable in any action of any kind in any
13 court or before any department, agency, board, commission, or
14 authority, except for any action considered necessary by the
15 commission, unless so ordered by a court of competent
16 jurisdiction according to the Rules of Civil Procedure.

17 (g) If the commission identifies a deficiency in an
18 application, the commission shall provide the applicant with a
19 reasonable period of time, as determined by the commission by
20 rule but not more than 60 days, to correct the deficiency.

21 §20-2A-56.

22 (a) An applicant is ineligible to receive a license
23 if any of the following circumstances exist:

24 (1) The applicant has been convicted of or released
25 from incarceration for a felony under the laws of this state,
26 any other state, or the United States within the past 10 years
27 or has been convicted of a controlled substance-related felony

1 within the past 10 years; provided, however, the commission
2 shall not consider any conviction overturned on appeal or any
3 charge that has been expunged pursuant to Chapter 27 of Title
4 15.

5 (2) The applicant has knowingly submitted an
6 application for a license under this article that contains
7 false information.

8 (3) The applicant is a member of the commission.

9 (4) The applicant fails to demonstrate the
10 applicant's ability to maintain adequate minimum levels of
11 liability and casualty insurance or other financial guarantees
12 for its proposed facility.

13 (5) The applicant fails to meet other criteria
14 established by rule.

15 (b) In determining whether to grant a license to an
16 applicant, the commission may consider all of the following:

17 (1) The integrity, moral character, and reputation;
18 personal and business probity; financial ability and
19 experience; and responsibility or means to operate or maintain
20 a facility of the applicant and of any other individual that
21 meets either of the following:

22 a. Controls, directly or indirectly, the applicant.

23 b. Is controlled, directly or indirectly, by the
24 applicant or by a person who controls, directly or indirectly,
25 the applicant.

26 (2) The financial ability of the applicant to
27 maintain required financial guarantees.

1 (3) The sources and total amount of the applicant's
2 capitalization to operate and maintain the proposed facility.

3 (4) Whether the applicant has been indicted for,
4 charged with, arrested for, or convicted of, pled guilty or
5 nolo contendere to, forfeited bail concerning, or had expunged
6 any relevant criminal offense under the laws of any
7 jurisdiction, either felony or misdemeanor, not including
8 traffic violations, regardless of whether the offense has been
9 expunged, pardoned, or reversed on appeal or otherwise.

10 (5) Whether the applicant has filed, or had filed
11 against it, a proceeding for bankruptcy within the past seven
12 years.

13 (6) Whether the applicant has been served with a
14 complaint or other notice filed with any court or public
15 agency regarding payment of any tax required under federal,
16 state, or local law that has been delinquent for one or more
17 years.

18 (7) Whether the applicant has a history of
19 noncompliance with any regulatory requirements in this state
20 or any other jurisdiction.

21 (8) Whether at the time of application the applicant
22 is a defendant in litigation involving its business practices.

23 (9) The applicant's ability to capitalize and
24 conduct operations as proposed in its business plan, including
25 business experience in related fields.

1 (10) The applicant's history of business activities
2 as it applies to the specific license for which the applicant
3 is seeking licensure.

4 (11) The proposed location of all operations as
5 being suitable for all activities, not inconsistent with
6 applicable zoning, and the applicant's ability to serve an
7 identifiable geographic area.

8 (12) Whether the applicant meets other standards or
9 requirements established under this article or by rules
10 applicable to the license category.

11 (c) The commission shall review all applications for
12 licenses and shall determine whether to grant or deny a
13 license not more than 60 days after the date a license
14 application was submitted, or if an applicant was notified of
15 a deficiency under subsection (g) of Section 20-2A-55, the
16 commission shall grant or deny a license not more than 60 days
17 after the deficiency was corrected.

18 (d) After denial of a license, the commission, upon
19 request, shall provide a public investigative hearing at which
20 the applicant is given the opportunity to present testimony
21 and evidence to establish its suitability for a license. Other
22 testimony and evidence may be presented at the hearing, but

26 to provide information requested by the commission and to

4 (a) If any of the following occurs, the commission
5 may deny, suspend, revoke, or restrict a license:

6 (1) An applicant or licensee fails to comply with
7 this article or rules.

8 (2) A licensee no longer meets the eligibility
9 requirements for a license under this article.

10 (3) An applicant or licensee fails to provide
11 information the commission requests to assist in any
12 investigation, inquiry, or commission hearing.

13 (b) The commission may impose civil fines of up to
14 five thousand dollars (\$5,000) against an individual and up to
15 twenty-five thousand dollars (\$25,000) or an amount equal to
16 the daily gross receipts, whichever is greater, against a
17 licensee for each violation of this article, rules, or an
18 order of the commission. Assessment of a civil fine under this
19 subsection is not a bar to the investigation, arrest,
20 charging, or prosecution of an individual for any other
21 violation of this article and is not grounds to suppress
22 evidence in any criminal prosecution that arises under this
23 article or any other law of this state.

24 (c) The commission shall comply with the hearing
25 procedures of the Administrative Procedure Act when denying,
26 revoking, suspending, or restricting a license or imposing a
27 fine. The commission may suspend a license without notice or

1 hearing upon a determination that the safety or health of
2 patrons or employees is jeopardized by continuing a facility's
3 operation. If the commission suspends a license under this

11 license, and any interest in or rights under a license, and
12 any ownership interest or other beneficial interest in a
13 licensed entity, may not be sold, transferred, assigned,
14 conveyed, or otherwise disposed of in any manner, in whole or
15 in part, voluntarily or involuntarily, directly or indirectly,
16 except upon application to and approval of the commission.

17 (b) A nonrefundable application fee of two thousand
18 five hundred dollars (\$2,500) shall be paid to the commission
19 at the time of filing any transfer request under subsection
20 (a).

21 (c) The attempted transfer, sale, or other
22 conveyance of an interest or right in a license, or transfer
23 of an ownership interest or other beneficial interest in a
24 licensed entity, without the approval of the commission, shall
25 be grounds for suspension or revocation of the license or for
26 other sanction considered appropriate by the commission.

27 §20-2A-59.

1 (a) Before hiring a prospective employee, a licensee
2 shall conduct a background check of the prospective employee.
3 If the background check indicates a pending charge or
4 conviction within the past five years for a controlled
5 substance-related felony or a controlled substance-related
6 misdemeanor, a licensee may not hire the prospective employee
7 without written permission of the commission; provided,
8 however, a licensee shall not consider any conviction
9 overturned on appeal or any charge that has been expunged
10 pursuant to Chapter 27 of Title 15.

11 (b) Each licensee shall enter all transactions,
12 current inventory, and other information into the statewide
13 seed-to-sale tracking system in accordance with rules adopted
14 by the commission and the Department of Agriculture and

17 (a) Except as otherwise provided in subsection (b),
18 a licensee shall adopt and use a third-party inventory control
19 and tracking system that is capable of interfacing with the
20 statewide seed-to-sale tracking system to allow the licensee
21 to enter or access information in the statewide seed-to-sale
22 tracking system as required under this article and rules. The
23 third-party inventory control and tracking system must have
24 all of the following capabilities necessary for the licensee

16 b. Product inventory that is finished and available
17 for sale.

18 c. Product that is in the process of transfer.

19 d. Product being processed into another form.

20 e. Postharvest raw product, such as product that is
21 in the drying, trimming, or curing process.

22 (7) Reporting and tracking loss, theft, or diversion
23 of product containing cannabis.

24 (8) Reporting and tracking all inventory
25 discrepancies.

26 (9) Reporting and tracking adverse patient responses
27 or dose-related efficacy issues.

1 (10) Reporting and tracking all sales and refunds.

2 (11) Receiving testing results electronically from a
3 state testing laboratory via a secured application program
4 interface into the system and directly linking the testing
5 results to each applicable source batch and sample.

6 (12) Identifying test results that may have been
7 altered.

8 (13) Providing the licensee with access to
9 information in the tracking system that is necessary to verify
10 that the licensee is carrying out all transactions authorized
11 under the licensee's license in accordance with this article.

12 (14) Providing information to cross-check that
13 product sales are made to a registered qualified patient, or a
14 registered caregiver on behalf of a registered qualified
15 patient, and that the product received the required testing.

16 (15) Providing the commission and state agencies
17 with access to information in the database that they are
18 authorized to access.

19 (16) Providing licensees with access only to the
20 information in the system that they are required to receive
21 before a sale, transfer, transport, or other activity
22 authorized under a license issued under this article.

23 (17) Securing the confidentiality of information in
24 the database by preventing access by a person who is not
25 authorized to access the statewide seed-to-sale tracking
26 system or is not authorized to access the particular
27 information.

1 (18) Providing analytics to the commission regarding
2 key performance indicators such as the following:

- 3 a. Total daily sales.
- 4 b. Total cannabis plants in production.
- 5 c. Total cannabis plants destroyed.
- 6 d. Total inventory adjustments.

7 (b) If the statewide seed-to-sale tracking system is
8 capable of allowing a licensee to access or enter information
9 into the statewide seed-to-sale tracking system without use of
10 a third-party inventory control and tracking system, a
11 licensee may access or enter information into the statewide
12 seed-to-sale tracking system directly and the licensee is not
13 required to adopt and use a third-party inventory control and
14 tracking system.

15 §20-2A-61.

16 (a) (1) With regard to any physical structure or
17 vehicle owned, leased, or otherwise used by a licensee, the
18 licensee may not do either of the following:

- 19 a. Advertise medical cannabis brand names or use
20 graphics related to cannabis or paraphernalia on the exterior
21 of the physical structure or vehicle.
- 22 b. Display medical cannabis products or
23 paraphernalia so as to be clearly visible from the exterior of
24 the physical structure or vehicle.

25 (2) Restrictions in this subsection shall apply to
26 any item located on real property on which a licensee's

1 (b) Advertising for medical cannabis may not contain

9 (a) (1) A cultivator license authorizes all of the
10 following:

11 a. The cultivation of cannabis.

12 b. The sale or transfer of cannabis to a processor.

13 c. If the cultivator contracts with a processor to
14 process its cannabis into medical cannabis on the cultivator's
15 behalf, the sale or transfer of medical cannabis to a
16 dispensary.

17 (2) A cultivator license authorizes the cultivator
18 to transfer cannabis only by means of a secure transporter.

19 (b) The commission shall consult with the Department
20 of Agriculture and Industries when determining the number of
21 cultivator licenses to issue, provided the commission shall
22 issue at least four cultivator licenses.

23 (c) An applicant for a license under this section
24 shall meet the following requirements:

25 (1) Provide records indicating continuous, full-time
26 business experience in the field of commercial horticulture or
27 agronomic production for a period of at least 15 years.

1 (2) Provide records indicating that majority
2 ownership is attributable to an individual or individuals with
3 proof of residency in this state for a continuous period of no
4 less than eight years preceding the application date.

5 (3) Demonstrate the ability to secure and maintain
6 cultivation facilities.

7 (4) Demonstrate the ability to obtain and use an
8 inventory control and tracking system as required under
9 Section 20-2A-60.

10 (5) Demonstrate the ability to commence cultivation
11 of cannabis within 60 days of application approval
12 notification.

13 (6) Demonstrate the ability to destroy unused or
14 waste cannabis in accordance with rules adopted by the
15 Department of Agriculture and Industries.

16 (7) Demonstrate the financial stability to provide
17 proper testing of individual lot and batches.

18 (d) A licensed cultivator shall comply with all of
19 the following, in accordance with rules adopted by the
20 Department of Agriculture and Industries:

21 (1) All facilities shall be protected by a monitored
22 security alarm system, be enclosed, and remain locked at all
23 times.

24 (2) All individuals entering and exiting facilities
25 shall be monitored by video surveillance and keypad or access
26 card entry.

1 (3) All employees may not have any conviction within
2 the past 10 years for a controlled substance-related felony or
3 a controlled substance-related misdemeanor other than a
4 conviction that was overturned on appeal or a charge that was
5 expunged pursuant to Chapter 27 of Title 15.

6 (4) Cultivars selected by a licensee must be
7 approved by the department prior to acquisition of plant
8 material for cultivation.

9 (e) A cultivator shall be subject to inspection by
10 the Department of Agriculture and Industries.

11 (f) The cultivation of cannabis pursuant to this
12 chapter shall be considered an agricultural purpose for
13 purposes of Section 40-23-4.

14 (g) Nothing in this section shall be construed to
15 prohibit the hydroponic growing of cannabis.

16 (h) The Department of Agriculture and Industries
17 shall consult with the commission when adopting rules pursuant
18 to this article.

19 §20-2A-63.

20 (a) (1) A processor license authorizes all of the
21 following:

22 a. The purchase or transfer of cannabis from a
23 cultivator.

24 b. The processing of cannabis into medical cannabis
25 which shall include properly packaging and labeling medical
26 cannabis products, in accordance with this section.

1 c. The sale or transfer of medical cannabis to a
2 dispensary.

3 (2) A processor license authorizes the processor to
4 transfer medical cannabis only by means of a secure
5 transporter.

6 (b) The commission shall issue no more than four
7 processor licenses.

8 (c) All medical cannabis products must be medical
9 grade product, manufactured using documented good quality
10 practices, such that the product is shown to meet intended
11 levels of purity and be reliably free of toxins and
12 contaminants. Medical cannabis products may not contain any
13 additives other than pharmaceutical grade excipients.

14 (d) Medical cannabis products may not be processed
15 into a form that is attractive to or targets children,
16 including all of the following which are prohibited:

17 (1) Any product bearing any resemblance to a cartoon
18 character, fictional character whose target audience is
19 children or youth, or pop culture figure.

20 (2) Any product bearing a reasonable resemblance to
21 a product available for consumption as a commercially
22 available candy.

23 (3) Any product whose design resembles, by any
24 means, another object commonly recognized as appealing to, or
25 intended for use by, children.

26 (4) Any product whose shape bears the likeness or
27 contains characteristics of a realistic or fictional human,

1 animal, or fruit, including artistic, caricature, or cartoon
2 rendering.

3 (e) All of the following shall apply to all packages
4 and labels of medical cannabis products:

5 (1) Labels, packages, and containers shall not be
6 attractive to minors and may not contain any content that
7 reasonably appears to target children, including toys, cartoon
8 characters, and similar images. Packages should be designed to
9 minimize appeal to children and must contain a label that
10 reads: "Keep out of reach of children."

11 (2) All medical cannabis products must be packaged
12 in child-resistant containers.

13 (3) All medical cannabis product labels shall
14 contain, at a minimum, the following information:

15 a. Lot and batch numbers.

16 b. A license identification number for the
17 cultivator and a license identification number for the
18 processor.

19 c. Cannabinoids content and potency.

20 d. The universal state symbol printed in color at
21 least one-half inch by one-half inch in size.

22 e. The following statement: "WARNING: There is
23 insufficient evidence showing it is safe to ingest medical
24 cannabis while pregnant or while breastfeeding. Women who are
25 pregnant or plan to become pregnant should discuss medical
26 cannabis use with their doctors."

1 (f) Any advertisement and any package or label may
2 not contain any false statement or statement that advertises
3 health benefits or therapeutic benefits of medical cannabis.

4 (g) The commission may require the implementation of
5 a digital image such as a QR Code for purposes of tracking
6 medical cannabis products. The digital image must interface
7 with the statewide seed-to-sale tracking system.

8 (h) The commission shall determine what information
9 from the label shall be entered into the statewide
10 seed-to-sale tracking system.

11 §20-2A-64.

12 (a) (1) A dispensary license authorizes all of the
13 following:

14 a. The purchase or transfer of medical cannabis from
15 a processor.

16 b. If a cultivator contracted with a processor to
17 process its cannabis into medical cannabis on the cultivator's
18 behalf, the purchase or transfer of medical cannabis from the
19 cultivator.

20 c. The purchase or transfer of medical cannabis from
21 an integrated facility.

22 d. The dispensing and sale of medical cannabis only
23 to a registered qualified patient or registered caregiver.

24 (2) A dispensary license authorizes the dispensary
25 to transfer medical cannabis only by means of a secure
26 transporter, including transport between its dispensing sites.

1 (b) The commission shall issue no more than four
2 dispensary licenses.

3 (c) A dispensary license authorizes the dispensary
4 to transfer medical cannabis to or from a state testing
5 laboratory for testing by means of a secure transporter.

6 (d) A licensed dispensary shall comply with all of
7 the following:

8 (1) Each dispensing site must be located at least
9 one thousand feet from any school, day care, or child care
10 facility.

11 (2) Sell and dispense medical cannabis at a
12 dispensing site to a registered qualified patient or
13 registered caregiver only after it has been tested and bears
14 the label required for retail sale.

15 (3) Enter all transactions, current inventory, and
16 other information into the statewide seed-to-sale tracking
17 system as required in Section 20-2A-54.

18 (4) Only allow dispensing of medical cannabis by
19 certified dispensers, as provided in subsection (e).

20 (5) Not allow the use of medical cannabis product on
21 the premises.

22 (6) Only allow registered qualified patients and
23 registered caregivers on the premises.

24 (e) (1) As used in this subsection, certified
25 dispenser means an employee of a dispensary who dispenses
26 medical cannabis to a registered qualified patient or

1 registered caregiver and who has been trained and certified by
2 the commission.

3 (2) The commission shall establish and administer a
4 training program for dispensers that addresses proper
5 dispensing procedures, including the requirements of this
6 subsection, and other topics relating to public health and
7 safety and preventing abuse and diversion of medical cannabis.
8 The commission shall certify trained dispensers and may
9 require, as a qualification to remain certified, periodic
10 training.

11 (3) A certified dispensary shall comply with all of
12 the following:

13 a. Before dispensing medical cannabis, inquire of
14 the patient registry to confirm that the patient or caregiver
15 holds a valid, current, unexpired, and unrevoked medical
16 cannabis card and that the dispensing of medical cannabis
17 conforms to the type and amount recommended in the physician
18 certification and will not exceed the 60-day daily dosage
19 purchasing limit.

20 b. Enter into the patient registry the date, time,
21 amount, and type of medical cannabis dispensed.

22 c. Comply with any additional requirements
23 established by the commission by rule.

24 (4) The commission shall adopt rules to implement
25 this subsection.

26 (f) A licensee may operate up to three dispensing
27 sites, each of which must be located in a different county

1 from any other dispensing site; provided, however, the
2 commission may authorize a licensee to operate a greater
3 number of dispensing sites if, at least one year after the
4 date when the maximum number of total dispensing sites
5 authorized under this section and Section 20-2A-67 are
6 operating, the commission determines that the patient pool has
7 reached a sufficient level to justify an additional dispensing
8 site in an underserved or unserved area of the state.

9 §20-2A-65.

10 (a) An secure transporter license authorizes the
11 licensee to store and transport cannabis and medical cannabis
12 for a fee upon request of a licensee. A license does not
13 authorize transport to a registered qualified patient or
14 registered caregiver.

15 (b) A secure transporter shall comply with all of
16 the following:

17 (1) Each employee who has custody of cannabis or
18 medical cannabis shall not have been convicted of or released
19 from incarceration for a felony under the laws of this state,
20 any other state, or the United States within the past five
21 years or have been convicted of a misdemeanor involving a
22 controlled substance within the past five years.

23 (2) A route plan and manifest shall be entered into
24 the statewide seed-to-sale tracking system, and a copy must be
25 carried in the transporting vehicle and presented to a law
26 enforcement officer upon request.

1 (3) The cannabis or medical cannabis shall be
2 transported in one or more sealed containers and not be
3 accessible while in transit.

4 (4) A secure transporting vehicle may not bear
5 markings or other indication that it is carrying cannabis or
6 medical cannabis.

7 (c) A secure transporter is subject to
8 administrative inspection by a law enforcement officer at any
9 point during the transportation of cannabis or medical
10 cannabis to determine compliance with this article.

11 §20-2A-66.

12 (a) A state testing laboratory license authorizes
13 the licensee to possess and test cannabis and medical cannabis
14 products cultivated or processed at licensed facilities.

15 (b) The commission, by rule, shall establish
16 protocols for product testing by a licensed state testing
17 laboratory, which shall be conducted during cultivation,
18 processing, and dispensing to ensure that all dispensed
19 medical cannabis is consistently high grade and maintains a
20 consistency with less than 0.5 percent variability among
21 batches of the same product. The protocols for testing shall
22 include the following, as well as a determination of
23 corresponding tolerance limits:

24 (1) Cannabinoid content and potency, including, but
25 not limited to, all of the following:

26 a. Total THC (THC+THCA).

27 b. Total CBD (CBD+CBDA).

1 c. THC/CBD ratio, if applicable.

2 d. Percent of THC relative to original plant
3 material (w/w).

4 (2) Terpene profiles.

5 (3) Heavy metals.

6 (4) Chemical contamination, such as residual
7 solvents remaining after extraction and concentration.

8 (5) Microbials, including pathogenic microbials.

9 (6) Mycotoxins.

10 (7) Residual insecticides, fungicides, herbicides,
11 and growth regulators used during cultivation.

12 (8) Residual solvents.

13 (c) A state testing laboratory license authorizes
14 the licensee to do all of the following without using a secure
15 transporter:

16 (1) Take cannabis or medical cannabis from, test
17 cannabis or medical cannabis for, and return cannabis or
18 medical cannabis to only a respective licensed facility.

19 (2) Collect a random sample of cannabis or medical
20 cannabis at the premises of a cultivator, processor, or
21 dispensary for testing.

22 (d) The licensee shall be accredited and shown to
23 meet the requirements for a testing laboratory in
24 international standard ISO/IEC 17025, with the licensee's
25 scope of accreditation demonstrating testing capabilities in
26 the categories of cannabinoids, pesticides, toxins, metals,
27 and microbiological bacteria.

1 (e) To be eligible for a state testing laboratory
2 license, the applicant and each investor with any interest in
3 the applicant must not have an interest in any licensed
4 cultivator, secure transporter, processor, or dispensary.

5 (f) The licensee shall comply with all of the
6 following:

7 (1) Perform tests to certify that cannabis and
8 medical cannabis is reasonably free of heavy metals, chemical
9 contamination, residual pesticides and growth inhibitors, and
10 residual solvents.

11 (2) Use validated test methods to determine
12 delta-9-tetrahydrocannabinol, tetrahydrocannabinolic acid,
13 cannabidiol, and cannabidiolic acid levels.

14 (3) Perform tests that determine whether cannabis
15 and medical cannabis comply with the standards the commission
16 establishes for microbial and mycotoxin contents.

17 (4) Perform other tests necessary to determine
18 compliance with any other good manufacturing practices as
19 prescribed in rules.

20 (5) Have a secured laboratory space that cannot be
21 accessed by the general public.

22 (6) Retain and employ at least one staff member with
23 a relevant advanced degree in a medical or laboratory science.

24 §20-2A-67.

25 (a) An integrated facility license authorizes all of
26 the following:

27 (1) The cultivation of cannabis.

1 (2) The processing of cannabis into medical
2 cannabis, including proper packaging and labeling of medical
3 cannabis products.

4 (3) The dispensing and sale of medical cannabis only
5 to a registered qualified patient or registered caregiver.

6 (4) The transport of cannabis or medical cannabis
7 between its facilities.

8 (5) The sale or transfer of medical cannabis to a
9 dispensary.

10 (b) The commission may issue no more than five
11 integrated facility licenses. The licenses must be awarded to
12 entities whose majority ownership is attributable to an
13 individual or individuals with proof of residency in this
14 state for a continuous period of no less than eight years
15 preceding the application date and who provide records
16 indicating continuous, full-time business experience in the
17 field of commercial horticulture or agronomic production for a
18 period of at least eight years.

19 (c) An integrated facility licensee shall have the
20 same authorizations granted to, and shall comply with all
21 requirements for, cultivators, processors, secure
22 transporters, and dispensaries, in addition to any other
23 authorizations or requirements under this section or as
24 established by rule by the commission.

25 (d) A an applicant for an integrated facility
26 license shall provide all of the following:

1 (1) A letter of commitment or other acknowledgement,
2 as determined by commission rule, of the applicant's ability
3 to secure a performance bond issued by a surety insurance
4 company approved by the commission in the amount of two
5 million dollars (\$2,000,000).

6 (2) Proof of at least two hundred fifty thousand
7 dollars (\$250,000) in liquid assets.

8 (3) Proof that the applicant has the financial
9 ability to maintain operations for not less than two years
10 following the date of application.

11 (e) At the time a license is issued under this
12 section, the commission shall ensure that the licensee has
13 secured a performance bond as provided in subdivision (1) of
14 subsection (d).

15 (f) A licensee may operate up to five dispensing
16 sites, each of which must be located in a different county
17 from any other dispensing site that the licensee operates;
18 provided, however, the commission may authorize a licensee to
19 operate a greater number of dispensing sites if, at least one
20 year after the date when the maximum number of total
21 dispensing sites authorized under this section and Section
22 20-2A-64 are operating, the commission determines that the
23 patient pool has reached a sufficient level to justify an
24 additional dispensing site in an underserved or unserved area
25 of the state. This subsection shall not be construed to limit
26 wholesale distribution from integrated facility licensees to
27 dispensary licensees.

1 §20-2A-68.

2 A license issued under this article is a revocable
3 privilege granted by this state and is not a property right.
4 Granting a license does not create or vest any right, title,
5 franchise, or other property interest. A licensee or any other
6 person shall not lease, pledge, or borrow or loan money
7 against a license.

8 Section 2. (a) Commencing January 1, 2021, there is
9 levied, in addition to all other taxes of every kind now
10 imposed by law, and shall be collected and remitted in
11 accordance with Article 1, commencing with Section 40-23-1, of
12 Chapter 23 of Title 40, Code of Alabama 1975, a tax on the
13 gross proceeds of the sales of medical cannabis when sold at
14 retail in this state at the rate of nine percent of the gross
15 proceeds of the sales.

16 (b) (1) Commencing January 1, 2021, there is levied
17 an annual privilege tax on every person doing business under
18 Chapter 2A of Title 20, Code of Alabama 1975, in Alabama. The
19 tax shall accrue as of January 1 of every taxable year, or in
20 the case of a taxpayer licensed under Chapter 2A of Title 20,
21 Code of Alabama 1975, during the year, or doing business in
22 this state for the first time, as of the date the taxpayer is
23 licensed to do business under Chapter 2A of Title 20, Code of
24 Alabama 1975. The tax shall be levied upon the taxpayer's net
25 worth in Alabama for the taxable year. For purposes of this
26 subdivision, a taxpayer's net worth in Alabama shall be
27 determined by apportioning the taxpayer's net worth computed

1 under Section 40-14A-23, Code of Alabama 1975, in the same
2 manner as prescribed for apportioning income during the
3 determination period for purposes of the income tax levied by
4 Chapter 18 of Title 40, Code of Alabama 1975, or the manner in
5 which the income would be apportioned if the taxpayer were
6 subject to the income tax.

7 (2) The amount of tax due shall be computed in the
8 same manner and at the same rate of tax as prescribed in
9 Section 40-14A-22, Code of Alabama 1975, for purposes of
10 determining the annual privilege tax levied by Chapter 14A of
11 Title 40, Code of Alabama 1975.

12 (3) The annual return required by this subsection
13 shall be due no later than the corresponding federal income
14 tax return, as required to be filed under federal law. In the
15 case of a taxpayer's initial return, the annual return shall
16 be due no later than two and one-half months after the
17 taxpayer is licensed to do business, or commences business, in
18 Alabama.

19 (4) The Department of Revenue may grant a reasonable
20 extension of time for filing returns under rules adopted by
21 the Department of Revenue. No extension shall be for more than
22 six months.

23 (5) The annual medical cannabis privilege tax shall
24 be reported on forms and in the manner as prescribed by rule
25 by the Department of Revenue. The failure to receive a form
26 from the Department of Revenue shall not relieve a taxpayer
27 from liability for any tax, penalty, or interest otherwise

1 due. The tax due, as reported, shall constitute an admitted
2 liability for that amount. The Department of Revenue may
3 compute and assess additional tax, penalty, and interest
4 against a taxpayer as provided in Chapter 2A of Title 40, Code
5 of Alabama 1975.

6 (c) The Department of Revenue shall adopt rules to
7 implement this section.

8 Section 3. An employee who is injured or killed
9 under circumstances that might otherwise make the employee or
10 the employee's dependents eligible to receive worker's
11 compensation benefits under Chapter 5 of Title 25, Code of
12 Alabama 1975, is, along with the employee's dependents,
13 ineligible to receive compensation as defined in Section
14 25-5-1, Code of Alabama 1975, if the injury or death occurred
15 due to the employee's impairment by medical cannabis, which
16 shall be conclusively presumed in the event of a positive drug
17 test conducted and evaluated pursuant to standards adopted for
18 drug testing by the U.S. Department of Transportation in 49
19 C.F.R. Part 40, as provided under Section 25-5-51, Code of
20 Alabama 1975, or if the employee refuses to submit to or
21 cooperate with a blood or urine test, as provided by that
22 section.

23 Section 4. (a) As used in this section, cannabis,
24 medical cannabis, and use of medical cannabis shall have the
25 same meanings as defined in Section 20-2A-3.

26 (b) There is established the Consortium for Medical
27 Cannabis Research for the purpose of awarding grants to

1 entities for research relating to cannabis and medical
2 cannabis. The initial member institutions shall consist of
3 public and private four-year colleges and universities within
4 the state designated not later than January 1, 2021, by the
5 Alabama Commission on Higher Education. Membership in the
6 consortium may be increased or decreased by rules established
7 by the board of directors of the consortium.

8 (c) The management of the consortium shall be vested
9 in a board of directors, composed of the presidents of each
10 member institution. The board of directors shall determine the
11 overall program and general policies of the consortium in
12 conformance with the purposes set forth in subsection (d). The
13 board may elect or appoint officers as it deems desirable, who
14 may or may not be members of the board, to have
15 responsibilities and to exercise authority as the board may
16 prescribe.

17 (d) The purposes of the consortium are as follows:

18 (1) Award grants to public or private entities to
19 conduct rigorous research relating to cannabis, the cannabis
20 industry, medical cannabis, and the use of medical cannabis
21 and its impact.

22 (2) Monitor research conducted pursuant to grant
23 awards and require accountability by entities awarded grants.

24 (3) Encourage dialog among interested entities.

25 (4) Effectively disseminate research findings and
26 outcomes.

1 (e) By February 15 of each year, the board of
2 directors shall issue a report to the Governor, the President
3 Pro Tempore of the Senate, and the Speaker of the House of
4 Representatives on research projects, research findings,
5 community outreach initiatives, and future plans for the
6 consortium.

7 (f) There is created a special account in the State
8 Treasury to be known as the Medical Cannabis Research Fund.
9 Expenditures from the Medical Cannabis Research Fund shall be
10 made to fund grants awarded by the consortium in accordance
11 with this section and to otherwise implement and administer
12 this section.

13 Section 5. Section 13A-7-2, Code of Alabama 1975, is
14 amended to read as follows:

15 "§13A-7-2.

16 "(a) A person is guilty of criminal trespass in the
17 first degree if he knowingly enters or remains unlawfully in a
18 dwelling or on the premises of any cultivator or processor, as
19 those terms are defined in Section 20-2A-3, or on the premises
20 of any cultivation or processing operation that is part of an
21 integrated facility, as defined in Section 20-2A-3.

22 "(b) Criminal trespass in the first degree is a
23 Class A misdemeanor."

24 Section 6. Although this bill would have as its
25 purpose or effect the requirement of a new or increased
26 expenditure of local funds, the bill is excluded from further
27 requirements and application under Amendment 621, now

1 appearing as Section 111.05 of the Official ReCompilation of
2 the Constitution of Alabama of 1901, as amended, because the
3 bill defines a new crime or amends the definition of an
4 existing crime.

5 Section 7. This act shall become effective
6 immediately following its passage and approval by the
7 Governor, or its otherwise becoming law.
