3 "(e) (1) An offender released pursuant to this
4 section shall be subject to electronic monitoring for a period
5 of time determined by the director.

6 "(2) The board shall be responsible for the costs of
7 the electronic monitoring as required by this subsection.

12 "(a) The Board of Pardons and Paroles, in releasing
13 ~~a prisoner~~ an inmate on parole, shall specify in writing the
14 conditions of his or her parole and shall provide a copy of
15 the conditions ~~shall be given~~ to the parolee. A parolee who
16 violates the conditions of parole may be subject to arrest and
17 reimprisonment.

18 "(b) The Board of Pardons and Paroles shall adopt
19 general rules regarding the conditions of parole and their
20 violation and may make special rules to govern particular
21 cases. The rules, both general and special, shall include, but
22 are not limited to, all of the following:

23 "(1) The parolee ~~shall~~ may not leave the state
24 without the consent of the board.

25 "(2) The parolee shall contribute to the support of
26 his or her dependents to the best of his or her ability.

1 "(3) The parolee shall make reparation or
2 restitution for his or her crime.

3 "(4) The parolee shall avoid persons or places of
4 disreputable or harmful character.

5 "(5) The parolee shall follow the instructions of
6 his or her parole officer and ~~comport himself or herself as~~
7 ~~the officer shall determine~~ shall cooperate with the parole
8 officer.

9 "(6)a. The parolee shall be subject to electronic
10 monitoring for a period of time determined by the director.

11 "b. The board shall be responsible for the costs of
12 the electronic monitoring as required by this subdivision.

13 "~~(6)~~ (7) The parolee shall submit to behavioral
14 treatment, substance abuse treatment, GPS monitoring, or any
15 other treatment as deemed necessary by the board or the
16 supervising parole officer.

17 "~~(7)~~ (8) The parolee may not buy, own, or possess a
18 firearm in violation of federal law or in violation of Section
19 13A-11-72."
