8 SYNOPSIS: This bill makes a supplemental appropriation
9 from the unanticipated and unappropriated beginning
10 balance in the State General Fund for the fiscal
11 year ending September 30, 2022 to the Department of
12 Corrections - Correctional Capital Improvement Fund
13 in the amount of \$135,000,000; and makes a
14 supplemental appropriation from the unanticipated
15 and unappropriated beginning balance in the State
16 General Fund for the fiscal year ending September
17 30, 2022 to the Alabama Bureau of Pardons and
18 Paroles for the acquisition and renovation of the
19 existing prison facility in Perry County in the
20 amount of \$19,000,000.

26 To make a supplemental appropriation from the
27 unanticipated and unappropriated beginning balance in the

1 State General Fund for the fiscal year ending September 30,
2 2022 to the Department of Corrections - Correctional Capital
3 Improvement Fund in the amount of \$135,000,000; and to make a
4 supplemental appropriation from the unanticipated and
5 unappropriated beginning balance in the State General Fund for
6 the fiscal year ending September 30, 2022, to the Alabama
7 Bureau of Pardons and Paroles for the purchase and renovation
8 of the Perry County Correctional Facility in the amount of
9 \$19,000,000.

10 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

11 Section 1. In addition to all other appropriations
12 heretofore or hereafter made, there is hereby appropriated
13 \$135,000,000 from the unanticipated and unappropriated
14 beginning balance in the State General Fund for the fiscal
15 year ending September 30, 2022 to the Department of
16 Corrections - Correctional Capital Improvement Fund to be used
17 for the construction, renovation, and improvement of prison
18 facilities as enumerated in Section 14-2-12, Code of Alabama
19 1975, as amended by HB___ of the 2021 1st Extraordinary
20 Session of the Legislature. Any amount of this appropriation
21 remaining unexpended on September 30, 2022, shall be
22 reappropriated to the entity for the same purpose for the
23 fiscal year beginning October 1, 2022.

24 Section 2. In addition to all other appropriations
25 heretofore or hereafter made, there is hereby appropriated
26 \$19,000,000 from the unanticipated and unappropriated
27 beginning balance in the State General Fund for the fiscal

1 year ending September 30, 2022, to the Bureau of Pardons and
2 Paroles to be used for the purpose of acquiring and renovating
3 the existing prison facility in Perry County. Any amount of
4 this appropriation remaining unexpended on September 30, 2022,
5 shall be reappropriated to the Bureau for the same purpose for
6 the fiscal year beginning October 1, 2022.

7 Section 3. This act shall become effective
8 immediately upon its passage and approval by the Governor, or
9 upon its otherwise becoming law.
