9 SYNOPSIS: This bill makes a supplemental appropriation  
10 from the Education Trust Fund to the Alabama  
11 Institute for Deaf and Blind, Board of Trustees in  
12 the amount of \$3,500,000 for the fiscal year ending  
13 September 30, 2021; makes a supplemental  
14 appropriation from the Education Trust Fund to the  
15 Educational Television Commission in the amount of  
16 \$5,500,000 for the fiscal year ending September 30,  
17 2021; makes a supplemental appropriation from the  
18 Education Trust Fund to the Marine Environmental  
19 Sciences Consortium in the amount of \$2,000,000 for  
20 the fiscal year ending September 30, 2021; makes a  
21 supplemental appropriation from the Education Trust  
22 Fund to Tuskegee University in the amount of  
23 \$1,000,000 for the fiscal year ending September 30,  
24 2021; makes a supplemental appropriation from the  
25 Education Trust Fund to Athens State University in  
26 the amount of \$880,000 for the fiscal year ending

11           To make a supplemental appropriation from the  
12           Education Trust Fund to the Alabama Institute for Deaf and  
13           Blind, Board of Trustees in the amount of \$3,500,000 for the  
14           fiscal year ending September 30, 2021; to make a supplemental  
15           appropriation from the Education Trust Fund to the Educational  
16           Television Commission in the amount of \$5,500,000 for the  
17           fiscal year ending September 30, 2021; to make a supplemental  
18           appropriation from the Education Trust Fund to the Marine  
19           Environmental Sciences Consortium in the amount of \$2,000,000  
20           for the fiscal year ending September 30, 2021; to make a  
21           supplemental appropriation from the Education Trust Fund to  
22           Tuskegee University in the amount of \$1,000,000 for the fiscal  
23           year ending September 30, 2021; to make a supplemental  
24           appropriation from the Education Trust Fund to Athens State  
25           University in the amount of \$880,000 for the fiscal year  
26           ending September 30, 2021; to make a supplemental  
27           appropriation from the Education Trust Fund to the University

11 fiscal year ending September 30, 2021; to make a supplemental  
12 appropriation from the Education Trust Fund to the Department  
13 of Education in the amount of \$51,750,000 for the fiscal year  
14 ending September 30, 2021; to make a supplemental  
15 appropriation from the Education Trust Fund to the Commission  
16 on Higher Education in the amount of \$270,000 for the fiscal  
17 year ending September 30, 2021; to make a supplemental  
18 appropriation from the Education Trust Fund to the Historical  
19 Commission in the amount of \$275,000 for the fiscal year  
20 ending September 30, 2021; to make a supplemental  
21 appropriation from the Education Trust Fund to the Education  
22 Trust Fund Advancement and Technology Fund in the amount of  
23 \$65,000,000 for the fiscal year ending September 30, 2021; and  
24 to make a transfer from the Education Trust Fund to the Budget  
25 Stabilization Fund in the amount of \$75,000,000 under certain  
26 conditions for the fiscal year ending September 30, 2021.

27 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

1           Section 1. In addition to all other appropriations  
2 heretofore or hereafter made, there is hereby appropriated  
3 \$3,500,000 from the Education Trust Fund to the Alabama  
4 Institute for Deaf and Blind, Board of Trustees for the fiscal  
5 year ending September 30, 2021. Of this appropriation,  
6 \$1,000,000 shall be expended for demolition and an  
7 environmental study of ANG Decatur Property; and \$2,500,000  
8 shall be expended for the Independent Living Center at AIDB  
9 Talladega.

10           Section 2. In addition to all other appropriations  
11 heretofore or hereafter made, there is hereby appropriated  
12 \$5,500,000 from the Education Trust Fund to the Educational  
13 Television Commission for the fiscal year ending September 30,  
14 2021 for nonrecurring expenditures, including but not limited  
15 to transmitters and fiber optic network.

16           Section 3. In addition to all other appropriations  
17 heretofore or hereafter made, there is hereby appropriated  
18 \$2,000,000 from the Education Trust Fund to the Marine  
19 Environmental Sciences Consortium for the fiscal year ending  
20 September 30, 2021 to assist with recovery efforts from damage  
21 caused by Hurricane Sally.

22           Section 4. In addition to all other appropriations  
23 heretofore or hereafter made, there is hereby appropriated  
24 \$1,000,000 from the Education Trust Fund to Tuskegee  
25 University for the fiscal year ending September 30, 2021 for  
26 Armstrong Hall Laboratory improvements.

1           Section 5. In addition to all other appropriations  
2 heretofore or hereafter made, there is hereby appropriated  
3 \$880,000 from the Education Trust Fund to Athens State  
4 University, Board of Trustees for the fiscal year ending  
5 September 30, 2021 for one-time costs of HyFlex classrooms.

6           Section 6. In addition to all other appropriations  
7 heretofore or hereafter made, there is hereby appropriated  
8 \$592,300 from the Education Trust Fund to the University of  
9 West Alabama, Board of Trustees for the fiscal year ending  
10 September 30, 2021 for a campus wide security system.

11           Section 7. In addition to all other appropriations  
12 heretofore or hereafter made, there is hereby appropriated  
13 \$900,000 from the Education Trust Fund to the University of  
14 South Alabama for the fiscal year ending September 30, 2021  
15 for the sea lab.

16           Section 8. In addition to all other appropriations  
17 heretofore or hereafter made, there is hereby appropriated  
18 \$175,000 from the Education Trust Fund to the University of  
19 North Alabama for the fiscal year ending September 30, 2021  
20 for a workforce development pilot project.

21           Section 9. In addition to all other appropriations  
22 heretofore or hereafter made, there is hereby appropriated  
23 \$545,718 from the Education Trust Fund to the Alabama  
24 Community College System for the fiscal year ending September  
25 30, 2021. Of this appropriation, \$315,718 shall be expended  
26 for the Drake State Community Technical College NASA Frontiers  
27 Project, and \$230,000 shall be expended for the Wallace State

1 Community College-Hanceville Winston County Learning Center  
2 project.

3 Section 10. In addition to all other appropriations  
4 heretofore or hereafter made, there is hereby appropriated  
5 \$51,750,000 from the Education Trust Fund to the State  
6 Department of Education for the fiscal year ending September  
7 30, 2021. Of this appropriation, \$50,000,000 shall be  
8 distributed to the TEAMS Fund established by House Bill  
9 537/Senate Bill 327 of the 2021 Regular Session of the  
10 Legislature or subsequent act of the Legislature for the  
11 purpose of implementing a new math and science teacher salary  
12 schedule; \$1,000,000 shall be expended for a marketing  
13 campaign for teachers; and \$750,000 shall be expended for the  
14 National Board for Certification of Teachers.

15 Section 11. In addition to all other appropriations  
16 heretofore or hereafter made, there is hereby appropriated  
17 \$270,000 from the Education Trust Fund to the Alabama  
18 Commission on Higher Education for the fiscal year ending  
19 September 30, 2021 for the Best and Brightest STEM Pilot  
20 Program under the same terms and conditions as Act 2020-204.

21 Section 12. In addition to all other appropriations  
22 heretofore or hereafter made, there is hereby appropriated  
23 \$275,000 from the Education Trust Fund to the Alabama  
24 Historical Commission for the fiscal year ending September 30,  
25 2021 for one-time expenses for Fort Toulouse.

26 Section 13. In addition to all other appropriations  
27 heretofore or hereafter made, there is hereby appropriated

1 \$65,000,000 from the Education Trust Fund to the Education  
2 Trust Fund Advancement and Technology Fund for the fiscal year  
3 ending September 30, 2021 to be allocated in accordance with  
4 Section 29-9-4, Code of Alabama 1975.

5 Section 14. In addition to all other provisions of  
6 this act, if the Finance Director certifies in September 2021  
7 that the ending balance in the Education Trust Fund for the  
8 fiscal year ending September 30, 2021 will exceed \$75,000,000,  
9 then \$75,000,000 shall be transferred to the Budget  
10 Stabilization Fund established by Section 29-9-4, Code of  
11 Alabama 1975.

12 Section 15. This act shall become effective  
13 immediately upon its passage and approval by the Governor, or  
14 upon its otherwise becoming law.
