8 SYNOPSIS: This bill makes a supplemental appropriation  
9 from the Education Trust Fund to the Alabama  
10 Institute for Deaf and Blind, Board of Trustees in  
11 the amount of \$3,500,000 for the fiscal year ending  
12 September 30, 2021; makes a supplemental  
13 appropriation from the Education Trust Fund to the  
14 Educational Television Commission in the amount of  
15 \$5,500,000 for the fiscal year ending September 30,  
16 2021; makes a supplemental appropriation from the  
17 Education Trust Fund to the Marine Environmental  
18 Sciences Consortium in the amount of \$2,000,000 for  
19 the fiscal year ending September 30, 2021; makes a  
20 supplemental appropriation from the Education Trust  
21 Fund to Tuskegee University in the amount of  
22 \$1,000,000 for the fiscal year ending September 30,  
23 2021; makes a supplemental appropriation from the  
24 Education Trust Fund to Athens State University in  
25 the amount of \$880,000 for the fiscal year ending

18 To make a supplemental appropriation from the  
19 Education Trust Fund to the Alabama Institute for Deaf and  
20 Blind, Board of Trustees in the amount of \$3,500,000 for the  
21 fiscal year ending September 30, 2021; to make a supplemental  
22 appropriation from the Education Trust Fund to the Educational  
23 Television Commission in the amount of \$5,500,000 for the  
24 fiscal year ending September 30, 2021; to make a supplemental  
25 appropriation from the Education Trust Fund to the Marine  
26 Environmental Sciences Consortium in the amount of \$2,000,000  
27 for the fiscal year ending September 30, 2021; to make a

1 supplemental appropriation from the Education Trust Fund to  
2 Tuskegee University in the amount of \$1,000,000 for the fiscal  
3 year ending September 30, 2021; to make a supplemental  
4 appropriation from the Education Trust Fund to Athens State  
5 University in the amount of \$880,000 for the fiscal year  
6 ending September 30, 2021; to make a supplemental  
7 appropriation from the Education Trust Fund to the University  
8 of West Alabama in the amount of \$592,300 for the fiscal year

7 supplemental appropriation from the Education Trust Fund to  
8 the Education Trust Fund Advancement and Technology Fund in  
9 the amount of \$65,000,000 for the fiscal year ending September  
10 30, 2021; and to make a transfer from the Education Trust Fund  
11 to the Budget Stabilization Fund in the amount of \$75,000,000  
12 under certain conditions for the fiscal year ending September  
13 30, 2021.

14 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

15 Section 1. In addition to all other appropriations  
16 heretofore or hereafter made, there is hereby appropriated  
17 \$3,500,000 from the Education Trust Fund to the Alabama  
18 Institute for Deaf and Blind, Board of Trustees for the fiscal  
19 year ending September 30, 2021. Of this appropriation,  
20 \$1,000,000 shall be expended for demolition and an  
21 environmental study of ANG Decatur Property; and \$2,500,000  
22 shall be expended for the Independent Living Center at AIDB  
23 Talladega.

24 Section 2. In addition to all other appropriations  
25 heretofore or hereafter made, there is hereby appropriated  
26 \$5,500,000 from the Education Trust Fund to the Educational  
27 Television Commission for the fiscal year ending September 30,

1 2021 for nonrecurring expenditures, including but not limited  
2 to transmitters and fiber optic network.

3 Section 3. In addition to all other appropriations  
4 heretofore or hereafter made, there is hereby appropriated  
5 \$2,000,000 from the Education Trust Fund to the Marine  
6 Environmental Sciences Consortium for the fiscal year ending  
7 September 30, 2021 to assist with recovery efforts from damage  
8 caused by Hurricane Sally.

9 Section 4. In addition to all other appropriations  
10 heretofore or hereafter made, there is hereby appropriated  
11 \$1,000,000 from the Education Trust Fund to Tuskegee  
12 University for the fiscal year ending September 30, 2021 for  
13 Armstrong Hall Laboratory improvements.

14 Section 5. In addition to all other appropriations  
15 heretofore or hereafter made, there is hereby appropriated  
16 \$880,000 from the Education Trust Fund to Athens State  
17 University, Board of Trustees for the fiscal year ending  
18 September 30, 2021 for one-time costs of HyFlex classrooms.

19 Section 6. In addition to all other appropriations  
20 heretofore or hereafter made, there is hereby appropriated  
21 \$592,300 from the Education Trust Fund to the University of  
22 West Alabama, Board of Trustees for the fiscal year ending  
23 September 30, 2021 for a campus wide security system.

24 Section 7. In addition to all other appropriations  
25 heretofore or hereafter made, there is hereby appropriated  
26 \$900,000 from the Education Trust Fund to the University of

1 South Alabama for the fiscal year ending September 30, 2021  
2 for the School of Marine and Environmental Sciences.

3 Section 8. In addition to all other appropriations  
4 heretofore or hereafter made, there is hereby appropriated  
5 \$175,000 from the Education Trust Fund to the University of  
6 North Alabama for the fiscal year ending September 30, 2021  
7 for a workforce development pilot project.

8 Section 9. In addition to all other appropriations  
9 heretofore or hereafter made, there is hereby appropriated  
10 \$545,718 from the Education Trust Fund to the Alabama  
11 Community College System for the fiscal year ending September  
12 30, 2021. Of this appropriation, \$315,718 shall be expended  
13 for the Drake State Community Technical College NASA Frontiers  
14 Project, and \$230,000 shall be expended for the Wallace State  
15 Community College-Hanceville Winston County Learning Center  
16 project.

17 Section 10. In addition to all other appropriations  
18 heretofore or hereafter made, there is hereby appropriated  
19 \$51,750,000 from the Education Trust Fund to the State  
20 Department of Education for the fiscal year ending September  
21 30, 2021. Of this appropriation, \$50,000,000 shall be  
22 distributed to the TEAMS Fund established by House Bill  
23 537/Senate Bill 327 of the 2021 Regular Session of the  
24 Legislature or subsequent act of the Legislature for the  
25 purpose of implementing a new math and science teacher salary  
26 schedule; \$1,000,000 shall be expended for a marketing

1 campaign for teachers; and \$750,000 shall be expended for the  
2 National Board for Certification of Teachers.

3 Section 11. In addition to all other appropriations  
4 heretofore or hereafter made, there is hereby appropriated  
5 \$470,000 from the Education Trust Fund to the Alabama  
6 Commission on Higher Education for the fiscal year ending  
7 September 30, 2021. Of this amount, \$270,000 shall be expended  
8 for the Best and Brightest STEM Pilot Program under the same  
9 terms and conditions as Act 2020-204; and \$200,000 shall be  
10 expended for the Trails Foundation and allocated as follows:  
11 \$100,000 for the Singing River Trail and \$100,000 for the  
12 Pinhoti River Trail.

13 Section 12. In addition to all other appropriations  
14 heretofore or hereafter made, there is hereby appropriated  
15 \$275,000 from the Education Trust Fund to the Alabama  
16 Historical Commission for the fiscal year ending September 30,  
17 2021 for one-time expenses for Fort Toulouse.

18 Section 13. In addition to all other appropriations  
19 heretofore or hereafter made, there is hereby appropriated  
20 \$100,000 from the Education Trust Fund to the Alabama  
21 Department of Archives and History for the fiscal year ending  
22 September 30, 2021 for one-time expenses for the Civil Rights  
23 Voting Project.

24 Section 14. In addition to all other appropriations  
25 heretofore or hereafter made, there is hereby appropriated  
26 \$574,000 from the Education Trust Fund to the Department of  
27 Examiners of Public Accounts for the fiscal year ending



1 September 30, 2021 for continuation of the evaluation and  
2 reorganization study of the State Department of Education.

3 Section 15. In addition to all other appropriations  
4 heretofore or hereafter made, there is hereby appropriated  
5 \$65,000,000 from the Education Trust Fund to the Education  
6 Trust Fund Advancement and Technology Fund for the fiscal year  
7 ending September 30, 2021 to be allocated in accordance with  
8 Section 29-9-4, Code of Alabama 1975.

9 Section 16. In addition to all other provisions of  
10 this act, if the Finance Director certifies in September 2021  
11 that the ending balance in the Education Trust Fund for the  
12 fiscal year ending September 30, 2021 will exceed \$75,000,000,  
13 then \$75,000,000 shall be transferred to the Budget  
14 Stabilization Fund established by Section 29-9-4, Code of  
15 Alabama 1975.

16 Section 17. This act shall become effective  
17 immediately upon its passage and approval by the Governor, or  
18 upon its otherwise becoming law.
