10 On page 3, after line 20, insert the following new
11 subdivisions (4) and (5):

12 (4) The improvement, renovation, equipping,
13 acquisition, provision, construction, and maintenance of
14 public historical parks and public historical sites under the
15 jurisdiction of the Alabama Historical Commission shall be
16 completed in accordance with plans developed by the Alabama
17 Historical Commission. Upon completion, all improvements,
18 renovations, fixtures, equipment, and real or personal
19 property shall become property of the Alabama Historical
20 Commission.

21 (5) If the bond proceeds exceed eighty-five million
22 dollars (\$85,000,000) due to receipt of original issue premium
23 in connection with the sale of bonds or due to any other
24 reason, any bond proceeds in excess of eighty-five million
25 dollars (\$85,000,000) plus expenses related to the issuance of
26 the bonds shall be allocated to the Alabama Forestry
27 Commission for capital improvement, renovation, acquisition,

1 provision, construction, equipping, and maintenance of state
2 forests.
