8 SYNOPSIS: This bill makes a supplemental appropriation
9 from the State General Fund to the Alabama Tourism
10 Department in the amount of \$1,000,000 for the
11 fiscal year ending September 30, 2021; makes a
12 supplemental appropriation from the State General
13 Fund to the Board of Pardons and Paroles in the
14 amount of \$16,000,000 for the fiscal year ending
15 September 30,2021; makes a supplemental
16 appropriation from the State General Fund to the
17 Supreme Court in the amount of \$633,985 for the
18 fiscal year ending September 30, 2021; makes a
19 supplemental appropriation from the State General
20 Fund to the Office of Information Technology in the
21 amount of \$4,500,000 for the fiscal year ending
22 September 30, 2021; makes a supplemental
23 appropriation from the State Board of
24 Dietetics/Nutrition Fund to the Alabama State Board
25 of Examiners for Dietetics/Nutrition Practice in
26 the amount of \$150,000 for the fiscal year ending
27 September 30, 2021; makes a supplemental

1 appropriation from the State General Fund to the
2 Department of Public Health in the amount of
3 \$8,700,000 for the fiscal year ending September 30,
4 2021; makes a supplemental appropriation from the
5 State General Fund to the Judicial Inquiry
6 Commission in the amount of \$460,000 for the fiscal
7 year ending September 30, 2021; and makes a
8 supplemental appropriation from the State General
9 Fund to the Alabama Department of Forensic Sciences
10 in the amount of \$304,000 for the fiscal year
11 ending September 30, 2021.

17 To make a supplemental appropriation from the State
18 General Fund to the Alabama Tourism Department in the amount
19 of \$1,000,000 for the fiscal year ending September 30, 2021;
20 to make a supplemental appropriation from the State General
21 Fund to the Board of Pardons and Paroles in the amount of
22 \$16,000,000 for the fiscal year ending September 30, 2021; to
23 make a supplemental appropriation from the State General Fund
24 to the Supreme Court in the amount of \$633,985 for the fiscal
25 year ending September 30, 2021; to make a supplemental
26 appropriation from the State General Fund to the Office of
27 Information Technology in the amount of \$4,500,000 for the

1 fiscal year ending September 30, 2021; to make a supplemental
2 appropriation from the State Board of Dietetics/Nutrition Fund
3 to the Alabama State Board of Examiners for
4 Dietetics/Nutrition Practice in the amount of \$150,000 for the
5 fiscal year ending September 30, 2021; to make a supplemental
6 appropriation from the State General Fund to the Department of
7 Public Health in the amount of \$8,700,000 for the fiscal year
8 ending September 30, 2021; to make a supplemental
9 appropriation from the State General Fund to the Judicial
10 Inquiry Commission in the amount of \$460,000 for the fiscal
11 year ending September 30, 2021; and to make a supplemental
12 appropriation from the State General Fund to the Alabama
13 Department of Forensic Sciences in the amount of \$304,000 for
14 the fiscal year ending September 30, 2021.

15 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

16 Section 1. In addition to all other appropriations
17 heretofore or hereafter made, there is hereby appropriated
18 \$1,000,000 from the State General Fund to the Alabama Tourism
19 Department for the fiscal year ending September 30, 2021 to be
20 expended for the World Games.

21 Section 2. In addition to all other appropriations
22 heretofore or hereafter made, there is hereby appropriated
23 \$16,000,000 from the State General Fund to the Board of
24 Pardons and Paroles for the fiscal year ending September 30,
25 2021.

26 Section 3. In addition to all other appropriations
27 heretofore or hereafter made, there is hereby appropriated

1 \$633,985 from the State General Fund to the Supreme Court for
2 the fiscal year ending September 30, 2021 to be used for the
3 updates to the case management and e-filing systems.

4 Section 4. In addition to all other appropriations
5 heretofore or hereafter made, there is hereby appropriated
6 \$4,500,000 from the State General Fund to the Office of
7 Information Technology for the fiscal year ending September
8 30, 2021 to be used for cybersecurity.

9 Section 5. In addition to all other appropriations
10 heretofore or hereafter made, there is hereby appropriated
11 \$150,000 from the State Board of Dietetics/Nutrition Fund to
12 the Alabama State Board of Examiners for Dietetics/Nutrition
13 Practice for the fiscal year ending September 30, 2021.

14 Section 6. In addition to all other appropriations
15 heretofore or hereafter made, there is hereby appropriated
16 \$8,700,000 from the State General Fund to the Department of
17 Public Health for the fiscal year ending September 30, 2021,
18 of which \$7,500,000 shall be used for Coronavirus preparedness
19 and response activities, and \$1,200,000 shall be used for
20 workforce development schools for in-demand medical
21 professionals with the Huntsville Hospital Health System.

22 Section 7. In addition to all other appropriations
23 heretofore or hereafter made, there is hereby appropriated
24 \$460,000 from the State General Fund to the Judicial Inquiry
25 Commission for the fiscal year ending September 30, 2021.

26 Section 8. In addition to all other appropriations
27 heretofore or hereafter made, there is hereby appropriated

1 \$304,000 from the State General Fund to the Alabama Department
2 of Forensic Sciences to be used for one-time capital outlay
3 expenses.

4 Section 9. This act shall become effective
5 immediately upon its passage and approval by the Governor, or
6 upon its otherwise becoming law.
