13 Relating to Talladega County; to amend Section 3 of
14 Act 90-430, 1990 Regular Session (Acts 1990, p. 593), as
15 amended by Act 2002-283, 2002 Regular Session (Acts 2002, p.
16 595) and Act 2005-139, 2005 Regular Session (Acts 2005, p.
17 243), providing for the establishment of and distribution of
18 funds from the Law Library Fund and the Juvenile Justice Fund;
19 to dissolve the Juvenile Justice Fund Committee and to further
20 provide for the expenditures from the Law Library Fund and the
21 Juvenile Justice Fund.

22 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

23 Section 1. Section 3 of Act 90-430, 1990 Regular
24 Session (Acts 1990, p. 593), as amended by Act 2002-283, 2002
25 Regular Session (Acts 2002, p. 595) and Act 2005-139, 2005
26 Regular Session (Acts 2005, p. 243), is amended to read as
27 follows:

1 "Section 3. The county shall expend monies from the
2 two funds herein created as follows:

3 "(a) From the Law Library Fund, only expenditures
4 for the purchase and maintenance of books, reports,
5 periodicals, and operations shall be authorized as directed by
6 the presiding circuit court judge of Talladega County.

7 "(b) From the Juvenile Justice Fund, only those
8 expenditures authorized and directed by the ~~Juvenile Justice~~
9 ~~Fund Committee, consisting of the presiding circuit court~~
10 ~~judge, the district attorney, the sheriff, the chair of the~~
11 ~~county commission, the Director of the Talladega Department of~~
12 ~~Human Resources, the juvenile court judge, and the circuit~~
13 ~~clerk, presiding juvenile court judge for any juvenile justice~~
14 or enforcement purposes.

15 "(c) Notwithstanding subsections (a) and (b),
16 immediately upon the effective date of the act ~~adding~~ amending
17 this subsection, funds in the Law Library Fund ~~shall~~ may be
18 used to pay the remainder of salaries of court attendants and
19 funds in the Juvenile Justice Fund ~~shall~~ may be used to pay
20 the salaries of juvenile court specialists until the positions
21 are funded from other court funds at the same level as the
22 positions were funded in the 2002-2003 fiscal year, at which
23 time this subsection shall be ineffective."

24 Section 2. This act shall become effective
25 immediately following its passage and approval by the
26 Governor, or its otherwise becoming law.
