2 Section 1. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated 3 \$3,500,000 from the Education Trust Fund to the Alabama 4 Institute for Deaf and Blind, Board of Trustees for the fiscal year ending September 30, 2021. Of this appropriation, 7 \$1,000,000 shall be expended for demolition and an environmental study of ANG Decatur Property; and \$2,500,000 shall be expended for the Independent Living Center at AIDB Talladega.

> Section 2. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$5,500,000 from the Education Trust Fund to the Educational Television Commission for the fiscal year ending September 30, 2021 for nonrecurring expenditures, including but not limited to transmitters and fiber optic network.

> Section 3. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$2,000,000 from the Education Trust Fund to the Marine Environmental Sciences Consortium for the fiscal year ending September 30, 2021 to assist with recovery efforts from damage caused by Hurricane Sally.

Section 4. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$1,000,000 from the Education Trust Fund to Tuskegee University for the fiscal year ending September 30, 2021 for Armstrong Hall Laboratory improvements.

Section 5. In addition to all other appropriations 1 heretofore or hereafter made, there is hereby appropriated 2 \$880,000 from the Education Trust Fund to Athens State 3 University, Board of Trustees for the fiscal year ending 5 September 30, 2021 for one-time costs of HyFlex classrooms. Section 6. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$592,300 from the Education Trust Fund to the University of 8 West Alabama, Board of Trustees for the fiscal year ending 9 10 September 30, 2021 for a campus wide security system. Section 7. This act shall become effective 11 12 immediately upon its passage and approval by the Governor, or 13 upon its otherwise becoming law.
