## ENROLLED, An Act,

To alter, rearrange, and extend the boundary lines and corporate limits of the municipality of Munford in Talladega County.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
Section 1. The boundary lines and corporate limits of the municipality of Munford in Talladega County are altered, rearranged, and extended to include within the corporate limits of the municipality, in addition to the lands now included, all of the following territory:

Township 17 South, Range 7 East
Section 17: The Northwest Quarter (NW-1/4) lying West of the Louisville-Nashville Railroad Right-of-Way.

Section 18: The Northeast Quarter (NE-1/4) lying North and East of Priebes Mill Road less and except a portion thereof described as follows: Begin at the Southeast corner of the Southeast Quarter of the Northeast Quarter (SE-1/4 of NE-1/4) and run North 306 feet to a point; thence West 77 feet to the point of beginning; thence North 15 degrees East a distance of 295 feet to a point; thence North 75 degrees West a distance of 295 feet to a point; thence South 15 degrees West 295 feet; thence South 75 degrees East 295 feet to the point of beginning. Also less the following parcel situated in the Southeast Quarter of the Northeast Quarter (SE-1/4 of the

NE-1/4) described as follows: Commence at a 2 inch open top iron pipe found, accepted as the Northwest corner of Northeast Quarter of the Northeast Quarter (NE-1/4 of NE-1/4) of Section 18 and run South 02 degrees 01 minute 52 seconds East for 1,754.46 feet to a $1 / 2$ inch rebar set on the East rightof-way of Priebes Mill Road (R/W 80 feet), the point of beginning of the excepted parcel; thence leave the right-of-way and run North 73 degrees 02 minutes 38 seconds East for 477.18 feet to a $1 / 2$ inch rebar set; thence South 00 degrees 33 minutes 18 seconds East for 475.44 feet to a $1 / 2$ inch rebar set on the North rightof-way of Grant Town Road (R/W 60 feet); thence along said Grant Town Road right-of-way South 72 degrees 56 minutes 08 seconds West for 477.45 feet to a $1 / 2$ inch rebar set at the East right-of-way of Priebes Mill Road; thence run North 00 degrees 33 minutes 18 seconds West for 476.38 feet to the point of beginning, containing 5.0 acres, more or less. Section 2. In accordance with Section 11-42-6(b) of the Code of Alabama 1975, a map showing what territory is proposed to be annexed to the municipality of Munford is on file in the office of the Judge of Probate in Talladega County, Alabama, and the map is open to the inspection of the public.

Section 3. This act shall become effective on the first day of the third month following its passage and approval by the Governor, or its otherwise becoming law.
