| 19 | Section 1. Section 45-5-230, Code of Alabama 1975,             |
| 20 | is amended to read as follows:                                 |
| 21 | <b>"</b> §45-5-230.  |
| 22 | "(a) Commencing July 1, 2000, the Sheriff of Blount            |
| 23 | County shall be entitled to an additional expense allowance in |
| 24 | the amount of twelve thousand dollars (\$12,000) per annum,    |
| 25 | which shall be in addition to all other expense allowances,    |
| 26 | compensation, or salary provided by law. This expense          |

allowance shall be payable in equal monthly installments from the general fund of the county.

"(b) (a) Beginning with the expiration of the term of the incumbent sheriff in office on the effective date of this amendatory act, the annual salary for the Sheriff of Blount County shall be fifty thousand dollars (\$50,000) per annum equal to 90 percent of the annual base salary of the judge of probate of the county, payable in equal monthly installments from the general fund of the county and at that time, subsection (a) shall become null and void.

"(c) The expense allowance and (b) The salary provided in this section shall be inoperative if the sheriff receives an additional expense allowance or salary increase pursuant to general law during the current term of office or effective upon the beginning of the next term of office which is equal to or greater than the amount provided by this section."

Section 2. (a) Any individual appointed to serve as Sheriff of Blount County shall meet all of the following minimum qualifications, in addition to any other qualifications required by law; and, effective on the first day of the qualifying period for the 2026 election for the office of sheriff, any individual qualifying for election to the office of sheriff shall meet all of the following qualifications, in addition to any other qualifications required by law:

1 (1) The individual is a citizen of the United 2 States.

- 3 (2) The individual has been a resident of the county 4 for at least one year immediately prior to the date of 5 qualification or appointment.
  - (3) The individual has the qualifications of an elector pursuant to state and federal law, and the individual has been registered to vote in the county at least one year immediately prior to the date of qualification or appointment.
  - (4) The individual has been awarded a high school diploma or GED equivalent.
    - (5) The individual is 25 years of age or older prior to qualifying or being appointed.
  - (6) The individual has three or more cumulative years of prior full-time experience as a law enforcement officer having the power of arrest.
- 17 (7) The individual has never been convicted of a felony.
- 19 (b) This section shall not apply to or affect a
  20 supernumerary sheriff.
- Section 3. This act shall become effective on immediately following its passage and approval by the Governor, or its otherwise becoming law.
