WHEREAS, in every proposal to have new conveniences added, a period of preparation had to take place; with the leadership of Pastor Hogue, many financial milestones were witnessed during 2016 and 2017; and

WHEREAS, the membership continued to follow leadership by praying and paying from 2017 until present; on December 15, 2019, Ground Breaking Ceremonies were held after the morning service; clearing began at the site on February 15, 2020, and construction of the Dr. C.L. Hogue Activity Center officially began February 17, 2020; and

WHEREAS, news of a virus outbreak that would affect the entire world was on the horizon; the members understood that man can plan, but God can unplan; on March 8, 2020, Pastor Hogue gave the members the Word on how to deal with the situation "IN THE MEANTIME," Jeremiah 29:4-7; and

WHEREAS, the method of worship changed to teleconference on Sunday, April 12, 2020; financial obligations never waivered and attendance for online service averaged 86 families per Sunday; because of the faithfulness of the members, the building project resumed in mid-April 2020; construction "hick-ups" caused other minor delays; however, the members never lost hope and the Dr. C.L. Hogue Activity Center was completed on December 28, 2021; to God Be
