1 "(a) The mayor of any municipality in Jefferson 2 County who is employed full-time by a municipality, municipal 3 board, or municipal public corporation, to serve as superintendent of a municipal light and power system, municipal water system, municipal sewage system and , or municipal gas system, or one or more of them, owned and 7 operated by such municipality, municipal board, or municipal public corporation pursuant to the provision of Title 37, Section 440, Alabama Code 1940 Section 11-43-80, Code of Alabama 1975, as amended, shall be paid for his or her service as superintendent of such the system or systems, in addition 11 12 to the salary he or she now or hereafter receives as mayor, 13 such the sum as the governing body, board, or municipal public 14 corporation shall deem reasonable, but not to exceed Twelve Hundred Dollars (\$1,200.00) twelve hundred dollars (\$1,200)15 16 per month, notwithstanding the provisions of Title 37, Section 17 440 Section 11-43-80, as amended, or any other law to the contrary.

"(b) Alternatively, notwithstanding subsection (a), the governing body or board of a municipality, municipal board, or municipal public corporation employing the mayor of any municipality in Jefferson County to serve as superintendent of a municipal light and power system, municipal water system, municipal sewage system, or municipal gas system, or one or more of them, owned and operated by the municipality, municipal board, or municipal public corporation, pursuant to the provisions of Section 11-43-80,

1	Code of Alabama 1975, as amended, may adopt an ordinance or
