5 RENAMING A PORTION OF STATE HIGHWAY 279 IN
6 SCOTTSBORO IN MEMORY OF DR. WAYNE PATTERSON III.

8 WHEREAS, it is with highest commendation that the
9 Legislature of Alabama renames a portion of Alabama State
10 Highway 279 from it's intersection of Alabama State Highway 79
11 and Goosepond Drive North to Ida Moody Road, in loving memory
12 of Dr. Wayne "Doc" Patterson III; and

13 WHEREAS, the renaming of this portion of the highway
14 is in tribute to Dr. Patterson who served Scottsboro, Alabama,
15 and the surrounding area as a Doctor of Dental Surgery for 39
16 years; he lovingly cared for his patients at Valley Dental
17 Implant Center; helping others and improving lives was his
18 favorite part of being a dentist; he was a pioneer in North
19 Alabama, among the first to begin doing dental implants in the
20 1980s; he was a shining example of a good human being, even
21 traveling across the globe on church missions to assist
22 impoverished countries and provide them with free dental care
23 and education; what brought him joy was serving others in
24 whatever capacity he could with a grateful and open heart; and

1 WHEREAS, it is indeed appropriate to recognize the
2 exceptional Dr. Patterson for his dedicated, capable, and
3 selfless service to his community of Scottsboro and to the
4 State of Alabama; now therefore,

5 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
6 HOUSES THEREOF CONCURRING, That a portion of Alabama State
7 Highway 279 from its intersection of Alabama State Highway 79
8 and Goosepond Drive North to Ida Moody Road, in loving memory
9 of Dr. Wayne "Doc" Patterson III, and the appropriate
10 authorities are directed to erect and maintain signs and
11 markers specifying this designation of honor as provided in
12 this resolution.

13 BE IT FURTHER RESOLVED, That the Department of
14 Transportation is requested to determine the cost of
15 fabricating and erecting the appropriate signs and markers,
16 consistent with applicable requirements and laws, and upon
17 receiving funds from non-state sources covering that cost, to
18 erect signs and markers as provided in this resolution in
19 recognition of this memorial designation.
