1 Enrolled, An Act,

2
3 Relating to Montgomery County; to amend Section
4 45-51-231 of the Code of Alabama 1975, relating to an expense
5 allowance and salary of the sheriff, to restate the current
6 salary of the sheriff and to delete an expired expense
7 allowance; and to provide a new expense allowance for the
8 sheriff and for the salary of the sheriff if the sheriff has
9 served two or more full consecutive terms as sheriff.

11 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

12 Section 1. Section 45-51-231 of the Code of Alabama
13 1975, is amended to read as follows:

14 "§45-51-231

15 ~~(a) The Sheriff of Montgomery County shall receive an~~
16 ~~expense allowance of twenty thousand dollars (\$20,000) per~~
17 ~~year, payable in equal monthly installments from the general~~
18 ~~fund of the county. This expense allowance shall be in~~
19 ~~addition to all other compensation or benefits granted to the~~
20 ~~sheriff and may be treated as compensation for retirement~~
21 ~~contributions.~~

22 ~~(b) Effective beginning the next term of office,~~
23 ~~the~~ Except as provided in Section 2 of the act adding this
24 language, the annual salary of the Sheriff of Montgomery
25 County shall be one hundred fifty-five thousand dollars
26 (\$155,000) ~~and the expense allowance provided for in~~
27 ~~subsection (a) shall become null and void.~~

28 Section 2. (a) (1) Any Sheriff of Montgomery County who

29 has served two consecutive full terms shall receive an
30 additional expense allowance of twenty thousand dollars
31 (\$20,000) per year, payable in equal monthly installments from
32 the general fund of the county. This expense allowance shall
33 be in addition to all other compensation or benefits granted
34 to the sheriff and may be treated as compensation for
35 retirement contributions.

36 (2) This subsection shall be void at the end of the
37 current term of the sheriff or on a vacancy in the office of
38 sheriff for any reason.

39 (b) Effective beginning the next term of office of the
40 Sheriff of Montgomery County, and thereafter, any sheriff who
41 has served two or more consecutive full terms as sheriff,
42 shall receive an annual salary in the amount of one hundred
43 seventy-five thousand dollars (\$175,000). The salary shall be
44 paid from the general fund of the county.

45 Section 3. This act shall become effective on the first
46 day of the third month following its passage and approval by
47 the Governor, or its otherwise becoming law.
