1 Enrolled, An Act,

3 Relating to Marion County; to amend Section
4 45-47-245.05, providing for the distribution of the proceeds
5 of a local tobacco tax in the county, to further provide for
6 the distribution of a portion of the proceeds to the Marion
7 County Firefighters Association.

8 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

9 Section 1. Section 45-47-245.05 of the Code of Alabama
10 1975, is amended to read as follows:

11 "§45-47-245.05

12 (a) The proceeds from the tax hereby levied, less the
13 actual costs of collection not to exceed 10 per centum, shall
14 be paid by the State Department of Revenue to the Marion
15 County Commission to be deposited in two separate accounts to
16 the credit of either the Marion County Water Coordinating and
17 Fire Prevention Authority or the Marion County Volunteer Fire
18 and Rescue Association as follows:

19 (1) Sixty percent to the Marion County Water
20 Coordinating and Fire Prevention Authority.

21 (2) Forty percent to the Marion County Volunteer Fire
22 and Rescue Association, to be divided as follows:

23 a. ~~Twenty-five~~ Thirty percent of the total net proceeds
24 to the Marion County Firefighters Association.

25 b. Ten percent of the total net proceeds to rescue
26 squad associations.

27 c. ~~Five percent to public licensed ambulance services~~
28 ~~if such services are authorized and created by such~~

29 ~~association.~~Any portion of the net proceeds held and not
30 distributed to public licensed ambulance services before the
31 effective date of the act adding this amendatory language
32 shall be distributed to the Marion County Firefighters
33 Association.

34 (b) The Marion County Volunteer Fire and Rescue
35 Association ~~shall have authority to promulgate~~may adopt rules
36 ~~and regulations~~ having the force and effect of law for the
37 distribution of the funds under subdivision (a) (2) ~~of~~
38 ~~subsection (a)~~.

39 (c) Distribution shall be made by the Marion County
40 Commission to the separate accounts upon written request of
41 the chair of the respective Marion County Water Coordinating
42 and Fire Prevention Authority and the Marion County Volunteer
43 Fire and Rescue Association. The written request shall be
44 submitted to the Marion County Commission and shall become a
45 permanent part of the minutes of the commission. A copy of the
46 written request shall be retained by the requesting authority
47 or association to be entered in their permanent records."

48 Section 2. This act shall become effective on the first
49 day of the third month following its passage and approval by
50 the Governor, or its otherwise becoming law.
