A BILL  
TO BE ENTITLED  
AN ACT

To alter, rearrange, and extend the boundary lines and corporate limits of the Town of Brantley in Crenshaw County.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The boundary lines and corporate limits of the Town of Brantley in Crenshaw County are altered, rearranged, and extended to include within the corporate limits of the municipality, in addition to the lands now included, all of the following territory:

Begin at the Southeast corner of Section 5, Township 7 North, Range 18 East, Crenshaw County, Alabama and run thence West along the South line of said Section 5 to the Southwest corner of the Southeast Quarter of said Section 5; thence run North to the Southeast corner of the Northeast Quarter of the Southwest Quarter of said Section 5; thence run West for a distance of 875 feet more or less to the Southwest corner of that property as described in Deed Book 160, Page 583 (TPID 24-20-03-05-0-000-014.005); thence run North to the North margin of Battles Road; thence run Easterly along said North margin of Battles Road to the West line of the East Half of the Northeast Quarter of said Section 5; thence continue East along said North margin of Battles Road for 210 feet more or less; thence leaving said North margin run North for 420 feet

29 more or less; thence run West for 210 feet more or less to  
30 said West line of the East Half of the Northeast Quarter of  
31 said Section 5; thence run North to the Southwest corner of  
32 the East Half of the Southeast Quarter of Section 32, Township

34 of said East Half of the Southeast Quarter of Section 32 to  
35 the North right of way of County Highway #39; thence run  
36 Westerly along said North right of way for 1600 feet more or  
37 less to the West line of that property as described in Deed  
38 Book 148, Page 179 (TPID 24-15-09-32-0-000-001.000); thence  
39 leaving the North right of way of County Highway #39 run North  
40 along the West line of that property as described in Deed Book  
41 148, Page 179 (TPID 24-15-09-32-0-000-001.000) to the  
42 Northwest corner of that property as described in Deed Book  
43 148, page 179 (TPID 24-15-09-32-0-000-001.000); thence run  
44 East along the North line of said Section 32 to the Northeast  
45 corner of said Section 32; thence run East to the Northeast  
46 corner of the West Half of the West Half of said Section 33;  
47 thence run South to the Southeast corner of said West Half of  
48 the West Half of Section 33, Township 8 North, Range 18 East;  
49 thence run South to the Southeast corner of the West Half of  
50 the Northwest Quarter of Section 4, Township 7 North, Range 18  
51 East; thence run East to the Northeast corner of the North  
52 Half of the Southwest Quarter of Section 4; thence run South  
53 to the Southeast corner of said North Half of the Southwest  
54 Quarter of Section 4; thence run West to the Northeast corner

70 South to the Southeast corner of the Northeast Quarter of the  
71 Northwest Quarter of Section 9, Township 7 North, Range 18  
72 East; thence run East to the Northeast corner of the Southwest  
73 Quarter of the Northeast Quarter of said Section 9; thence  
74 run South along the East line of said Southwest Quarter of the  
75 Northeast Quarter of Section 9 to the existing Northern limit  
76 of the Town of Brantley, Alabama; thence run Westerly along  
77 said Northern limit of the Town of Brantley to the West line  
78 of Section 9; Township 7 North, Range 18 East; thence run  
79 North to the Southeast corner of Section 5, Township 7 North,  
80 Range 18 East and point of beginning.

81 Section 2. In accordance with Section 11-42-6(b) of the  
82 Code of Alabama 1975, a map showing the proposed territory to  
83 be annexed to the Town of Brantley is on file and open to  
84 public inspection in the Office of the Judge of Probate in

85 Crenshaw County, Alabama.

86           Section 3. This act shall become effective on the first  
87 day of the third month following its passage and approval by  
88 the Governor, or its otherwise becoming law.
