4 SYNOPSIS:

> Under existing law, any person who plans to perform excavation or demolition work is required to submit a design or survey locate request to the One-Call Notification System for information on the location of any underground facilities, and the underground facility operator is required to respond to the request within five days.

> This bill would authorize a design professional, who has received no response from an operator after two design or survey locate requests have been submitted and have expired, to employ an independent third-party locator at the expense of the operator.
