4	SYNOPSIS:
5	The Military Family Jobs Opportunity Act extends
6	professional license reciprocity to eligible
7	individuals, defined as spouses of specified members of
8	the United States Armed Forces and specified federal
9	employees.
10	This bill would extend professional license
11	reciprocity to spouses of United States Department of
12	Defense civil servants.
13	This bill would make nonsubstantive changes to
14	conform to existing definitions in the law.

21	Relating to the Military Family Jobs Opportunity Act;
22	to amend Section 31-1-6, Code of Alabama 1975, as amended by
23	Act 2022-92, 2022 Regular Session, to extend professional
24	license reciprocity to spouses of United States Department of
25	Defense civil servants; and to make nonsubstantive conforming
26	changes to the law.
27	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. Section 31-1-6, Code of Alabama 1975, as

- last amended by Section 1 of Act 2022-92 of the 2022 Regular Session, is amended to read as follows:

- 32 (a) This section shall be known and may be cited as the 33 Military Family Jobs Opportunity Act.
- 34 (b) Except as provided in subsection (h), and 35 notwithstanding other provisions of law, this section shall 36 apply to any board, agency, commission, or other entity providing professional licenses or certificates, or both, for 37 the purpose of employment in the State of Alabama occupational 38 39 licensing board, as defined in Section 41-9A-1. On or before January 1, 2023, each board, agency, or commission providing 40 professional licenses or certificates, or both, occupational 41 42 licensing board shall adopt rules in conformity with this 43 section for the purpose of implementing its requirements. The rules shall provide a method of accomplishing both of the 44 45 following:
 - (1) The issuance of a license or certificate to an eligible individual, within 30 days of application, if the certification or license of the original issuing state or governing body is similar to that requested from this state, as provided in subsection (d).
 - (2) A procedure for authorizing an eligible individual to perform professional services regulated by the <u>occupational licensing board board</u>, agency, or commission in this state pursuant to a temporary permit, effective for at least 360 days, while the board, agency, or commission deliberates the application to obtain a license or certificate in this state,

- (c) For the purposes of this section, an "eligible
- 59 individual" is any individual who satisfies all of the
- 60 following:
- (1) Is the spouse of any of the following:
- a. An active duty, reserve, or transitioning member of
- the United States Armed Forces, including the National Guard,
- or a surviving spouse of a service member who, at the time of
- his or her death, was serving on active duty, who is relocated
- 66 to and stationed in the State of Alabama under official
- 67 military orders. For the purposes of this <u>section</u> paragraph, a
- "transitioning service member" is a member of the United
- 69 States Armed Forces, including the National Guard, on active
- 70 duty status or on separation leave who is within 24 months of
- 71 retirement.
- 72 b. An individual currently employed by the United
- 73 States Department of Justice or any of its encompassed
- offices, agencies, institutes, and bureaus, including, but not
- 75 limited to, the Federal Bureau of Investigation (FBI), the
- 76 U.S. Attorney's Office, the Bureau of Alcohol, Tobacco,
- 77 Firearms, and Explosives (ATF), the Drug Enforcement
- 78 Administration (DEA), and the United States Marshal Service
- 79 (USMS), who is relocated to Alabama by order of their
- 80 employer.
- 81 c. An individual currently employed at the National
- 82 Aeronautics and Space Administration who is relocated to
- 83 Alabama by order of their employer.
- d. An individual currently employed in Alabama as a

- (2) Has not committed or participated in an act that would constitute grounds for refusal, suspension, or revocation of a professional license or certificate.
 - (3) Has not been disciplined by an authorized entity or under investigation, in any jurisdiction, in relation to a professional license or certificate.
- (d) Any eligible individual under subsection (c) who possesses a valid license or certificate, in good standing, in another state, district, or territory of the United States, or in any branch of the United States Armed Forces, including the National Guard, that is substantially similar to the license issued by the appropriate board, agency, or commission in the State of Alabama shall be approved to continue work in his or her profession upon relocation to the State of Alabama for such time as normally allotted with receipt of a license or certificate from the appropriate occupational licensing board, agency, or commission. Upon completion of an application, an authorized board, agency, or commission the occupational licensing board shall expedite the application according to statute, adopted rules, or if applicable, at the next scheduled licensure proceeding for an eligible individual under subsection (c).
- (e) Any <u>occupation licensing</u> board, agency, or <u>commission in the State of Alabama</u> may establish reciprocity with other states for military spouse professional licensing and certification.
 - (f) Any occupational licensing board, agency,

- commission, or other entity providing professional licenses or

 certificates, or both, for the purpose of employment in this

 state, that is created after April 6, 2018, shall adopt the

 rules required by this section within one year after the date

 of its initial organizational meeting.
- 118 (g) Any occupational licensing board, agency, 119 commission, or other entity providing professional licenses or 120 certificates, or both, for the purpose of employment in the 121 state, shall waive the initial licensing fee for the eligible individual upon application by the eligible individual in a 122 123 manner prescribed by the occupational licensing board, agency, commission, or other entity. The occupational licensing board, 124 125 agency, commission, or other entity shall process an 126 application for a fee waiver within 30 days after receiving 127 the application.

- (h) This section does not apply to the practice of law or the regulation of attorneys, any license or registration issued by the Securities Commission under the Alabama Securities Act, any certification issued by the Alabama Peace Officers' Standards and Training Commission, or the practice of any profession regulated by the Alabama State Board of Pharmacy, Board of Optometry, Board of Dental Examiners, State Board of Chiropractic Examiners, Alabama Liquefied Petroleum Gas Board, or State Board of Medical Examiners."
- Section 2. This act shall become effective on the first day of the third month following its passage and approval by the Governor, or its otherwise becoming law.
