SYNOPSIS:

This bill makes supplemental appropriations from the Education Trust Fund Advancement and Technology Fund for the fiscal year ending September 30, 2024; to the public institutions of higher education in the amount of \$273,700,000; and to the Department of Education, the Board of Trustees of the Alabama Institute for Deaf and Blind, the Board of Youth Services School Districts, the Board of Directors of the Alabama School of Fine Arts, the Board of Trustees of the Alabama School of Math and Science, and the Board of Trustees of the Alabama School of Cyber Technology and Engineering in the amount of \$726,300,000.

TO BE ENTITLED

AN ACT

To make supplemental appropriations from the Education Trust Fund Advancement and Technology Fund for the fiscal year ending September 30, 2024, to the public institutions of higher education in the amount of \$273,700,000, and to the Department of Education, the Board of Trustees of the Alabama Institute for Deaf and Blind, the Board of Youth Services



29 School Districts, the Board of Directors of the Alabama School  
30 of Fine Arts, the Board of Trustees of the Alabama School of  
31 Math and Science, and the Board of Trustees of the Alabama  
32 School of Cyber Technology and Engineering in the amount of  
33 \$726,300,000.

34 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

35 Section 1. In addition to all other appropriations  
36 heretofore or hereafter made, there is hereby appropriated a  
37 total of \$273,700,000 from the Education Trust Fund  
38 Advancement and Technology Fund to the public institutions of  
39 higher education for the fiscal year ending September 30,  
40 2024. This appropriation shall be expended as provided in  
41 Section 29-9-4, Code of Alabama 1975. This appropriation shall  
42 be distributed as follows:

58 Section 2. In addition to all other appropriations  
59 heretofore or hereafter made, there is hereby appropriated a  
60 total of \$726,300,000 from the Education Trust Fund  
61 Advancement and Technology Fund to the Department of  
62 Education, the Board of Trustees of the Alabama Institute for  
63 Deaf and Blind, the Board of Youth Services School Districts,  
64 the Board of Directors of the Alabama School of Fine Arts, the  
65 Board of Trustees of the Alabama School of Math and Science,  
66 and the Board of Trustees of the Alabama School of Cyber  
67 Technology and Engineering, for the fiscal year ending  
68 September 30, 2024. This appropriation shall be expended as  
69 provided in Section 29-9-4, Code of Alabama 1975.

70 Section 3. (a) The Department of Education shall  
71 allocate the funds appropriated herein to the local boards of  
72 education and entities as follows:

229           (b) Notwithstanding any other laws to the contrary, the  
230 funds appropriated to the Department of Education by  
231 subsection (a) of this section shall not be expended without  
232 prior approval of the State Superintendent of Education.

233           (c) (1) The above appropriation for teacher professional  
234 development shall be allocated to the Alabama Department of  
235 Education to be distributed to the Ed Farm Classroom of  
236 Tomorrow. These funds will be used by Ed Farm to provide  
237 technology tools and professional development services to  
238 classroom teachers in an effort to improve instruction and  
239 student learning gains. It is the intent of the legislature  
240 that in addition to general programmatic costs, Ed Farm may  
241 also expend funds for software, hardware, administrative  
242 costs, and professional learning services.

243           (2) The State Superintendent shall provide a report of  
244 the initiative to the Chair of the House Ways and  
245 Means-Education Committee and the Chair of the Senate  
246 Committee on Finance and Taxation-Education no later than  
247 October 1, 2025.

248           Section 4. All funds not expended in the current fiscal  
249 year shall not revert but be carried forward for the purpose  
250 appropriated.

251           Section 5. This act shall become effective immediately



252 upon its passage and approval by the Governor, or upon its  
253 otherwise becoming law.
