LO	Relating to crimes and offenses; to amend Section
L1	13A-6-152, Code of Alabama 1975, to further provide for the
L2	punishment of certain human trafficking offenses under certain

L 7	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
L 8	Section 1. This act shall be known and may be cited as
L 9	the Sound of Freedom Act.
20	Section 2. Section 13A-6-152, Code of Alabama 1975, is
21	amended to read as follows:
22	"\$13A-6-152
23	(a) A person commits the crime of human trafficking in
24	the first degree if:
25	(1) He or she knowingly subjects another person to
26	labor servitude or sexual servitude.
27	(2) He or she knowingly obtains, recruits, entices,
28	solicits, induces, threatens, isolates, harbors, holds,

- restrains, transports, provides, or maintains any minor for the purpose of causing a minor to engage in sexual servitude.
- 31 (3) He or she knowingly gives, or attempts to give,
  32 monetary consideration or any other thing of value to engage
  33 in any sexual conduct with a minor or an individual he or she
  34 believes to be a minor.
  - (b) For purposes of this section, it is not required that the defendant have knowledge of a minor victim's age, nor is reasonable mistake of age a defense to liability under this section.
  - (c) A corporation, or any other legal entity other than an individual, may be prosecuted for human trafficking in the first degree for an act or omission only if an agent of the corporation or entity performs the conduct which is an element of the crime while acting within the scope of his or her office or employment and on behalf of the corporation or entity, and the commission of the crime was either authorized, requested, commanded, performed, or within the scope of the person's employment on behalf of the corporation or entity or constituted a pattern of conduct that an agent of the corporation or entity knew or should have known was occurring.
  - (d) Any person who obstructs, or attempts to obstruct, or in any way interferes with or prevents the enforcement of this section shall be guilty of a Class A felony.
  - (e) Human trafficking in the first degree is a Class A felony. In any prosecution under this section where there is a minor trafficking victim, the court shall sentence the defendant to a minimum of life imprisonment. However, if the

5 /	detendant is to years of age of younger, the court shall
58	sentence the defendant as a Class A felon."
59	Section 3. Although this bill would have as its purpose
60	or effect the requirement of a new or increased expenditure of
61	local funds, the bill is excluded from further requirements
62	and application under Section 111.05 of the Constitution of
63	Alabama of 2022, because the bill defines a new crime or
64	amends the definition of an existing crime.
65	Section 4. This act shall become effective October 1,
