SYNOPSIS:

Under existing law, a registered voter may only vote by absentee ballot if he or she meets one of the criteria prescribed by law for voting absentee.

This bill would allow a registered voter to vote by absentee ballot without an excuse.

A BILL  
TO BE ENTITLED  
AN ACT

Relating to voting; to amend Sections 17-11-3 and 17-11-7, Code of Alabama 1975; to authorize absentee voting without an excuse.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. Sections 17-11-3 and 17-11-7, Code of Alabama 1975, are amended to read as follows:

"§17-11-3

(a) Any qualified elector of this state may ~~apply for~~ ~~and~~ vote an absentee ballot by mail, ~~by hand delivery~~ in person, or by commercial carrier, as determined by rule by the Secretary of State, as further provided in ~~Sections 17-11-5 and 17-11-9~~ this chapter, in any primary, general, special, or municipal election, if he or she ~~makes application in writing~~

59 (b) Applications returned by mail must be received not  
60 less than seven days prior to the election. Applications  
61 returned by hand must be received not less than five days  
62 prior to the election.

63 (c) An applicant for an absentee ballot who is a member  
64 of the Armed Forces of the United States, including the  
65 Alabama National Guard, the United States Naval Reserves, the  
66 United States Air Force Reserves, and the United States Army  
67 Reserve on active duty or active duty for training or an  
68 applicant who is the spouse of any member of the armed forces  
69 or any other applicant qualified to vote absentee pursuant to  
70 the federal Uniformed and Overseas Citizens Absentee Voting  
71 Act, 52 U.S.C. §§ 20301-20311, may make application for an  
72 absentee ballot by filling out the federal postcard  
73 application form, authorized and provided for under the  
74 provisions of The Federal Voting Assistance Act of 1955,  
75 Public Law 296, Chapter 656, H.R. 4048, approved August 9,  
76 1955, 84th Congress 1st Session.

77 (d) Any registered elector who requires emergency  
78 treatment of a licensed physician within five days of an  
79 election may apply for an emergency absentee ballot for the  
80 election and may vote by returning the absentee ballot no  
81 later than noon on the day the election is held. The attendant  
82 physician shall describe and certify the circumstances as  
83 constituting an emergency on a special form designed by the  
84 Secretary of State and provided by his or her office to local

85 absentee election managers. The special form shall be attached  
86 to the application.

87 (e) (1) Any registered elector whose name appears on the  
88 poll list of qualified voters may vote by an emergency  
89 absentee ballot if any of the following situations arise:

90 a. The elector is required by his or her employer under  
91 unforeseen circumstances within five days before an election  
92 to be unavailable to vote at the polls on election day.

93 b. The elector is a caregiver of a person who requires  
94 emergency treatment by a licensed physician within five days  
95 before an election.

96 c. A family member to the second degree of kinship by  
97 affinity or consanguinity of an elector dies within five days  
98 before an election.

99 (2) Under such circumstances, the elector shall apply  
100 for an emergency absentee ballot at the office of the absentee  
101 election manager no later than the close of the business day  
102 one day prior to the election. The applicant shall complete  
103 and file an application form designed by the Secretary of  
104 State for emergency absentee voters. The form shall contain an  
105 affidavit which the applicant shall sign or swear  
106 acknowledging that he or she was not aware of the situation  
107 constituting the emergency prior to five days before the  
108 election. An applicant who meets the requirements of this  
109 subsection may vote by an emergency absentee ballot. After  
110 voting the ballot, the voter shall hand the ballot to the  
111 absentee election manager.

112 (f) If the occurrence of a state of emergency as

113 declared in this or any other state, or by the federal  
114 government, renders substantial compliance with this article  
115 impossible or unreasonable for a group of qualified voters who  
116 respond to the emergency, the Secretary of State, pursuant to  
117 Section 41-22-5, may adopt an emergency rule to allow those  
118 qualified voters to vote by absentee ballot. Notwithstanding  
119 any other laws to the contrary, all expenses and costs  
120 incurred by the state or any county in carrying out the  
121 responsibilities and duties included in an emergency rule  
122 adopted pursuant to this subsection shall be paid by the State  
123 of Alabama from any funds made available for election expenses  
124 under state and federal law.

125 (g) Notwithstanding any other provision of otherwise  
126 applicable law, in the event more than one absentee ballot is  
127 cast in the name of the single voter, whether any multiple  
128 ballot is cast by mail or otherwise, none of the affidavit  
129 envelopes containing the multiple ballots shall be opened, and  
130 none of the multiple ballots shall be counted, except in the  
131 event of an election contest, upon the order of the election  
132 contest tribunal. Upon the conclusion of an election contest  
133 or, in the event no contest is filed, upon the expiration of  
134 time for filing a contest, the multiple ballots shall be  
135 provided to the district attorney, with photocopies provided  
136 to the state Attorney General, for the investigation,  
137 prosecution, or other action as may be appropriate under  
138 applicable law."

142 (b) With respect to an absentee ballot cast pursuant to  
143 Section 17-11-3, the affidavit shall read as follows:

185 Moreover, I further swear (or affirm) that all of the  
186 information given above is true and correct to the best of my  
187 knowledge and that I understand that by knowingly giving false  
188 information so as to vote illegally by absentee ballot that I  
189 shall be guilty of a misdemeanor which is punishable by a fine  
190 not to exceed one thousand dollars (\$1,000) or confinement in  
191 the county jail for not more than six months, or both.
